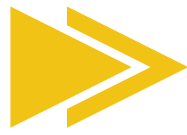

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Simmons Hanly Conroy 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). 1. Description of Plan

The following description of the Simmons Hanly Conroy 401(k) Plan, (the “Plan”), provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan generally covering all employees, as defined in the plan document, of Simmons Hanly Conroy LLP, Consumer Acquisition Solutions, Sokolove Law, LLC, Digital Strategy, LLC, Rex Encore, LLC, Theodora Farms, and Flock at Park Park, (collectively, the “Employer”) who are age 21 and older. There is no minimum service requirement to participate in the Plan and employees may enter the Plan the beginning on the first day of the month after meeting all eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective July 1, 2025, the Plan was formally amended to add Tom’s Place Hospitality Group, LLC as an adopting employer of the Plan.

b. Contributions

Participants in the Plan may contribute a percentage of pretax annual compensation, as defined in the Plan, up to the maximum dollar limit set by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated investment fund until changed by the participant. Automatically enrolled participants may elect to increase or decrease deferral percentages and may elect to stop deferrals.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Plan also allows participants to make Roth contributions to the Plan on an after-tax basis.

1. **Description of Plan (Continued)**

b. **Contributions (Continued)**

The Plan provides for discretionary employer matching contributions for participants who have completed at least one year of service working at least 1,000 hours and are an active participant on the last day of the Plan year. For the year ended December 31, 2024, the Employer made discretionary matching contributions, for those who are employees of Simmons Hanly Conroy LLP, Consumer Acquisition Solutions, Sokolove Law, LLC, and Digital Strategy, LLC, equal to 100% of eligible compensation that a participant contributed to the Plan. For the year ended December 31, 2024, the Employer made discretionary matching contributions, for those who are employees of Rex Encore LLC, Theodora Farms, and Flock at Park Park, LLC equal to 100% of eligible compensation up to 5% of eligible compensation that a participant contributed to the Plan. The Employer may also make additional discretionary contributions, but did not elect to do so for the year ended December 31, 2024.

Contributions are subject to certain IRC limitations. Participants may direct the investment of all their contributions among one or more fund investment options offered by the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan provisions.

c. **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer's discretionary matching contributions as well as any additional discretionary Employer contributions and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contributions and the earnings thereon, is based on years of continuous service. A participant is 25% vested after two years of service and then vests an additional 25% each year thereafter. A participant is 100% vested after five years of credited service or in the event of death or total and permanent disability.

1. Description of Plan (Continued)

e. Payment of Benefits

On termination of service due to death, disability, retirement, separation of service, or attainment of age 59 ½, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. At December 31, 2024 and 2023, if a separated participant's vested interest in the Plan is less than \$7,000 or \$5,000, respectively, a mandatory lump-sum distribution may be made to the participant. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

f. Forfeited Accounts

Forfeited accounts may be used to pay administrative expenses of the Plan or to reduce future employer matching contributions. At December 31, 2024 and 2023, the forfeited non-vested accounts totaled \$79,238 and \$56,619, respectively. Forfeitures of \$53,917 and \$52,696 were applied to Employer contributions for the years ended December 31, 2024 and 2023, respectively.

g. Administrative Expenses

The Plan sponsor bears substantially all administrative costs of the plan, including the costs of officers and employees who perform certain administrative functions. Administrative expenses that are paid by the Plan consist of fees charged by the Plan's trustee.

2. Summary of Significant Accounting Policies

The following are the significant policies followed by the Plan:

a. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

b. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets available for benefits and the changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Payment of Benefits

Benefit payments are recorded when paid.

e. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

f. Income Taxes

The Plan's income tax filings are subject to examination by various taxing authorities. The Plan's open examination periods are 2021 and forward.

g. Contributions Receivable and Allowance for Credit Losses

Contribution receivables are reduced by an estimate made for an allowance for credit losses. The Plan is exposed to credit losses resulting from the inability of the Plan Sponsor to make the required payments. The Plan establishes an allowance for these potential credit losses based on its review of historical loss statistics, current business conditions and macro-economic trends. The Plan applies credit loss estimates to the contribution receivables to determine expected credit losses. There is no allowance for credit losses at December 31, 2024 and 2023.

h. Subsequent Events

Subsequent events have been evaluated up to August 19, 2025, the date these financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy within is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Represented by separate accounts inside a group annuity and valued at the net asset value (NAV) of the separate accounts. The net asset value is used as a practical expedient to estimate fair value.

Common/Collective Trusts: Valued at the net asset value (NAV) of units of the collective investment trust held by the Plan. The NAV is based on the fair value of the underlying investments and is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Exempt Party-in-Interest Transactions

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the trustee as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

7. Tax Status

The Plan adopted a volume submitter plan from Principal, which received an opinion letter from the IRS on June 30, 2020, stating that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since the date of the aforementioned opinion letter, the Employer and the Plan Administrator believes that the Plan is designed, and currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. Risk and Uncertainties

The Plan invests in various investment instruments. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
