- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of *Universal/Land Profit Sharing Plan and Trust* and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about *Universal/Land Profit Sharing Plan and Trust's* ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with

generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of *Universal/Land Profit Sharing Plan and Trust's* internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about *Universal/Land Profit Sharing Plan and Trust's* ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) (modified cash basis), as of the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the

underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 – Description of Plan

The following description of the Universal/Land Profit Sharing Plan and Trust provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General

The plan is a defined contribution plan covering all non-union employees of Universal/Land Construction Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan contains participant directed investments.

Eligibility

New employees become eligible to defer a portion of their eligible compensation and for company matching on the first entry date following 90 days of service. Entry dates are the 1st of every month.

New employees become eligible for profit sharing contributions on the first entry date following completion of one year of service. Entry dates are January 1, April 1, July 1 and October 1.

Participant Contributions

Participants may elect to make 401(k) salary deferral and/or designated Roth contributions of their eligible compensation subject to the Internal Revenue Code limitations. The participants are permitted to modify their deferral elections at any time.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 5% of eligible compensation, and an auto increase of 1% each plan year until reaching 10%. Contributions are automatically invested in the T. Rowe Price target date funds based off the participant's date of birth until changed by the participant.

Eligible employees may make rollover contributions to this plan from distributions from another qualified plan.

Company Contributions

Matching contributions - The Company will match 100% of participants elected 401(k) salary deferral contributions up to 6% of compensation.

Profit sharing contributions - The Company may make profit-sharing contributions to be determined at the discretion of the board of directors. The board of directors elected not to make profit sharing contributions in 2024 and 2023.

Prevailing wage contributions - The Company will contribute to each participant working on a project governed by the Davis-Bacon Act an amount required under the Davis-Bacon Act. There were no Davis-Bacon contributions for the years ended December 31, 2024 and 2023.

Participants' Accounts

Separate accounts are maintained for 401(k) deferred compensation, designated Roth, prevailing wage, employee rollover contributions, profit sharing, and Company matching for each participant as applicable. Participants' accounts are credited with the respective contributions and forfeitures if applicable, and earnings (losses) based on participant selected investment performance.

Annual contributions otherwise allocable to the profit-sharing account of a given participant are reduced by the annual amount of the participant's prevailing wage benefits.

Vesting

Participants are immediately 100% vested in their 401(k) salary deferral, Company matching and prevailing wage contributions plus allocated earnings thereon. Vesting in the Company profit-sharing contribution is based on years of service. A participant is 100% vested after six years of credited service.

Forfeitures

Terminated participants' non-vested amounts are first used to pay plan expenses. Remaining amounts are allocated to current participants on the basis of their individual participant compensation over total compensation, integrated with compensation in excess of the social security taxable wage base. The amount allocated on the basis of compensation in excess of the social security taxable wage base is subject to a ceiling which shall not exceed 5.7% of compensation. There were no forfeitures for the years ended December 31, 2024 and 2023.

Investment Options

Upon enrollment in the plan, a participant may direct contributions made on their behalf in any of the approved Empower Life and Annuity Company's investment options. Participants may change their contribution investment options and may transfer balances daily.

Administration Costs

Investment transactions and broker fees are paid by the plan. Certain transaction costs are paid from the account of the participant initiating the transaction. The plan sponsor pays all other administration costs.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account, and as of December 31, 2024 and 2023, interest rates ranged from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service, a participant may elect to receive vested benefits in a single lump-sum distribution or in optional annuities according to plan limitations. In service withdrawals before age 59½ are permitted in case of financial hardship, as defined by the plan. "Hardship" withdrawals are available only to the extent that the participant has no other available resources to meet the financial needs, and the amount of withdrawal cannot exceed the amount needed.

Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

The modified cash basis of accounting requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 2 – Significant Accounting Principles and Estimates

Basis of Accounting

The financial statements are prepared on the modified cash basis of accounting. Under this method, contributions and realized investment earnings (losses) are recognized when received and expenses are recognized when paid. Unrealized changes in the market value of investments are recognized when the Plan is valued at the end of any period. Under accounting principles generally accepted in the United States of America, contributions and investment earnings (losses) would be recognized when earned and expenses would be recognized when the resources are used and a liability is incurred. Accordingly, the accompanying financial statements are not intended to present financial position in conformity with accounting principles generally accepted in the United States of America. The accounting for the valuation of investments would be the same under either method.

Investments

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from investments is recorded on the modified cash basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income includes unpaid interest. Related fees are charged directly to the participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make repayments on the note and the plan administrator considers the note receivable from the participant to be in default, the note balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits to participants are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Recently Adopted Accounting Standards:

In June 2016, the Financial Accounting Standards Board (“FASB”) issued Accounting Standards Update (“ASU”) 2016-13, Financial Instruments — Credit Losses (Topic 326) (with subsequent targeted amendments) which modifies the measurements of expected credit losses for certain financial instruments and financial assets, including contribution receivables. This guidance was effective for fiscal years beginning on or after December 15, 2022 and was adopted by the Plan on January 1, 2023 using the prospective method. Application of the standard did not require a cumulative-effect adjustment to net assets available for plan benefit as of the effective date and did not have a material impact on the financial statements.

Subsequent Events

The plan trustees are not aware of any subsequent events requiring disclosure or adjustments in the financial statements as of July 25, 2025, the date the financial statements were available to be issued.

Note 3 – Party-in-Interest Transactions

The Plan has a number of service providers. Such parties are parties-in-interest under ERISA. All transactions were exempt from the prohibited transaction rules of ERISA.

Empower is the custodian and trustee as defined by the plan, and is the Plan administrator, recordkeeper, and investment advisor of the Plan assets. Transactions with these parties qualify as party-in-interest transactions. Administrative fees of \$38,280 and \$32,432 were paid to these parties during the years ended December 31, 2024 and 2023. In addition, as of December 31, 2024 and 2023, the Plan held \$6,853 and \$6,695 in investments with these parties.

Note 4 – Risks and Uncertainties

The Plan provides for investments in various investment options. Investments are exposed to risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment options, it is at least reasonably possible that changes in the values of investment options will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 5 – Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Level 1 - Unadjusted quoted prices in active markets for identical assets. These assets include investments in interest-bearing cash accounts and mutual funds. The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2 - Significant other observable inputs, including quoted prices for similar securities, interest rates, credit risk, etc. that are determined for an asset, either directly or indirectly, based on independent market data. These assets include a fixed annuity contract. The fair value of the fixed annuity contract is obtainable/observable through the review of existing contracts and readily available financial information of the issuing financial institution.

Level 3 - Significant unobservable inputs for the asset or liability that reflect the plan's own assumptions which market participants would use in pricing the asset based on the best information available. The plan did not have any level 3 assets.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value at the reporting date.

Note 6 – Plan Termination

Although the Company has not expressed intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.
