Our opinion is not modified with respect to that matter.

NOTE 1- DESCRIPTION OF PLAN

The following description of the Lenco 401 (k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan was established in January 2013. The Plan is a defined contribution plan covering all eligible employees of Lenco Diagnostic Laboratories Inc. (the "Company" and "Employer") as defined in the Plan Agreement, and allows eligible participants to invest pre-tax earnings in a 401 (k) fund. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Termination

In January 2024, the Sponsor announced an agreement to sell substantially all of the assets of its clinical laboratory segment to Quest Diagnostics Inc. (the "Asset Sale"). Most Lenco Diagnostics Laboratories, Inc. employees were terminated in April 2024, the scheduled closing date of the sale and a WARN report was filed with the New York State Department of Labor.

On July 2, 2024, Board of Directors of the Company approved the Plan termination effective August 30, 2024. The necessary regulatory filings and notifications to participants were completed. The termination of the Plan does not affect the benefits accrued by participants up to the termination date, and all accrued benefits were distributed in accordance with the Plan provisions and applicable regulations.

Trustees and Administrator of the Plan

Reliance Trust Company is the asset trustee of the Plan. ADP Inc. provides recordkeeping and retirement services for the Plan.

The Plan is administered by the Company's management and third-party administrator, Pentegra Retirement Services.

Eligibility and Contributions

Employees who are at least 21 years of age are eligible to participate in the Plan on the first day of the month after the completion of three months of employment. Participants may make elective salary deferral contributions to the Plan, which are not to exceed statutory limits. Under the provisions of the Plan, maximum salary deferral is 90%. Participants direct their investments in numerous investment options offered by the Plan. There is no default investment option. The Company may decide to make a matching contribution to the Plan, although the Company is not required to make this contribution. Matching contributions were \$0 for the period ended October 31, 2024 and for the year ended December 31, 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account, as defined in the Plan agreement.

Vesting

Participants are 100% vested in their contributions attributable to salary deferrals, safe harbor contributions and actual earnings therefore.

Forfeitures

As participants are fully vested upon entrance to the Plan, there are no forfeited account balances.

Withdrawal and Payment of Benefits

A participant's interest in the Plan's assets is distributable generally upon termination, disability, retirement or death. In addition, participants may request withdrawals pursuant to specific guidelines as set forth in the Plan.

Notes receivable from participant

Each participant is permitted to borrow up to 50% of his or her vested account balance to a maximum of \$50,000. However, the \$50,000 amount in the preceding sentence is reduced by the highest outstanding loan balance participant had under the Plan during the previous one-year period. The minimum loan is \$500. The term of a loan may not exceed five years, unless it is used to purchase a principal residence. Loans used to purchase participant's primary residence may be repaid within a period of no more than 30 years. The interest rate is the prime rate as published in The Wall Street Journal on the 14th of each month, plus two percentage points. This interest rate is effective for any loan processed as of the 16th day of the month.

NOTE 2- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affects the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Payments of Benefits

Benefits are recorded when paid. Upon termination of services due to death, disability or retirement, a participant may elect to receive either a lump sum distribution equal to participant's vested interest in his or her account, or annual installment. For termination of service for other reasons, a participant may receive the value of vested interest in his or her account balance as a lump sum distribution.

Notes Receivable from Participants

Notes receivable from participants are measured at their principle balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 provides framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value

Following is a description of the valuation methodology used for assets measured at fair value.

Common/collective trust funds: Valued at respective net assets value (NAV) of units of the collective/common trust. The NAV, as provided by trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for the amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5- TAX STATUS

On July 8, 2014, the Internal Revenue Service (“IRS”) stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401 of the Internal Revenue Code (“IRC”). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6- RISKS AND UNCERTAINTIES

The Plan’s investments are concentrated in funds that invest in marketable securities. Such securities are subject to various risks, such as interest rate, market and credit risks, that determine the value of the funds. Due to the level of risk associated with certain securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants’ account balances and the value of investments reported in the financial statements.

Notes receivable from participants are considered party-in-interest transactions because they are transacted with Plan participants.
