To the Board of Directors

Scope and Nature of the ERISA 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the accompanying financial statements of KODE Health 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of KODE Health 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

December 31, 2024 and 2023

Note A - Plan Description

The following description of the KODE Health 401(k) Plan (the “plan”) provides only general information. Participants should refer to the plan document and amendments for a more complete description of the plan’s provisions.

General

The plan is a defined contribution plan covering substantially all employees of KODE Health, Inc. (the “company”) who are age twenty-one or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of pretax or after tax eligible compensation, as defined in the plan, up to the maximum amount permitted by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the plan. The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate in the plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund on a pre-tax basis until changed by the participant. The company makes a safe-harbor matching contribution of 100% of an employee’s deferral up to 3% of compensation, plus 50% of an employee’s deferral between 3% and 5% of compensation for the year ended December 31, 2024. The company may make discretionary profit-sharing contribution to the plan. No profit-sharing contribution was made for the year ended December 31, 2024. The company contribution is invested as directed by the participant.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and company matching contributions, as well as allocations of the plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note D - Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All investments held by the plan consist of mutual funds and are classified as Level 1 in the fair value hierarchy as of December 31, 2024 and 2023.

Note E - Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the plan, any party rendering service to the plan, the employer and certain others. Certain plan investments are in funds and/or accounts that are managed by Benefit Trust Company, the plan's custodian. Participant loan and distribution processing fees are paid to Guideline, the plan's recordkeeper.

Note F - Plan Amendment and Termination

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provision of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note G - Tax Status of Plan

The plan has adopted a Guideline Technologies, Inc. Defined Contribution pre-approved plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated September 26, 2024. The plan has not applied for its own determination letter. The plan has been amended since this date; however, the plan administrator believes that the plan is designed and is being operated in compliance with the applicable requirements of ERISA and the Internal Revenue Code. Accordingly, no provision for income taxes has been included in the plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note H - Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
