Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rana USA Inc. 401(k) Profit-Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

1. Description of the Plan

The following description of Rana USA Inc. 401(k) Profit-Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the published summary Plan booklet for a more complete description of the Plan's provisions.

General:

The Plan became effective on January 1, 2012. The Plan is a defined-contribution plan covering all employees of Rana USA Inc. (the Company) and participating affiliates as denoted in the Adoption Agreement. The purpose of the Plan is to enable eligible employees to save for retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan participation:

An employee of the Company shall become eligible to participate on the first day of the calendar month following the date on which the employee attains the age of 18 and has met the service requirement. The service requirement for eligibility is one month of service.

Contributions:

Each year, participants may contribute up to the lesser of 90% of pre-tax annual compensation as defined in the Plan or the maximum amount as allowed by the Internal Revenue Code (the Code). Contributions can be made on a regular 401(k) "pre-tax" basis or on a Roth 401(k) "after-tax" basis. Participants may also contribute rollover amounts representing distributions from other qualified plans. The Plan includes a traditional Automatic Contribution Arrangement thereby automatically enrolling all participants who are not deferring any amount and who did not make a timely Affirmative Election to not contribute elective deferrals at a rate of 6% of compensation per pay period. The automatic deferral will increase annually by 1% up to a maximum of 10%.

The Plan has a safe harbor matching contribution equal to 100% of employee salary deferrals that do not exceed 1% of the deferred compensation plus 50% of the salary deferrals between 1% and 6% of the deferred compensation.

In addition, the Company may make an annual discretionary profit-sharing contribution in an amount to be determined at Plan year-end by the Company's Board of Directors. A participant must be employed as of the last day of the Plan year to be eligible for a profit-sharing contribution. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

1. Description of the Plan (continued)

Participant accounts:

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and (b) Plan earnings and decreased with the participant's withdrawal and allocations of administrative expenses. A participant directs his or her and the Company's contributions in the various investment options offered by the Plan. Allocations are based on participant's earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

A participant's vested portion of the employer contribution amounts plus earnings thereon credited to his or her account is based on the number of years of service to the Company.

For the years ended December 31, 2024 and 2023, the vested portion is determined in accordance with the following schedule:

Years of service	Vested portion
Less than 2	0%
At least 2 but less than 3	20%
3 or more	100%

Participants will become fully vested in their employer contributions and earnings upon death or total and permanent disability.

Participants are vested immediately in their contributions plus earnings thereon.

Investment options:

The Plan currently offers a variety of registered investment companies and common collective trust funds as investment options for participants.

1. Description of the Plan (continued)

Payment of benefits:

A participant becomes entitled to benefits under the Plan upon normal retirement, death, disability or other termination of employment. Benefit payments are generally paid in a lump-sum as soon as practicable after employment with the Company has ended. Participants who terminate with account balances greater than \$5,000 may elect to leave their account balances in the Plan.

Until such time as the funds are distributed, the participant is entitled to receive a pro-rata share of fund earnings. Benefits may also be paid directly to an eligible retirement plan as an eligible rollover distribution.

Participant loans:

A participant may borrow from their fund accounts amounts not to exceed the lesser of \$50,000 or 50% of the vested portion of the balance with the minimum loan amount being \$500. The term of all loans shall be 60 months or less (360 months for purchase of principal residence). Participants may only have two loans outstanding at a given time. The loan interest rate is determined by the Plan Administrator based on interest rates charged for similar types of loans by other lenders.

Forfeitures:

If a participant terminates employment and is less than 100% vested in the employer account, then he or she may forfeit the nonvested portion of the employer account. A forfeiture will occur in the Plan year that a distribution of the entire vested account balance is received or after five consecutive one-year breaks in service if a distribution is not made. Forfeitures of employer matching contributions are used to reduce the Company's future matching contributions or to reduce administrative expenses. The Company used \$57,614 of accumulated forfeitures towards matching contributions during the year ended December 31, 2024. There were \$9,958 and \$8,144 of forfeiture account balances at December 31, 2024 and 2023, respectively.

2. Summary of significant accounting policies

Basis of accounting:

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants:

As described in Note 1, the Plan allows for participants to borrow against their vested account balance and the loan is secured by the participant's account balance. Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest. Participant loans are repaid ratably through regular payroll deductions and loan defaults are treated as distributions.

Administrative expenses:

All administrative costs, charges and expenses are paid by the Plan to the extent not paid by the Company.

Payment of benefits:

Benefits are recorded when paid.

Contributions:

Participants' contributions are recognized by the Plan when withheld from the participants' paychecks by the Company.

2. Summary of significant accounting policies (continued)

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Subsequent events:

The Plan Administrator has reviewed and evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.

3. Investments (information prepared and certified by Reliance Trust Company (the Trustee))

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in these financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Trustee.

The Trustee certified the fair value of investments of \$15,843,195 and \$13,315,983 as of December 31, 2024 and 2023, respectively. Notes receivable from participants of \$763,230 and \$565,138 were also certified by the Trustee at December 31, 2024 and 2023, respectively. Interest rates for outstanding loans ranged from 4.25% to 9.50% as of December 31, 2024 and 2023.

The Trustee certified that the Plan's investments (including gains and losses on investments bought, sold and held during the year) appreciated value in the amount of \$1,402,186 for the year ended December 31, 2024. Dividend income was \$415,894 and interest on participant loans was \$51,007 for the year ended December 31, 2024, as certified by the Trustee.

4. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

5. Tax status of the Plan

The Company has received a favorable determination letter from the Internal Revenue Service dated October 2020, stating that the Plan is in compliance with the applicable requirements of the Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and is being operated in accordance with applicable rules and regulations of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

6. Party-in-interest transactions

Fees paid by the Plan to the third party administrator amounted to \$24,216 for the year ended December 31, 2024. The Plan also contracts with an investment advisor. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for these investment services totaled \$20,014 for the year ended December 31, 2024.

7. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Common collective trust funds: Valued at the net asset value (NAV) of units held by the Plan at year-end. NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes that the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
