Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Perfect Sense, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Perfect Sense, Inc. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Perfect Sense, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at year end) at December 31, 2024 is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO THE FINANCIAL STATEMENTS

Note 1. Description of Plan and Significant Accounting Policies

The following description of the Perfect Sense, Inc. (PSI) – Perfect Sense, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was adopted effective January 1, 2009, and is a defined contribution plan covering all full-time employees of Perfect Sense, Inc. (the Company) who are at least 21 years of age and have completed 1 month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator and Asset Custodian Trustee oversees the governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Administrator and Asset Custodian Trustee.

Plan Amendments: The Plan was amended in 2017 and 2016 to incorporate certain updated provisions of ERISA. The plan was amended in 2020 to temporarily suspend safe harbor match in accordance with IRS Notice 2020-52. The plan was amended in 2021 to reinstate the safe harbor match. The plan was amended in 2023 to include an automatic deferral provision.

Contributions: Each employee may elect to contribute pretax annual compensation up to the maximum amount allowed by the internal revenue code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants. Effective October 1, 2017, under the newly adopted prototype Plan (See Note 3), the Company matches employee contributions at 100% of the first 3% of compensation and 50% of the next 2% of the participants' compensation contributed to the plan. Beginning in 2023, The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 5% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. Auto-enrolled participants have automatic contribution escalations of 1% annually, unless they elect otherwise.

Participant Accounts: Each participant's account is credited with the participant's and employer's contributions and an allocated share of plan earnings, and charged with an allocation of administrative expenses which varies depending on the investment option selected by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and in employer matching contributions. Employer discretionary additional plan contributions to employee accounts vest based on the following schedule of full years of service: less than 1 – 0%, 1 year – 25%, 2 years – 50%, 3 years – 75%, 4 years – 100%.

Notes Receivable from Participants: Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through monthly payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in member requested service expense when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make a loan repayment and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Note 1. Description of Plan and Significant Accounting Policies (Continued)

Excess Contributions Payable: Amounts payable to participants totaling \$5,000 of contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to contributions. All excess contributions are distributed prior to March 15 of the following year. There were no excess contributions for the year ended December 31, 2024 or 2023.

Expenses: Certain expenses of maintaining the Plan are paid by PSI and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participants account.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a set period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Benefits are recorded when paid.

Forfeited Accounts: Forfeitures from terminated participants are available for employer matching contributions or to offset plan administrative expenses. At December 31, 2024 and 2023, forfeited accounts held no substantial amounts.

Participant Rollover: Participants may roll over an amount from another plan to this plan under certain circumstances. This is a rollover contribution and becomes part of the participants' vested account.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting: The financial statements of the plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statements of Net Assets Available for Benefits and The Statements of Changes in Net Assets Available for Benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. For 2024 and 2023, fair value was equal to contract value.

Investment Options: Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the available investment options. Participants may change their investment options or transfer among investment options at their discretion.

Investment Valuation and Income Recognition: Investments are reported at fair value except for the fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. For 2024 and 2023, contract value for the fully benefit-responsive investments was approximately equal to fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Deposits and Investment Asset Custodian Trustee and Plan Administration

The Plan contracted with ADP Retirement Services for plan administration services and Reliance Trust Company to provide individual participant account, asset investment and asset custodian management and trustee services. The Asset Custodian Trustees maintain the Plan assets in a pooled investment account maintaining separate accounting for each participating retirement plan. The separate account is credited with contributions received from the Plan, along with an allocated share of the net investment earnings and is maintained and accounted by individual participant. Individual participants are charged for the fees associated with administrative and trustee services. Investment management costs and fees are direct expenses of the individual investment funds.

Note 3. Tax Status

The Plan is adopted under a prototype defined contribution plan arrangement with ADP Retirement Services, which has received approval from the Internal Revenue Service (IRS) that its prototype defined contribution plan is designed in accordance with the applicable regulations of the Internal Revenue Code (IRC).

ADP Retirement Services, as sponsor of the prototype defined contribution plan, amended the Plan to reflect the provisions included in the regulations published by the Departments of the Treasury and Labor. These amendments are intended to provide good faith compliance with the requirements of those regulations.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax reporting periods in progress.

Note 4. Plan Termination

Although it has not expressed any intent to do so, PSI has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the company may determine.

Note 5. Information Prepared and Certified by Plan Trustee

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statements of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 and 2023, and the accompanying notes to the financial statements were prepared from information certified by the Asset Custodian Trustee, Reliance Trust Company, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information reported and certified includes:

Statement of Net Assets Available for Benefits: All investments and participant loans.

Statement of Changes in Net Assets Available for Benefits: All items and amounts adjusted for employee and employer contribution receivable.

Supplemental Schedule: All items and amounts.

The accompanying notes to the financial statements were prepared from information certified by the Plan Administrator and Asset Custodian Trustees.

Note 6. Fair Value Measurements

The Financial Accounting Standards Board (FASB) has issued guidance for measurement and disclosure of fair value and establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Quoted prices for similar instruments in active and inactive markets and model driven valuations with significant inputs and drivers derived from observable active markets.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

Collective Investment Trust: Fair value of the collective trust fund and a variety of separate accounts and mutual funds are used in determining the NAV held by the Plan at year end.

Cash Deposits: Cash funds held for investments valued at stated deposit value.

Self-Directed Brokerage Account: Valued based on quoted market prices on an active exchange or the underlying net asset values of the investments.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers of investments into or out of level 3 as of the date of the event or change in circumstances that caused the transfer.

Note 8. Guaranteed Investment Contract with Insurance Company

The Plan was entered into a benefit-responsive fixed income guaranteed income contract with Reliance Trust Company, (RTC). RTC maintains the contributions in a general account. The account was credited with interest and charged for participant withdrawals and administrative expenses. The guaranteed fixed income contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed fixed income contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at fair value with an adjustment to contract value in arriving at net assets available for benefits. There is no adjustment made for 2024 or 2023 because contract value approximates fair value. Contract value, as reported to the Plan by RTC, represents contributions made under the contract by participants, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 8. Income Contract with Insurance Company (Continued)

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the Plan's ability to transact at contract value with RTC. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

That discrepancy of \$2,488 was corrected during 2024 causing an opening balance adjustment as shown above. Amount is not material to the financial statements.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
