We have performed an audit of the accompanying financial statements of Gateway Management Group, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ## NOTES TO FINANCIAL STATEMENTS

December 31, 2024

---

### 1. DESCRIPTION OF THE PLAN

The following brief description of the Gateway Management Group, LLC 401 (K) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

#### **General**

The Plan is a defined contribution plan covering substantially all full-time employees of Gateway Management Group, LLC (the “Company”) who meet eligibility requirements. Participants are eligible to participate in the Plan after completing 1,000 hours of service during the first 12 months of employment. Must be at least age 21 as well. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### **Contributions**

Participants in the Plan may elect for any calendar year to contribute on a pretax basis, up to the lesser of the maximum amount permitted under Section 402(g) of the Internal Revenue Code of 1986 (\$23,000 for 2024) as adjusted by a cost of living factor each year or 50 percent of their annual compensation. In addition, certain participants are allowed to contribute an additional amount (\$7,500 for 2024) to the Plan as allowed by the catch-up rules. Contributions are subject to certain limitations.

The employer only makes discretionary contributions. For the Plan year ended December 31, 2024, the employer provided discretionary contributions of 25 percent of the amount contributed by each participant up to their first 4 percent of deferred contributions to the Plan.

#### **Participant accounts**

Each participant’s account is credited with (a) the participant’s contributions, (b) the Company’s contributions, and (c) Plan earnings and appreciation. Each participant’s account is charged with (a) any withdrawals or distributions, (b) Plan losses and depreciation, and (c) an allocation of administrative and mutual fund expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Investment options**

Participants were able to allocate their contributions among a variety of managed funds by Reliance Trust.

## 1. DESCRIPTION OF THE PLAN - CONTINUED

### **Vesting**

Participants are always 100 percent vested in their deferred contribution. Participants are 100% vested in their employer contributions after 6 years of service.

### **Participant loans**

Participants may borrow from their accounts a minimum of \$1,000 up a maximum equal to the less of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 4.25 – 9.50 percent. Principal and interest are paid ratably through payroll deductions.

### **Payment of benefits**

On termination of service due to death, disability, or retirement at age 65, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account, or a joint and survivor annuity. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeited accounts** – At December 31, 2024, there were no forfeited nonvested accounts. These accounts will be used to pay plan expenses. For the year ended December 31, 2024, none of forfeitures were used to pay administrative expenses.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Investments valuation and recognition**

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes both realized and unrealized appreciation, including those investments bought and sold during the year.

### **Payment of benefits**

Benefits are recorded when paid.

### Payment of administrative expenses

It is the policy of the Plan that certain administrative expenses pertaining to the Plan be paid by the Company.

## 3. FAIR VALUE MEASUREMENTS

FASB ASC 820-10, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

### *Level 1 Fair Value Measurements*

Level 1 inputs are quoted prices in active markets on the actual asset being valued. An active market has sufficient transaction activity to provide pricing information on an ongoing basis.

### *Level 2 Fair Value Measurements*

Level 2 inputs are those other than quoted prices in Level 1 that are observable and include the following quoted prices on similar assets in active markets; quoted prices for identical or similar assets in markets that are not active; observable inputs other than quoted prices such as yield curves, volatilities, prepayment speeds, or inputs derived principally or corroborated by observable market data by correlation or other means.

### *Level 3 Fair Value Measurements*

Level 3 inputs are unobservable inputs for the asset reflecting internal assumptions used to arrive at an estimate or exit price. Those inputs are based on the best information available in the circumstances.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 3. FAIR VALUE MEASUREMENTS - CONTINUED

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

### 4. TAX STATUS

The Internal Revenue Service has determined that the Plan meets the requirements of Section 401(a) of the Internal Revenue Code and is exempt from federal tax under Section 501(a) of the Code.

The Plan continually evaluates expiring statutes of limitations, audits, changes in tax laws and new authoritative rulings. The Plan files an annual return in the U.S. federal jurisdiction.

**5. INFORMATION CERTIFIED BY THE CUSTODIAN**

Reliance Trust has certified the completeness and accuracy of certain information which management used in preparing the financial statements, supplemental schedule and accompanying notes as of December 31, 2024. Accordingly, this information was not audited. The following is a summary of information provided by the custodian:

- Investments and notes receivable from participants as reported in the Statement of Net Assets Available for Benefits at December 31, 2024 and 2023.
- Investment income (loss) and interest income on loans to participants as reported in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024.
- Investments and loans to participants as reported in the supplemental Schedule of Assets (Held at End of Year) at December 31, 2024.

**6. RISKS, UNCERTAINTIES AND CONCETRATIONS**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits. The plan has 64% of its net assets concentrated in 5 investment funds.

**7. PLAN TERMINATION**

While it is the Company's intention to continue the Plan indefinitely, it has the right to terminate or amend the Plan at any time. No amendment, however, may permit any part of the assets of the Plan, other than those required to pay taxes and administrative expenses, to be used for any purpose other than for the exclusive benefit of the participants.

**8. RELATED PARTY TRANSACTIONS**

Account fees were paid by the Plan for services provided by Reliance Trust, the third party administrator as defined by the Plan. Reliance Trust provided services such as participant enrollment and financial advisor for the Plan.

**10. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through July 25, 2025, the date on which the financial statements were available to be issued.
