INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of Bakery Express Mid-Atlantic 401(k) Plan and its Participants:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bakery Express Mid-Atlantic 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. DESCRIPTION OF THE PLAN

The following description of the Bakery Express Mid-Atlantic, Inc. 401(k) Plan (the Plan) for the employees of Bakery Express Mid-Atlantic, Inc. (the Company) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established by the Company, effective January 1, 1997. The Plan covers all employees with the following exceptions: (i) nonresident aliens are excluded from all contributions, (ii) union employees are excluded from all nonelective contributions and (iii) non-union employees are excluded from Company matching contributions. Eligible employees are permitted to enter the Plan on the first day of the month coinciding or following twelve consecutive months of employment, during which at least 1,000 hours of service are completed. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and was most recently amended on July 16, 2024, where participant loans will be granted at the prime rate plus 1%.

Participant Contributions

Participants may contribute up to 99% of their eligible annual compensation, as defined by the Plan, in the form of pre-tax deferrals or Roth after-tax deferrals. Participants' annual pre-tax contributions are subject to the Internal Revenue Code (the Code) limits, which totaled \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions, subject to limitations imposed by the Code, not to exceed \$7,500 for the year ended December 31, 2024. Participants are permitted to make rollover contributions to the Plan. Federal income tax law limited the annual compensation on which tax-qualified plan benefits may be based to \$345,000 for the year ended December 31, 2024.

Company Contributions

Union employees are eligible to receive matching contributions. The Company makes matching contributions calculated on a per-payroll basis equal to 100% of participant deferrals up to 2% of a participant's compensation plus 50% of the participant's deferrals that exceed 2% of the participant's compensation, but not to exceed 6%. Matching contributions totaled \$167,697 for the year ended December 31, 2024.

The Company will make safe harbor matching contributions for all participants eligible to make elective deferrals, with the exception of union employees. For the year ended December 31, 2023, the Company made safe harbor contributions totaling \$194,404, on a per-payroll basis equal to 100% of participant deferrals up to 4% of a participant's compensation plus 50% of the participant's deferrals that exceed 4% of the participant's compensation, but not to exceed 6%.

The Company may make additional non-elective contributions to the Plan at its discretion to eligible employees. The Company did not make any such contributions to the Plan during the year ended December 31, 2024.

Participant Accounts

Accounts are participant-directed and are credited with the participant and Company contributions and an allocation of Plan earnings and losses and are charged with any direct expenses related to the specific account. Allocations are based on participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of Company matching contributions is based on the participant's years of service, as defined by the Plan, according to the following schedule:

Any non-union employees who were participants in the Plan on December 31, 2019 are 100% vested in the Company matching contributions for all current and future Company matching contributions made to their account.

1. DESCRIPTION OF THE PLAN – cont'd.

Notes Receivable from Participants

Participants may borrow a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any time. The notes are collateralized by a participant's vested account. Note repayments are to be made each pay period through payroll deductions with interest based on the prime rate at the time of loan origination plus 2%. Effective July 16, 2024, interest for new loans are based on the prime rate plus 1%. Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes for the purchase of a primary residence are to be repaid within thirty years.

Payment of Benefits

Upon termination of service, retirement, death, disability, or attainment of age 59½, a participant, or his or her beneficiary in the event of death, is entitled to a distribution of his or her vested account balance. Distributions from the Plan are payable in the form of a lump sum or installments at the election of the participant. Upon termination, participants with vested account balances less than \$5,000 are automatically distributed as a lump-sum payment without participant consent. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, vested amounts contributed may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan document. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½. Effective January 1, 2024, in accordance with the SECURE 2.0 Act (SECURE 2.0), the Plan adopted the provision to increase the threshold for mandatory distributions from \$5,000 to \$7,000. A formal amendment incorporating this SECURE 2.0 provision is expected to be adopted no later than December 31, 2026, in accordance with Internal Revenue Service (IRS) guidelines. As of July 31, 2025, the Plan has not been formally amended for this provision. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions prior to year-end.

Forfeitures

Forfeitures of Company contributions may be applied to reduce future Company contributions and pay administrative expenses. Forfeitures become available to the Plan as of the earlier of the last day of the Plan year in which a former employee incurs five consecutive one-year breaks in service or a distribution of the participant's entire vested account balance occurs. The forfeiture account totaled \$1,199 and \$1,167 as of December 31, 2024 and 2023, respectively. The forfeiture account held uncashed checks of \$1,178 and \$1,146 as of December 31, 2024 and 2023, respectively. These amounts are not available to the Company or Plan for use. Total forfeitures of \$16,305 were used to reduce Company contributions for the year ended December 31, 2024. No forfeitures were used to pay administrative expenses for the year ended December 31, 2024.

Administrative Expenses

Direct expenses incurred in the administration of the Plan are required to be paid by the Trustee with net assets of the Plan unless paid by the Company, at its discretion. For the year ended December 31, 2024, the Company elected to pay a portion of the Plan's direct expenses. Expenses that are paid directly by the Company are excluded from the Plan's financial statements. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

The Company utilizes a revenue sharing account to offset recordkeeping fees due from the Company. Plan expenses are shown gross on the accompanying statement of changes in net assets available for benefits. Revenue sharing generated \$446 during the year ended December 31, 2024, which was used to offset recordkeeping fees. There was no balance in the revenue sharing account as of December 31, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of these investments could occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are reported at their fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded when received. Interest income is recorded when received. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement levels within the fair value hierarchy are based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Fair Value Measurement – cont’d.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

Interest in common collective trust: Value is based on the net asset value (practical expedient) as determined by the issuer.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based on the terms of the Plan document.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of these investments could occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through July 31, 2025, the date the financial statements were available to be issued and determined there were no material subsequent events that warrant disclosure.

3. INVESTMENTS

All investment information contained in the accompanying financial statements and supplemental schedule, including assets held at December 31, 2024 and 2023, interest and dividend income and net realized and unrealized appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

5. INCOME TAX STATUS

The Plan has adopted a non-standardized pre-approved profit sharing plan with a deferral arrangement which received a favorable opinion letter from the IRS dated October 6, 2020, which stated that the Plan was designed in accordance with applicable sections of the Code. The Plan administrator believes that the Plan and Trust are designed and currently being operated in compliance with applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business taxable income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognized interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits, for any periods, in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. EXCESS CONTRIBUTIONS PAYABLE

During the year ended December 31, 2024, the Plan failed to comply with certain non-discrimination rules. As a result, the Plan was required to record excess contributions payable of \$1,253 in the accompanying statements of net assets available for benefits as of December 31, 2024. The Plan refunded these excess contributions to affected participants on February 19, 2025. During the year ended December 31, 2023, the Plan was in compliance with all non-discrimination rules.
