We have performed audits of the accompanying financial statements of Mann Lake Ltd. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mann Lake LTD. 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

A. Description of Plan

The following description of the Mann Lake Ltd. 401(K) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Mann Lake Ltd. (the Company). Employees who are age 21 or older and have six months of service are eligible to participate.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees. The recordkeeper maintains records of participant data and the custodian holds Plan assets.

This Plan implemented to increase the voluntary force out threshold from \$5,000 to \$7,000 for participants, in accordance with the changes allowed under the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022. The Plan will be amended by December 31, 2025.

Contributions – Participants may make (a) pre-tax contributions to the traditional 401(k) Plan, and/or (b) after-tax contributions to the Roth 401(k) Plan of any amount of gross pay up to the maximum dollar amount allowed by law for the Plan year. Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute certain rollover amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company will match 100% of employee elective deferrals up to 4% of compensation. In addition, the Company may make discretionary non-elective contributions to the Plan which will be allocated to each participant's account based on their individual compensation as a percentage of total compensation, although the Company is not required to do so. During the years ended December 31, 2024 and 2023, the Company did not make any non-elective contributions.

Rollovers – Participants may elect to rollover amounts from other qualified plans or individual retirement accounts into the Plan, provided that certain conditions are met.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contribution, (b) Plan earnings (losses), and (c) charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Concentrations of Credit Risk – The Plan maintains its cash in a deposit account, the balance of which is periodically in excess of federally insured limits. However, no losses have been experienced in such accounts.

Vesting - Participants are immediately fully vested in their contributions and employer safe harbor contributions, plus actual earnings thereon.

Investment Options - The Plan offers a variety of mutual funds with varying general investment objectives and degrees of risk. Participants enrolled in the Plan may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change investment options during the year by logging in to their account online.

Forfeited Accounts – Forfeitures may be used to pay Plan expenses or reduce future employer matching contributions. The forfeiture balance was used to offset Plan expenses and reduce Company match of \$333 and \$80 during 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$23 and \$10, respectively.

Payment of Benefits - Upon retirement, termination of employment, disability or death, a participant or his or her beneficiary in the event of death, may elect to receive either a lump-sum payment, a partial lump-sum payment, or installment payments in an amount up to the value of the vested interest in his or her account, less any applicable tax withholdings and fees. Employees may elect in-service withdrawals of vested account balances upon attaining age 59 ½. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required age. The Plan allows for hardship withdrawals, subject to account balance limits and applicable laws.

Terminated participants with account balances of \$7,000 or less must take their account balance out of the Plan when they terminate employment. Terminated participants with account balances of \$1,000 or less will receive a lump-sum cash payment as soon as administratively practicable upon the participant's employment termination. Participants with account balances between \$1,000 and \$7,000 will be rolled over into an IRA established on their behalf as soon as administratively practicable upon the participant's employment termination.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance minus the highest total outstanding Plan loan balance in the 12 months immediately before the date of the participant's new loan. Participants may have up to two outstanding loans. The loans are issued directly from fund balances in the participant's account. These loans are included in the statements of net assets available for benefits. All notes are secured by the balance in the participant's account and bear reasonable interest rates, established by the Trustees (prime rate plus 1% in 2024 and 2023). Principal and interest are paid ratably through monthly payroll deductions, amortized over a period not exceeding five years, except in the purchase of a primary residence. Loans outstanding, including any accrued interest, at December 31, 2024 and 2023 totaled \$247,045 and \$268,799, respectively.

B. Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account, are deducted from the loan proceeds when the loan is originated, and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator deems the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Total deemed distributions of participant loans for the years ended December 31, 2024 and 2023 were \$24,986 and \$10,291, respectively.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Administrative Expenses - The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Various administrative expenses for recordkeeping and plan reporting requirements are charged directly to participants' accounts. Reliance Trust Company charges participant fees of \$55 for each withdrawal and \$125 for each new loan. Total administrative expenses paid by participants in 2024 and 2023 were \$51,984 and \$41,256, respectively. The expenses to maintain participants' accounts within the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. Total excess contributions payable for the years ended December 31, 2024 and 2023 were \$0 and \$82, respectively. The Plan distributed the 2023 excess contributions to the applicable participants prior to the year ended December 31, 2024.

Payment of Benefits - Benefit payments to participants are recorded when paid. At December 31, 2024 and 2023, there were no benefit claims payable for distributions to participants from the Plan requested prior to the end of the Plan year.

Reclassifications – Certain amounts reported in the prior year have been reclassified to conform with the current year's presentation with no effect on the previously reported in net assets available for benefit.

Date of Management's Review – Management has evaluated subsequent events for the Plan through August 13, 2025, which is the date the financial statements were available to be issued.

C. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

D. Tax Status

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the pre-approved plan indicating that the pre-approved plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

E. Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

F. Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, other income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the Trustee of the Plan).

G. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are defined under FASB ASC 820, *Fair Value Measurements*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- **Quoted prices for similar assets or liabilities in active markets;**
- **Quoted prices identical or similar assets or liabilities in inactive markets;**
- **Inputs other than quoted prices that are observable for the asset or liability; and**
- **Inputs that are derived principally from or corroborated by observable market data by correlation or other means**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023:

***Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair market value of certain financial instruments could result in a different fair value measurement at the reporting date.
