1. Description of Plan

The following description of the Bridgestone Metalpha U.S.A., Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants may review the Plan Document for a more complete presentation of the Plan's provisions. The Plan was adopted on October 1, 1995, by its sponsor, Bridgestone Metalpha U.S.A, Inc. (the "Company").

General

The Plan is a defined contribution plan that provides retirement and other benefits for all non-union, non-expatriate employees of the Company. Employees who are age 18 or older are eligible to participate and may enroll on the first day of any pay period thereafter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Administration

The Company controls and manages the operation and administration of the Plan. Fidelity Management Trust Company ("Fidelity") serves as the record keeper and custodian of the Plan. The Company pays certain operating expenses incurred in the ongoing administration of the Plan.

Contributions

Participants in the Plan may elect to contribute through salary deferrals (i.e. payroll deductions) an amount not less than one percent or more than fifty percent of their earnings, as defined in the Plan Document. The maximum annual contribution for each participant (\$23,000 and \$22,500 for calendar years 2024 and 2023, respectively) may be adjusted annually for inflation by federal statute. Participants may elect to change their contribution percentage or cease salary deferrals into the Plan at any time.

Additional contributions, called "catch-up" contributions, are allowed for employees who are age 50 or older by the end of the calendar year in which the catch-up contributions are made. Qualifying participants can make the additional contributions (limited to \$7,500 for calendar years 2024 and 2023) once the participant's regular contributions have reached the maximum annual deferral limit prescribed by federal statute. Catch-up contributions are included in the calculation of the Company's matching contributions.

During 2024 and 2023, the Company made matching contributions to the Plan equal to 50% of the lesser of: (1) each participant's total contributions to the Plan, or (2) 8% of the participant's earnings. Company matching contributions are allocated to participants each pay period. Additionally, the Company has the option of making a discretionary contribution to the Plan each Plan year. The Company exercised the option to make quarterly discretionary contributions to the plan of 2.5% for the years ended December 31, 2024 and 2023.

Each participant's account is credited with the participant's salary deferral contributions, the Company's matching contributions, allocations of the Company discretionary contributions, and an allocable portion of the Plan's net investment earnings. Participant accounts are charged with an allocable portion of Plan losses and administrative expenses. Allocations are based on participant compensation or account balances, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, including any rollovers, plus actual earnings thereon. Vesting in the remainder of the account is based on years of service, as follows:

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$166,042 and \$165,003, respectively. These accounts will be used to reduce future employer contributions. During the years ended December 31, 2024 and 2023, employer contributions were reduced by \$168,733 and \$158,499, respectively, from forfeited nonvested accounts.

Investment Options

All investments within the Plan are participant-directed. An investment election form is initially completed by each participant upon enrollment in the Plan. Participants may elect to invest their entire account, or any portion thereof, in one or more of the following investment options offered by Fidelity:

Collective Trust: One option that offers participants the opportunity to invest in stable value investment contracts and fixed income instruments.

Mutual Funds: Twenty-nine options that offer participants the opportunity to invest in shares of specified mutual funds.

Distributions to Participants

Upon termination of service due to attainment of normal retirement age, death, or permanent disability (each as defined by the Plan), a participant may elect to receive the vested value of his or her account in a lump sum distribution or in participant-directed installments. Upon termination of employment for any reason other than retirement, death, or disability, the vested value of the participant's account will be paid in a lump sum distribution. Withdrawal of part or all of a participant's account may be authorized by the Plan administrator prior to termination of employment if the participant experiences a financial hardship, as defined by the Plan.

Notes Receivable from Participants

Participant loans are limited to the lesser of 50% of the vested portion of a participant's account balance or \$50,000, with the minimum amount of each loan being \$1,000. Loans are secured by the balance of the participant's account; bear interest at a commercially reasonable rate; and are repaid through payroll deductions over a period generally not to exceed five years, unless the loan is used to acquire a home at which time the loan term would be extended over a reasonable period of time.

Plan Termination

The Company expects the Plan to continue indefinitely. However, the Company retains the right under the Plan to discontinue Company contributions at any time and to terminate the Plan subject to provisions set forth in ERISA. In the event of Plan termination, the participants shall become 100% vested in their accounts.

Date of Management's Review

Subsequent events have been evaluated through June 20, 2025, which is the date the financial statements were available to be issued.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan prepares its financial statements in conformity with U.S. generally accepted accounting principles using the accrual method of accounting.

Plan Year End

The Plan year end is December 31.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. An allowance for uncollectible notes receivable from participants is generally considered unnecessary because the outstanding loan balances are collateralized by the vested portions of the respective participants' account balances.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. Amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid were \$0 at December 31, 2024 and 2023.

3. Related Party Transactions

All Plan investments are held as shares in mutual funds managed by Fidelity, the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fidelity Workplace Services, LLC serves as the third-party administrator of the Plan. Therefore, these transactions also qualify as party-in-interest transactions. Fees paid to the custodian and the third party administrator by the Plan were \$103,586 and \$86,126 for the years ended December 31, 2024 and 2023, respectively.

4. Investments and Related Information Certified by the Custodian

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan's independent auditor did not perform any auditing procedures with respect to the information certified to as complete and accurate by Fidelity, custodian for the Plan, except for comparing such information to the related financial statements and supplemental schedule of assets (held at end of year). Accordingly, all information presented in the accompanying financial statements and supplemental schedule pertaining to investments held at December 31, 2024 and 2023, and investment income and net appreciation (depreciation) in fair value of investments for the Plan years then ended, was obtained from certifications by Fidelity, and is therefore unaudited.

5. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Level 1 Fair Value Measurements: The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements:

Collective Investment Trust: The collective investment trust invests in a collective trust fund, as well as a variety of separate accounts and mutual funds. The fair value of the collective investment trust and the separate accounts are not publicly quoted pricing inputs. The fair values of mutual funds are publicly quoted pricing inputs. The fair values of all these investments are used in determining the NAV of the collective investment trust, which is not publicly quoted. FASB ASC 820 allows NAV per share to serve as a practical expedient to estimate the fair value of a collective investment trust as long as certain requirements are met. It is the assessment of Principal, the custodian of the Plan, that the Plan's collective investment trust meets those requirements. FASB ASC 820 goes on to state that where NAV is allowed to be used as an estimate of fair value, if the reporting entity has the ability to redeem its investment at NAV as of the measurement date, that investment shall be categorized as a Level 2 fair value measurement. If the investment cannot be redeemed at the measurement date, but may be redeemable in the future, but at an uncertain date, the investment shall be categorized as a Level 3 fair value measurement. The Plan's collective investment trust can be redeemed at NAV as of the measurement date and, therefore, is categorized as a Level 2 fair value measurement. Unfunded commitments are not applicable to collective investment trusts. The redemption frequency (if currently eligible) for participant transactions (purchased and sales) is daily, and the redemption notice period is generally 30 days. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Internal Revenue Service has determined and informed the Plan administrator by a letter dated June 15, 2004 that the Plan was designed in accordance with the applicable regulations of the Internal Revenue Code. The Plan has been amended since receiving the determination letter; however, the Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is no longer subject to federal, state and local income tax examinations by tax authorities for fiscal years ended before December 31, 2021.

Plan participants are not subject to federal income taxes on contributions to their accounts or the related account earnings until they receive a distribution from the Plan. Distributions that are rolled over to another qualified retirement plan generally continue to be tax-deferred until ultimate distribution to the participant.

7. Risks and Uncertainties - Investments

Financial instruments that potentially subject the Plan to significant concentrations of credit risk consist principally of cash and mutual funds. The Plan places its cash with federally-insured financial institutions. The Plan's mutual funds include investments in securities, which are inherently exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain mutual funds, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the accompanying "Statement of Net Assets Available for Benefits."

8. Reconciliation of Financial Statements to Form 5500

The financial statement caption "Net assets available for benefits," presented on pages 5 and 6 of the accompanying financial statements, is synonymous with the caption "Net assets" presented in Part 1, Line 11 of Schedule H to Form 5500.

In accordance with the instructions to IRS Form 5500, investment income from registered investment companies is to be reported as a component of the "Net investment gain (loss)" for the reporting period. For financial reporting purposes, investment income from such investments is to be reported as a separate line item on the "Statement of Changes in Net Assets Available for Benefits."
