Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pioneer Telephone Cooperative, Inc. Non-Qualified Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. GENERAL DESCRIPTION OF THE PLAN

The following description of the Pioneer Telephone Cooperative, Inc. (the "Company"), Non-Qualified Savings Plan (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. General

The Plan, effective November 11, 1985, is a savings plan covering eligible employees of the Company, the Plan sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees are eligible to participate in the Plan.

All costs of plan administration are paid by the Company. The Plan does not provide for participant direction of account balances.

B. Contributions

The Company does not make any employer contributions to the Plan. Effective January 1, 2017, the Plan no longer allows employee contributions. There were no employee contributions for the years ending December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”). Employee contributions are accrued in the year in which the contributions are determined to be payable.

B. Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The Plan's investment in the insurance company guaranteed interest account is reported at contract value as it has been deemed fully benefit responsive. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus interest at the contract rate, less benefits paid to participants.

Interest income is recorded when earned.

D. Payment of Benefits

Benefits are recorded when paid.

E. Date of Management's Review

Subsequent events were evaluated through the date the financial statements were available to be issued.
