

NOTE 1 **DESCRIPTION OF PLAN**

The following brief description of TCLAD Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

1. General

The Plan is a defined contribution plan established by TCLAD Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company is the administrator and sponsor of the Plan and has appointed VOYA Retirement and Annuity Company as Trustee and recordkeeper of the Plan, respectively. The Plan's Investment Committee determines the appropriateness of the Plan's offerings, monitors investment performance and reports to the Company's Board of Directors. The Plan was effective on June 1, 2021.

2. Eligibility

Substantially all employees become eligible upon completion of 30 days and entry date will be the first day of the month coinciding with or next following the date the participant satisfied the eligibility requirement. Employees covered by a collective bargaining agreement and leased employees are excluded from participation in the Plan.

3. Contributions

Each year, participants may contribute, up to the maximum limits of the Internal Revenue Code ("IRC") of their pretax annual compensation (salary reduction contributions), as defined in the Plan Document. Participants may designate all or a portion of their deferral contributions as after tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company provides a safe harbor match contribution of 100% of the first 4% and 50% of the next 4% up to a maximum of 8% of base compensation that a participant contributes to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. The Company contributions are made each pay period.

4. Investment Options

Upon enrollment into the Plan, a participant may direct employee and Company contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

5. Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, if any, and allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

6. Participant Loan Accounts

The Plan allows participants to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest loan balance in the last 12-month period. Loan terms range from 1 to 5 years, or, if the loan is used to acquire a principal residence, the payment terms can be 10 years. Participants are allowed two outstanding loans. The loans are secured by the vested balance in the participant's account and bear interest rates at the prevailing national prime rate plus 1% at the last business day of the month. Principal and interest are paid through payroll deductions, or, if a participant terminates employment with the Company, the participant may continue to make loan payments directly to the trustee. If the loan is not repaid, the loan will be defaulted and be treated as a distribution to the participant.

7. Payment of Benefits

Distribution of a participant's account can occur on termination of employment, for in-service withdrawals for participants who have attained age 59½, or through hardship withdrawals requiring administrative approval as explained in the Plan Document. A lump-sum payment will be made for all distributions of participants' accounts with a balance of less than \$5,000 as soon as practicable. Participants who terminate employment with a balance of greater than \$5,000 may request a distribution in a lump-sum payment or installments.

8. Plan Termination

It is expected that the Company will continue the Plan indefinitely, but it reserves the right to terminate the Plan at any time subject to the provisions of ERISA and applicable collective bargaining agreements. If the Plan is terminated, the participants will become 100% vested, and the trustee shall continue to hold the trust funds and to distribute the participants' accounts as if the Plan had not terminated.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES
AND USE OF ACCOUNTING ESTIMATES****Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

Accounting Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements stated at fair value using quoted market prices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the Net Assets Available for Benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of **December 31, 2024** and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES
AND USE OF ACCOUNTING ESTIMATES (CONTINUED)**

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Payment of Benefits

Benefit payments to participants are recorded upon distribution and not accrued upon termination of employment.

NOTE 3 FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used when necessary and available to the Plan, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There has been no changes in the methodologies used at **December 31, 2024** and 2023.

Level 1 Fair Value Measurements

Money market account: Value at the closing price reported on the active market on which the individual funds are traded and at accumulated unit value of shares (amortized cost) held by the Plan at the year end.

Level 2 Fair Value Measurements

The pooled separate accounts are valued at net asset values ("NAV") as reported by such accounts, which are reported at fair value. The values are based on valuations provided by the annuity provider of the underlying investments as of the date investments are valued adjusted to apply the expense factor disclosed in the annuity contract.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits.

NOTE 4 GROUP ANNUITY CONTRACTS WITH INSURANCE COMPANIES

The Plan has a group annuity contract with VOYA Retirement Insurance and Annuity Company ("VOYA") as of **December 31, 2024** and 2023. The contract is a traditional investment contract. Under the contract, the participant principal and interest are fully guaranteed by the general account assets of VOYA. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

VOYA is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rating, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

The average yield earned by the Plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the audit periods. The average for the years ended **December 31, 2024** and 2023 was 1.5 percent for both the years. The actual average yield earned by the Plan for the benefit responsive fund can be derived by averaging the Plan's quarterly interest rates. The average for the years ended **December 31, 2024** and 2023 was 1.5 percent for both the years.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include premature termination of the contract; Plan terminations or merger; plant closings, layoffs, changes to the Plan's prohibition or competing investment options; and bankruptcy of the Plan Sponsor.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer as that would limit the ability of the Plan to transact at contract value.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee organization, or a relative of such persons mentioned.

Certain Plan investment options are investments offered by the Trustee of the Plan. Additionally, fees incurred by the Plan for investment manager services are included in investment income for the audit periods. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 6 **NOTES RECEIVABLE FROM PARTICIPANTS**

Participants in the Plan are eligible to borrow up to 50 percent of their vested interests in the Plan up to a maximum amount of \$50,000. The loans are repaid through biweekly payroll deductions over the term of the loan. As of **December 31, 2024** and 2023, the Plan had outstanding loans to participants in the amount of **\$134,679** and \$85,996, respectively. The loans include interest of **4.25** to **9.5** percent and are secured by the balance in the participant's account. Interest income earned on the loan balances for **2024** was **\$8,665**.

NOTE 7 **BOND**

The Company maintains a fidelity bond through an insurance agency that covers ten percent of the net assets available for benefits of the Plan.

NOTE 8 **PLAN TAX STATUS**

The Plan uses a Prototype Plan document established by the Trustee, who received an opinion letter from the Internal Revenue Service dated June 30, 2020, which stated the Prototype Plan document satisfies applicable regulations of the IRC. The Company believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the Company to evaluate tax positions taken by the Plan. The effects of an uncertain tax position are recognized in the financial statements when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan and has concluded that as of **December 31, 2024** and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions.

NOTE 9 **INFORMATION CERTIFIED BY THE PLAN TRUSTEE**

The Plan administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income and Security Act of 1974. Accordingly, as permitted under such election, no independent auditing procedures were performed with respect to the information certified by VOYA, the trustee, as of and for the years ended **December 31, 2024** and 2023.

The Plan trustee has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the Statements of Net Assets Available for Benefits as of **December 31, 2024** and 2023 and the supplementary Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of **December 31, 2024** and the related investment activity and interest income reported in the Statements of Changes in Net Assets Available for Benefits for the year ended **December 31, 2024**.

NOTE 10 **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market conditions, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

The Plan had investments of **\$4,124,852** and \$3,206,012 that were concentrated in five funds at **December 31, 2024** and 2023, respectively.

NOTE 11 **SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through **August 8, 2025**, the date the financial statements were available to be issued.
