Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Peter Kiewit Sons', Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Basis for Opinion

1. Plan Description

The following brief description of the Peter Kiewit Sons', Inc. Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Peter Kiewit and Sons', Inc. (the Company).

The Plan is administered by the Company and includes participating plan agreements for various Company divisions that participate in the Plan. The participating plan agreements include Peter Kiewit Sons', Inc., Mining Company Nonunion Craft, and Nonmining Nonunion Craft. Also, a participating plan agreement for the union employees of Weeks Marine, Inc. (including its Hopper Dredge division) became effective January 1, 2024. The participating plan agreements differ in many respects, including eligibility requirements, contribution limitations, and other provisions. Participants should refer to the participating plan agreement for the Plan's provisions specific to their employment for a more detailed description of the Plan's provisions.

In December 2023, the Company approved the merger of the Weeks Group 401(k) Savings Plan, the Hopper Dredge 401(k) Savings Plan, and the Weeks Marine Local 25 Yard Employees 401(k) Retirement Plan (collectively, the "Weeks Marine Plans"). Participants of the Weeks Marine Plans began participating in the Plan effective for payroll periods starting on January 1, 2024. The effective date of the mergers was December 31, 2023. Assets of the Weeks Marine Plans were in the process of being transferred to the Plan as follows as of and for the year ended December 31, 2023:

The Plan Oversight Committee ("POC") was created by the Executive Committee to review, develop, and implement an investment structure and policy for the Plan. The main responsibilities of the POC is to monitor on a periodic basis the performance of each investment manager, recordkeeping and review investment fees. The POC meets periodically to review overall plan investment performance. The POC ensures that there is a comprehensive employee communication program in place for participants of the Plan which is intended to provide information to assist participants in making informed decisions among the investment choices offered in the Plan. The POC hires service providers and investment advisors as needed to assist with executing their roles. The POC will monitor, add or remove service providers, investment advisors and investment managers as necessary. The POC is comprised of senior personnel from legal, finance, accounting, benefits, and human resources.

A brief summary, by Company division, of the Plan is provided below for general information. Participants should refer to the participating plan agreements for the Plan's provisions specific to their employment for a more detailed description of the Plan's provisions.

(i) Peter Kiewit Sons', Inc.

All salaried or hourly paid employees over 18 years of age of the Company are eligible to participate in the Plan the first day of the month following the date of hire. Participants may contribute up to 75% of their eligible salary, not to exceed certain Internal Revenue Service (IRS) limitations. Participants are automatically enrolled with a 6% salary deferral contribution. The deferral amount for each participant will increase by 1% every twelve months up to a maximum of 10%. The employer may make an annual profit sharing contribution, at its discretion, to eligible participants who are employed on December 31 and have completed 1,000 hours of service during the Plan year. The employer will make a weekly contribution based on the participants contributions up to 100% of the first 6% of the participants contributions.

(ii) Mining Company Nonunion Craft

All hourly paid manual production or maintenance employees over 18 years of age of Buckskin Mining Company and Kiewit Mining Group, Inc. are eligible to participate in the Plan on the first day of the month following two months of service. Participants may contribute up to 75% of their eligible salary, not to exceed certain IRS limitations. Participants are automatically enrolled with a 4% salary deferral contribution. The deferral amount for each participant will increase by 1% every twelve months up to a maximum of 8%. Buckskin Mining Company and Kiewit Mining Group, Inc. will make a weekly matching contribution based on the participant's contributions up to 100% of the first 4% of the participant's contributions.

(iii) Nonmining Nonunion Craft

All nonmining nonunion craft employees over 18 years of age are eligible to participate in the Plan on the first day of the month following two months of service. Participants may contribute up to 75% of their eligible salary, not to exceed certain IRS limitations. Participants are automatically enrolled with a 4% salary deferral contribution. The deferral amount for each participant will increase by 1% every twelve months up to a maximum of 8%. The employer may make an annual profit sharing contribution, at its discretion, to eligible participants who are employed on December 31 and have completed 1,000 hours of service during the Plan year. In addition, the Company will make a weekly matching contribution based on the participant's contributions up to 100% of the first 4% of the participant's contributions.

(iv) Prevailing Wage Craft

All nonunion hourly paid manual employees over 18 years of age who are employed on a Davis Bacon Job are automatic participants in the Plan on the first day of employment. Participants are automatically enrolled with a 4% salary deferral contribution. The deferral amount for each participant will increase by 1% every twelve months up to a maximum of 8%. The Company will contribute, based on the participant's compensable hours, the amount set forth on the prevailing wage craft pension plan schedule rates as set forth in the participating plan agreement.

(v) Local 25 Craft

All Local 25 union craft employees over 18 years of age are eligible to participate in the Plan the first quarter after 6 months from date of hire. Participants may contribute up to 75% of their eligible salary, not to exceed certain IRS limitations. The deferral amount for each participant will increase by 1% every twelve months up to a maximum of 8%. In addition, the Company will make a weekly matching contribution based on the participant's contributions up to 50% of the first 5% of the participant's contributions.

(vi) Hopper Dredge Union Craft

All Hopper Dredge union craft employees over 18 years of age are eligible to participate in the Plan the first quarter after 90 days from date of hire. Participants may contribute up to 75% of their eligible salary, not to exceed certain IRS limitations. The deferral amount for each participant will increase by 1% every twelve months up to a maximum of 8%. There is no company match.

Participants may take hardship withdrawals for reasons specified in the participating plan agreements. Additionally, effective April 2025, distributions for qualified birth, adoptions, domestic abuse, qualified disaster recovery and emergency expenses are also allowed under the Plan. Loans for up to 50% of their elective contribution may be taken out for reasons specified for hardship withdrawals at an interest rate of 1% above the prime lending rate established at the beginning of each calendar quarter (7.50% at December 31, 2024), with a maximum maturity of five years, the balance of which must be at least \$1,000 and may not exceed \$50,000. Repayment of loans is made ratably via payroll deductions, with both the principal and interest being credited to the borrower's account balance.

Contributions

Participants may contribute pre-tax, after-tax, and after-tax Roth contributions to the Plan based on a percentage of their annual eligible compensation, as provided for in the respective participating plan agreements, up to the maximum dollar amounts allowable by law. Participants are automatically enrolled in the Plan based on plan documents. Participants may also contribute amounts representing distributions from other qualified plans. Company matching and profit sharing contributions are determined separately by each participating plan agreement and are allocated only among the participants eligible in that respective Company division. All participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations. Effective April 1, 2024, participants can make an election to receive a student loan Company matching contribution at the end of the Plan year equal to 100% of the first 6% of qualified student loan payments that they make in the Plan year.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching and profit sharing contributions as defined in their respective participating plan agreement and (b) Plan earnings or losses. Each participant's account is also charged with the allocation of administrative expenses incurred by the Plan directly related to that participant's account, including loan fees and self-directed brokerage account fees. Plan earnings and losses are allocated on the basis of actual results of the investments selected by each participant. The Company's matching contributions are allocated to participants based on the participant's elected salary deferral and applicable participating plan agreement. The Company's profit sharing contributions are allocated based on eligible compensation as described in the applicable participating plan agreement. Investments are maintained in individual member accounts managed by the Fidelity Management Trust Company (FMTC).

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive either a lump sum or installment payments equal to the value of the vested funds allocated to the participant's account. A brief summary, by Company division, of the distribution payments is provided below.

(i) Peter Kiewit Sons', Inc.

Distribution payments between \$1,000 and \$5,000 will be paid out to the participant in the event the participant does not elect a payout option.

(ii) Mining Company Nonunion Craft

Distribution payments between \$1,000 and \$5,000 will be paid out to the participant in the event the participant does not elect a payout option.

(iii) Nonmining Nonunion Craft

Distribution payments between \$1,000 and \$5,000 are directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option.

(iv) Prevailing Wage Craft

Distribution payments between \$1,000 and \$5,000 are directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option.

(v) Local 25 Craft

Distribution payments between \$1,000 and \$5,000 are directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option.

(vi) Hopper Dredge Union Craft

Distribution payments between \$1,000 and \$5,000 are directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option.

Benefit payments are recorded when paid.

Forfeitures

The nonvested portion of the Company's contributions may be forfeited upon termination of a participant's employment. Such forfeitures may be used to reduce Company contributions or to pay Plan expenses. There were \$10,972,251 and \$9,900,537 in forfeitures used to reduce Company contributions in the years ended December 31, 2024 and 2023, respectively. Forfeitures used to pay Plan administrative fees totaled \$335,871 and \$364,216 for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,955,220 and \$7,869,778, respectively.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, Plan Accounting – Defined Contribution Plans.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Employer Contribution Receivable

Additional discretionary contributions can be made to participants at the option of the Company's Board of Directors. During the years ended December 31, 2024 and 2023, the Company did not approve a discretionary contribution, therefore, there were no related employer contributions receivable recorded at December 31, 2024 and 2023.

Other

Certain administrative expenses are paid by the Company for the Plan and are excluded from the financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Fees and costs associated with maintaining accounts of participants no longer actively employed with the Company are charged to those participants' accounts.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through August 18, 2025. See the "General" section of Note 1 for a description of a subsequent event.

3. Information Certified by FMTC

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by FMTC, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds and Money Market Fund: Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission.

These funds are required to publish their Net Asset Value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued at the NAV based on the market value of its underlying investments. The NAV is marked to market daily on the value of the underlying assets owned by the fund, minus the liabilities and then divided by the number of shares outstanding. The Plan has concluded that the NAV as adjusted is classified within Level 1 in the fair value hierarchy as the NAV is determined daily. Also, there were no unfunded commitments or redemption restrictions.

Self-Directed Brokerage Accounts: The self-directed brokerage accounts include investments in money market funds, mutual funds, and common stocks. The common stocks, mutual funds, and money market funds are valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The IRS has determined and informed the Company by a letter dated September 8, 2013, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirement of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Related-Party Transactions

Certain Plan investments are mutual funds, money market funds, self-directed brokerage accounts, and common collective trusts managed by FMTC. FMTC is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the plan administrator has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.
