Note 1 - Plan Description

The following description of Orthopedic Centers of Colorado, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible class employees of Orthopedic Centers of Colorado, LLC (the "Company") who have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on January 1, 2018 and most recently restated on January 1, 2022. Effective January 1, 2024, the Plan was amended such that employees who have completed 30 days of service are eligible to make elective deferral contributions and employees who have completed one year of service are eligible to receive discretionary matching contributions and profit-sharing contributions.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the Internal Revenue Service. IRC Section 415 limits the aggregate contribution made to all plans, which may reduce the contribution allowed under the Plan.

The Company may make annual discretionary matching contributions. Participants who have completed one year of service on or before December 31, 2024 and continue employment through December 31, 2024 will be eligible to receive an allocation of the Company's discretionary contribution. The Company did not make an annual discretionary matching contribution for the year ended December 31, 2024.

The Company may make an additional discretionary profit-sharing contribution to the Plan. Participants who have completed one year of service, regardless of their employment status, as of December 31, 2024 will be eligible to receive an allocation of the Company's discretionary profit-sharing contribution. For the year ended December 31, 2024, the Company made discretionary profit-sharing contributions of \$2,208,723, net of forfeitures.

The Company may elect to make a discretionary safe harbor 401(k) contribution for any plan year of at least 3 percent of the compensation of non-highly compensated employees for that portion of the plan year during which they are participants in the Plan. A safe harbor basic matching contribution is a contribution equal to 100 percent of the first 3 percent of eligible compensation and 50 percent of the next 2 percent of eligible compensation that non-highly compensated participants elect to defer into the plan year. A safe harbor enhanced matching contribution is a contribution equal to 100 percent of at least 4 percent of eligible compensation that non-highly compensated participants elect to defer into the Plan. All safe harbor contributions will be 100 percent vested at all times. For the year ended December 31, 2024, the Company made a discretionary safe harbor 401(k) contribution of \$1,289,740.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.5 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants' contributions and any discretionary safe harbor 401(k) contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

The Company's matching and profit-sharing discretionary contributions, if any, vest according to the following schedule:

4 but fewer than 5	60
5 but fewer than 6	80
6 or more	100

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$132,853 and \$163,269, respectively.

The Plan used \$170,185 for the year ended December 31, 2024 to reduce employer contributions.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Related Party and Party-in-interest Transactions

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Self-directed brokerage accounts include corporate stocks and mutual funds, valued based on quoted market prices, and money market funds, which are valued based on the funds' outstanding balance.

The common/collective trust funds are valued at net asset value per share (NAV) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets.

See Note 5 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid. At December 31, 2024, there were no benefit payments requested but not paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 13, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

John Hancock Trust Company, LLC (the "Trustee") holds the Plan's investments and participant notes receivable, other than the investments in the self-directed brokerage account, and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year, other than the investments in the self-directed brokerage account, are based solely on information certified by the Trustee.

The Plan's investments in the self-directed brokerage account, totaling \$25,268,648 and \$21,302,825 at December 31, 2024 and 2023, respectively, and related investment income of \$3,903,103 for the year ended December 31, 2024 were not certified by John Hancock Trust Company, LLC.

Note 4 - Tax Status

The Plan adopted a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
