*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Thorlabs, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1 - Description of Plan

The following brief description of the Thorlabs, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan, adopted on December 1, 1993 and subsequently amended, is a participant-directed defined contribution plan established to provide retirement benefits to eligible employees, as defined, of Thorlabs, Inc. (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### **Administration**

The Company supervises and manages the operations and administration of the Plan. Certain employees of the Company serve as Plan administrators of the Plan, and Ascensus Trust Company is the trustee and custodian (the Trustee).

##### **Eligibility**

An employee is eligible to participate in the Plan at the next entry date after completing one month of service and attaining the age of 21. Entry dates are the first day of January, April, July and October.

The Plan has an auto-enrollment policy under a qualified automatic contribution arrangement ("QACA"). This policy automatically enrolls all new participants into the Plan after completing one month of service at 3% of their eligible salary. If new participants do not make a deferral election, the initial deferral rate will increase 1% annually until 6% deferral is reached. Employees must opt out of the Plan to cease enrollment.

##### **Contributions**

Participants may elect to contribute up to 100% of their pre-tax or post-tax (including Roth) annual compensation, as defined in the Plan, subject to certain limitations of the Internal Revenue Code (the "IRC"). The Company's matching contribution for the year ended December 31, 2024 is 100% on the first 1% of the deferral (dollar for dollar match) and 50 cents on the dollar on the next 5% of deferral. The Company, at its discretion, may also contribute additional matching amounts to the Plan. Participants who have attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions up to \$7,500 in 2024 and 2023. The Company does not provide a matching contribution on catch-up contributions. There were no additional matching contributions made to the Plan for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

A participant may, with the consent of the Plan administrator, make a rollover contribution to the Plan at any time. Rollover contributions are assets transferred to the Plan from a qualified savings plan in which employees participated prior to their employment by the Company.

##### **Participant accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution and earnings and losses thereon, and charged with withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

#### **Investments**

Participants direct the investment of their contributions into various investment options offered by the Plan. Company contributions are automatically invested in the funds as the employee directs. The Plan currently offers 31 mutual funds and one common/collective trust as investment options for the participants.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions is based on years of service. In accordance with the QACA, a participant entering the Plan will be 50% vested in his or her Company matching contributions after one year of credited service, and will be 100% vested after two years of credited service.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the vested balance in the participant's account, whichever is less. The notes receivable from participants are secured by the vested balance in the participant's account and bear interest at a rate of prime rate plus 1%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through weekly payroll deductions over a one- to five-year period, unless the notes receivable from participants are used to purchase a primary residence.

#### **Payment of benefits**

For termination of service for any reason, a participant will receive his or her vested balance in the form of a lump-sum.

#### **Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,481 and \$32,876, respectively. These accounts will be used to reduce future employer contributions, subject to the Plan's provisions. During 2024, \$52,785 of forfeited nonvested accounts were used to reduce employer contributions.

### **Note 2 - Summary of accounting policies**

#### **Basis of accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, trustee and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### Payment of benefits

Benefit payments to participants are recorded upon distribution.

#### Expenses

Fees related to the administration of notes receivable from participants as well as check processing fees are charged directly to the participant's account. Investment-related expenses are included in net appreciation in fair value of investments. Additionally, certain expenses of administering the Plan are deducted from Plan assets.

#### Subsequent events

The Plan has evaluated subsequent events through July 29, 2025, which is the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The Plan applies the fair value measurement provisions as required by Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures* ("ASC 820"), as issued by the Financial Standards Accounting Board ("FASB"). ASC 820 provides a framework for measuring fair value including a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under the FASB issued ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust funds:* Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Interest-bearing accounts:* Valued at fair value by discounting the related cash flows based on current yield of similar instruments with comparable duration considering the creditworthiness of the issuer.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **Note 4 - Tax status**

The Plan obtained its opinion letter on a prototype plan approved by the IRS, effective June 30, 2020. The IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5 - Administrative expenses**

Administrative costs of originating and maintaining participant loans, as well as check processing fees, are deducted from the participant's account. Additionally, certain expenses of administering the Plan are deducted from Plan assets.

#### **Note 6 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7 - Certified investments**
