## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Campbell Companies 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

**(1) PLAN DESCRIPTION**

The Campbell Companies 401(k) Profit Sharing Plan and Trust (the Plan) is a deferred compensation plan for employees of Campbell Companies (the Company). Significant provisions of the Plan, including elective deferral contribution, matching, eligibility, and vesting are described below. Participants should refer to the Plan document for a more complete description of the provisions of the Plan.

**(a) General**

The Plan is a defined contribution plan, covering employees who are not otherwise covered under a collective bargaining agreement, who have completed sixty days of service, and are age 18 or older. Any participant who subsequently fails to perform a full year of service will be placed on inactive status. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**(b) Contributions**

Participants may elect to contribute up to 100 percent of their gross annual income into the Plan up to a maximum of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants age 50 and over may contribute an additional \$7,500 and \$7,500 for the years ended December 31, 2024 and 2023, respectively. The Company matches 100 percent of employee contributions limited to four percent of each employee's qualifying income.

**(c) Vesting**

Participant contributions vest immediately. Company contributions and the earnings thereon are fully vested upon completion of five years of employment service, retirement, death, or disability. Prior to the fifth year, vesting in any Company contribution or earnings thereon is on a graduated basis and vest at the rate of 20 percent per year.

**(d) Investment Options**

Participants may direct contributions to any of the investment options as detailed in Schedule 1 of this report.

**(e) Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. A participant may have no more than one loan outstanding at any given time. The loans are secured by the balance in the participant's account and bear interest at the rate of 4.25 to 10.50 percent.

***(f) Employer's Contributions and Forfeitures***

Contributions are recorded in separate accounts for each employee. The non-vested portion of employer contributions, and earnings thereon, forfeited by employees are used to decrease required employer contributions in the following year. The forfeiture balance totaled \$166,730 and \$234,309 for the years ended December 31, 2024 and 2023, respectively.

***(g) Allocation of Earnings***

The net increase or decrease in the value of the Plan's assets attributable to interest, dividends, and changes in market value is allocated to the participants according to their percentage of total assets by fund.

***(h) Distribution of Benefits***

Benefits are distributed upon retirement, disability, death, or termination of employment. Participants may choose to have their vested account paid under one or more of the optional forms available under the Plan.

***(i) Plan Termination***

Although it has not expressed any intent to do so, the Company may terminate the Plan subject to provisions of ERISA. In the event the Plan is terminated, the interest of all affected participants will become fully vested and non-forfeitable. The Plan's assets shall be distributed to participants and beneficiaries according to their proportionate account balances.

**(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***(a) Basis of Presentation***

The accompanying financial statements have been prepared on the modified-cash basis of accounting. The modified-cash basis is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP) under which asset additions and deletions are recognized based on cash receipts and disbursements and investments are adjusted to fair value.

***(b) Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value or its equivalent for which the fair value is not readily determinable. See Note 6 for a further discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year.

***(c) Other Income and Other Costs***

For the years ended December 31, 2024 and 2023, other costs consist of certain administrative custodial fees, loan fees, and professional fees from independent consultants.

***(d) Use of Estimates***

The preparation of the financial statements in conformity with the modified-cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and disclosure of liabilities (contingent or otherwise) at the date of the financial statements, and the reported amounts of additions and deletions during the reporting period. Actual results could differ from those estimates.

***(e) Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***(f) Risks and Uncertainties***

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

***(g) Subsequent Events***

Subsequent events have been evaluated through August 8, 2025, the date that the financial statements were available to be issued.

***(h) Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the plan document.

**(3) RELATED PARTY TRANSACTIONS**

Certain Plan investments are managed by Empower Annuity Insurance Company (EAIC), the trustees of the Plan, and therefore qualify as party-in-interest. These party-in-interest transactions, as well as notes receivable from participants, are not considered prohibited transactions by statutory exemptions under ERISA regulations.

**(4) TAX STATUS OF THE PLAN**

The Plan uses a prototype plan document, which received an opinion letter from the IRS, dated March 31, 2008, stating that the prototype document satisfies the applicable provisions of the Internal Revenue Code. The Plan itself has not received a determination letter from the IRS and the prototype has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

**(5) INFORMATION CERTIFIED BY PLAN TRUSTEE**

The following data has been certified as complete and accurate by EAIC, who is the plan trustee, as of and for the years ended December 31, 2024 and 2023:

- (a) Investments managed by EAIC included in the statements of net assets available for benefits (modified-cash basis) and the cost and market value information included in the accompanying supplemental schedule of assets (held at end of year) (modified-cash basis);
- (b) Investment income included in the statement of changes in net assets available for benefits (modified-cash basis) consisting of net appreciation/depreciation in fair value of investments, interest, and dividends.

**(6) FAIR VALUE OF INVESTMENTS**

The Plan's investments are stated at fair value. Fair value is the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

- Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets or liabilities;
- Level 2 - Quoted prices for identical or similar assets or liabilities in markets that are not considered to be active or identical or similar financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurements and unobservable.

**(6) FAIR VALUE OF INVESTMENTS (CONTINUED)**

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. In periods of market inactivity, the observability of prices and inputs may be reduced for certain instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or from Level 2 to Level 3.

Registered Investment Companies (RIC)

Valued at the daily closing price as reported by the fund. RIC's held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The RIC's held by the Plan are deemed to be actively traded.

**(7) POOLED SEPARATE ACCOUNTS (PSA)**

Investments in PSA are valued at the net asset value of units held by the Plan at year end reflecting the closing price reported on the applicable active market on which the underlying investments in equity securities are traded. ASC 820 allows Net Asset Value (NAV) per share to serve as a practical expedient to estimate the fair value of a PSA as long as certain requirements are met. The Plan's PSA meet those requirements. The PSA can be redeemed at NAV on a daily basis. Unfunded commitments typically are found in private equity funds and therefore are not applicable to PSA.

**(8) GUARANTEED INCOME FUND**

The Guaranteed Income Fund (GIF) is a group annuity product issued by EAIC. Amounts contributed to the contract are deposited in EAIC's general account. Payment obligations and the fulfillment of any guarantees specified in the group annuity contract are insurance claims supported by the full faith and credit of EAIC. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is affected directly between the Plan Sponsor and the issuer. The repayment of principal and interest credited to participants is a financial obligation to the issuer. Given these provisions, EAIC considers this contract to be fully benefit responsive. Therefore, contract value is the only required measure.

**(9) COMMON COLLECTIVE TRUST**

Investments in common and collective trust funds are valued based upon the redemption price of units held by the Plan, which is based on the current fair value of the common and collective trust funds' underlying assets. Unit values are determined by the financial institution sponsoring such funds by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. The Plan holds the right to liquidate its positions in these common and collective trust funds at any time, subject to a reasonable notification period. No unfunded commitment existed with respect to these common and collective trust funds at December 31, 2024 and 2023.
