Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of D.G. Yuengling & Son, Inc., 401(k) Savings & Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events considered in the aggregate, which raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



Note 1. Plan Description

The following description of D. G. Yuengling & Son, Inc., 401(k) Savings & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General: The Plan is a defined contribution employee benefit plan which was established January 1, 1985. The Plan is available to all eligible employees of Yuengling Beer Co. Inc., Yuengling Brewery Museum & Gift Shop, Yuengling Brewing Company of Tampa, Inc., and D. G. Yuengling & Son, Inc., (the Corporation). To participate in salary deferral and employer match, an employee must attain age 21 and complete 60 days of service. To participate in the employer discretionary profit-sharing contribution, an employee must attain age 21, complete one year of service and be employed at year end. Bargaining and hourly rate non-bargaining employees of D. G. Yuengling & Son, Inc. are not eligible for the employer discretionary profit-sharing amount because the Corporation also sponsors a qualified defined-benefit plan for these employees, unless they have elected to cease additional benefit accruals under the defined benefit plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendments: Effective January 1, 2017, the Plan was amended to exclude union and part-time employees from plan participation.

Effective July 1, 2021, the Plan added an automatic enrollment provision whereby participants will automatically have five percent of their compensation deferred into the Plan as a pre-tax 401 (k) deferral unless they elect otherwise. The automatic deferral provision applies to all participants who become a participant in the Plan on or after July 1, 2021. Additionally, as of October 1, 2021, the automatic deferral provisions will apply to all existing participants except for those who have a salary deferral agreement in effect as of October 1, 2021, provided that the deferral amount under the agreement is at least equal to automatic enrollment provision.

Contributions: Each year, participants may elect to contribute up to the maximum allowable per IRC Section 415 deferral limitations. Employees may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan. At its discretion, the Corporation may make a matching contribution equal to a uniform percentage of salary deferral. An additional discretionary profit-sharing amount may be contributed at the option of the Corporation allocated to participants in proportion to each participant's compensation to the compensation of all participants eligible to share in the contribution for each designated classification among the participating companies. Contributions are subject to certain limitations.

Participant's Accounts: Each participant's account is credited with the participant's contributions, allocations of the Corporation's contribution and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Plan Description (Continued)

Vesting: Participants are vested immediately in their contributions and actual earnings thereon. Vesting in the Corporation's contribution is based upon years of service. After two years of service, participants become vested at twenty percent (20%). Vesting increases twenty percent (20%) per year thereafter, until fully vested at six years of service.

Payment of Benefits: A participant shall be entitled to receive the balance held in his or her account upon retirement, reaching age 59 ½, upon death or disability or upon termination of employment. Participant benefits are paid in a lump sum. There is an option of taking an annuity payment on the portion of the participant's balance attributable to the D.G. Yuengling & Son, Inc., Money Purchase Pension Plan that was merged into this Plan. Effective April 1, 2018, the Plan was amended to permit hardship distributions.

Administrative Expenses: Expenses incurred for administration of the Plan are paid by the Plan through revenue sharing amounts and by the Corporation.

Forfeitures: Forfeitures represent the non-vested portion of a participant's account upon termination and shall be used to reduce future employer contributions or pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$34,823 and \$60,241, respectively. During 2024, forfeitures of \$48,079, were used to reduce employer contributions.

Note 2. Significant Accounting Policies

Basis of Accounting: The accounting records of the Plan are maintained on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Note 2. Significant Accounting Policies (Continued)

Investment Contracts: Investment contracts held by a defined-contribution plan are required to be reported at fair value if not benefit responsive. The Plan invests in an investment contract through an insurance company group annuity contract with an investment option available in a guaranteed interest account. The Plan's guaranteed interest contract is not fully benefit responsive as the contract does not meet the basic criteria to be considered a benefit responsive contract under accounting standards. Transfers from the guaranteed interest account to other investments options may be subject to a market value adjustment (i.e., valued at the lesser of contract or market). However, the Plan Administrator has determined that the contract value of the guaranteed interest account approximates fair value as of December 31, 2024 and 2023, and any adjustment from contract value to fair value is not material to the financial statements.

Payment of Benefits: Benefit payments are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through July 25, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Current and Former Custodians

Certain information related to investments is disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024, and net appreciation in fair value of investments, and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Ascensus, LLC, an authorized representative of Ascensus Trust Company (the Custodian of the Plan).

Certain information related to the guaranteed interest account is disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including the balance held at December 31, 2024, and net appreciation in fair value, and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.).

Certain information related to investments is disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2023, was obtained by management and agreed to information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (the former Custodian of the Plan).

Note 3. Information Certified by the Current and Former Custodians (Continued)

Effective January 1, 2024, the Plan's custodial responsibilities were transferred to The Vanguard Group ("Vanguard") as the new custodian of the Plan. Prior to that date, John Hancock Life Insurance Company (U.S.A.) served as the Plan's custodian and held the Plan assets. In connection with the change in custodians, on December 29, 2023, all investments in the Plan, other than the guaranteed interest account, were liquidated. Cash in transit at December 31, 2023, represents the funds in transit from John Hancock Life Insurance Company (U.S.A.) to Vanguard. These funds were not covered under the investment certification obtained from John Hancock Life Insurance Company (U.S.A.).

Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.

- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The Plan's investments consist of a money market fund and registered investment companies (mutual funds), held by The Vanguard Group, and a guaranteed interest account held by John Hancock Life Insurance Company (U.S.A.). The following is a description of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund and registered investment companies: Shares of a money market fund and registered investment companies (mutual funds) are valued at the closing price as reported by the fund. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed Interest Account: The insurance Company's guaranteed interest account consists of an investment in the general assets of John Hancock Life Insurance Company and is stated at contract value, which approximates fair value. Contract value represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Fair value is based on a formula that incorporates prevailing interest rates. Inputs used to determine the fair value of the general account are considered to be Level 2.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The Plan has entered into a group annuity contract with John Hancock which provides for an investment in a guaranteed interest account. The guaranteed interest account guarantees the return of principal plus compound interest earned over the selected term of three years. New contributions each year earn the current interest rate published at the beginning of the month of contribution. A dollar-weighted composite rate of interest is computed at the end of each contribution year, which is used to compute earnings for the remainder of the guaranteed term. Withdrawals from the guaranteed interest account prior to end of the guarantee period are subject to a market value adjustment. Contract value represents the aggregate of all contributions, interest earned, less administrative fees and participant withdrawals. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

As described in Note 2, the guaranteed interest account is not fully benefit-responsive. Transfers from a participant's guaranteed accounts to registered investment companies are subject to certain restrictions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Corporation had the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

Note 7. Tax Status

The Plan has adopted a non-standardized pre-approved profit-sharing plan with CODA sponsored by Ascensus, LLC. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the Plan's qualified status. Although the Plan has since been amended, the Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America, require plan management to evaluate tax positions taken by the Plan and recognize a tax liability, if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Related Party Transactions

Plan investments include shares of mutual funds and a money market fund managed by The Vanguard Group, Inc. (Vanguard). Vanguard is the contracted recordkeeper and therefore, these transactions qualify as party-in-interest transactions. Vanguard retained Ascensus, LLC as a subcontractor to perform recordkeeping services for the Plan on its behalf.

Plan investments also include a guaranteed interest account managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is the Custodian of the guaranteed interest account and therefore, these transactions qualify as party-in-interest transactions.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
