To the Board of Directors of Horner Electric, Inc. and the Plan
Participants of the Horner Electric, Inc. Employees' Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Horner Electric, Inc. Employees' Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Horner Electric, Inc. 1. DESCRIPTION OF THE PLAN

The following description of Horner Electric, Inc. Employees' Retirement Plan (the Plan) provides only general information. Reference should be made to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, effective January 31, 1968, and most recently amended and restated effective July 1, 2024, is a defined contribution plan covering the employees of Horner Industrial Services, Inc. and Horner APG, LLC (together referred to as "the Company") who are at least 21 years old and have completed three months of employment. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may make voluntary pre-tax contributions subject to the IRS limits of annual compensation as defined by the Plan. Effective January 1, 2024, the plan was amended to allow participants to make voluntary Roth contributions. Eligible participants are automatically enrolled in the Plan, at a pre-tax contribution rate of 2% of their compensation, unless they elect not to participate in the Plan or select an alternative deferral amount. Effective October 1, 2023, the auto enrollment contribution rate increased from 2% to 6% of compensation.

The Company may make contributions in two manners. First, a discretionary matching contribution equal to a percentage of compensation of contributing participants is possible. For the year ended December 31, 2024, the Company elected to match 100% of participant contributions up to 6% of eligible compensation. Second, the Company may make a special discretionary contribution allocated to all eligible participants based on his or her compensation. Both contributions are determined by the Board of Directors on an annual basis. The Board elected not to make a special discretionary contribution for the year ended December 31, 2024.

Participants' Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, the Company's special discretionary contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contribution portion of their account plus earnings thereon occurs on a graduated scale as shown on the following page. A participant is 100% vested after five years of credited service.

Withdrawals

The Plan permits hardship withdrawals to participants subject to certain restrictions. Participants may also take in-service withdrawals once they reach the age of 59 ½.

Contributions Receivable

Participant and employer contributions receivable consist of amounts remitted to, but not yet received by the plan, prior to year-end.

Notes Receivable from Participants

Participants may borrow from their accounts. Loans are made on a uniform and non-discriminatory basis. A participant may borrow up to 50% of his or her vested account up to a maximum of \$50,000. The plan administrator will determine a reasonable rate of interest by reviewing the interest rates charged for similar types of loans by other lenders. Payments of principal and interest are made through payroll deductions. Loans are secured by the balance in the participant's account.

Payment of Benefits

Distributions and withdrawals are payable upon normal retirement at age 65, termination, disability or death. The participant, or his or her beneficiary, elects the manner he or she will receive vested benefits as outlined in the Plan document.

Forfeited Accounts

Forfeitures of employer matching contributions may be used to pay administrative expenses or to reduce future employer contributions. Forfeitures may also be reallocated to participants as though they are additional employer contributions. The forfeited nonvested account amount applied to reduce employer contributions was \$44,903 for the year ended December 31, 2024. At December 31, 2024, no forfeitures remained to be applied in future years.

1. DESCRIPTION OF THE PLAN, CONTINUED

Plan Administration

The Company is the administrator of the Plan, and as such, carries out the duties imposed by ERISA. The fiduciary committee of the Company meets regularly to review investment options and performance. The administrator has delegated certain responsibilities for the operation and administration of the Plan. Some of the administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The total administrative expenses incurred by the Plan were \$3,206 for the year ended December 31, 2024.

Subsequent Events

Subsequent events have been evaluated by plan management through July 24, 2025, which is the date the financial statements were available to be issued.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

These statements have been prepared on the accrual basis of accounting. The preparation of statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Shares of registered investment companies are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held at year end. The Plan's group annuity contract is stated at contract value, which is determined by principal invested plus interest earned on fixed income investments in which the contract has invested. Interest rates are established and declared for new contributions that will be received in a calendar quarter. The rate is based on expected returns on new investments made during the quarter.

Purchases and sales of securities are recorded on a settlement-date basis. Dividends are recorded on the ex-dividend date. Changes in the difference between cost and quoted market value of investments are reflected as net appreciation and/or depreciation in value of investments in the statement of changes in net assets available for benefits.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to April 15, 2025 and 2024, respectively.

Payments of Benefits

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. GROUP ANNUITY CONTRACT WITH AMERICAN UNITED LIFE INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with American United Life Insurance Company ("AUL") with a balance of \$2,918,432 and \$2,893,000 at December 31, 2024 and 2023, respectively. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a yearly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

4. GROUP ANNUITY CONTRACT WITH AMERICAN UNITED LIFE INSURANCE COMPANY, CONTINUED

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

5. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The investments at fair value and contract value held at December 31, 2024 and 2023, and the net appreciation in fair value of investments and interest income for the year ended December 31, 2024, as reported and disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American United Life Insurance Company, the custodian of the Plan.

6. INCOME TAX STATUS

The Internal Revenue Service has determined in its opinion letter dated August 19, 2020, that the prototype plan adopted by the Plan is qualified and the trust established under the Plan is exempt under the appropriate sections of the Internal Revenue Code (the IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as most recently amended and restated, is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan has filed its tax returns for periods through December 31, 2023. These returns are generally open to examination by the relevant taxing authorities for a period of three years from the later of the date the return was filed or its due date. Accordingly, the tax filings for the years ended December 31, 2023, 2022, and 2021, are open to examination at December 31, 2024.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, all assets would be distributed out of the Plan in accordance with the Plan document and all participants would become fully vested.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are held and managed by American United Life Insurance Company, and therefore these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers, which also qualify as party-in-interest transactions.
