## INDEPENDENT AUDITOR'S REPORT

To the Bank Forward Audit Committee

### Opinion on the 2024 Financial Statements

We have audited the financial statements of Bank Forward Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Bank Forward Employee Stock Ownership Plan as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion on the 2024 Financial Statements

**NOTE 1 PLAN DESCRIPTION**

**General**

The following description of the Bank Forward Employee Stock Ownership Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Security State Bank of North Dakota established an employee stock ownership plan effective January 1, 2000. The plan sponsor was renamed Bank Forward as of January 1, 2007 and the Plan became known as the Bank Forward Employee Stock Ownership Plan ("the Plan") thereafter. The Plan operates as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986 as amended and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by an ESOP Committee appointed by the plan sponsor's Board of Directors. The trustees are employees of and appointed by the Plan sponsor. Principal Trust Company has been engaged to serve as the Plan's trustee.

The Plan originally purchased Security State Bank Holding Company ("the Holding Company") common stock using the proceeds of Holding Company borrowings (see Note 7) and holds the common stock in a trust established under the Plan. As the Plan makes debt payments, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of common stock. The lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the years then ended, present separately the assets and liabilities and changes therein pertaining to:

- a. the accounts of eligible employees with vested rights in allocated common stock (allocated), and
- b. common stock not yet allocated to eligible employees (unallocated)

**Eligibility**

Employees of the plan sponsor are generally eligible to participate in the Plan after they have attained age 21 and have been credited with at least 1,000 hours of service at the end of their first twelve months of consecutive employment with the company. Participants who do not have at least 1,000 hours of service during the Plan year or are not employed on the last working day of a Plan year are not eligible for an allocation of plan sponsor contributions for such year.

**Contributions**

Employer contributions are determined annually by the Board of Directors of the Plan Sponsor subject to limitations imposed under the Internal Revenue Code. The Plan Sponsor is obligated to make contributions in cash to the Plan, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regular scheduled payments of principal and interest due on its term loans. Employee contributions are not permitted.

**Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of the Plan with an allocation of shares of the Holding Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings and administrative expenses paid by the Plan are allocated to each participant's account based on the ratio of the participant's account balance.

**Vesting**

If a participant's employment with the company ends for any reason other than retirement, permanent disability or death, the participant will vest in the balance in their account based on total years of service with the company. Participants vest at a rate of 20% per year of service after they have at least two years of credited service and are fully vested after six years of credited service.

**Payment of Benefits**

Distributions on account of death, disability, retirement or for other separations from service may be made as soon as administratively feasible in the Plan year following the event. If the value of a terminated participant's vested benefit does not exceed \$7,000, then the participants' vested benefit shall be paid in a lump sum payment as soon as administratively feasible. Benefit payments may be made in cash as direct rollovers, lump sum payments or installments over a period of time. The determination and distribution of benefits shall be made as of the valuation date on or immediately preceding the distribution date.

**Voting Rights**

Participants in the Plan will be entitled to vote the Holding Company securities allocated to their accounts with respect to merger or consolidation, recapitalization, reclassification, liquidation, dissolution or sale of substantially all of the assets of the Employer. Participants are notified by the Trustee or the Employer when any such issues arise that will require shareholder approval. For other corporate matters, the Employer will direct the Trustee as to how to vote all Employer Securities in the Plan.

**Administrative Expenses**

The Plan permits the payment of Plan expenses to be made from the Plan's assets. Administrative expenses paid using the Plan's assets will generally be allocated among the accounts of all participants in the Plan. Administrative expenses paid by the Plan sponsor are not reflected in the financial statements.

**Diversification**

Diversification is available to participants close to retirement so they have the opportunity to move part of the value of their investment in Holding Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of Plan participation may elect to diversify a portion of their account by notifying the plan administrator of their desire.

Diversification is offered to eligible participants over a six year period. In each of the first five years, eligible participants may diversify up to 25% of the number of shares of Holding Company stock allocated to their accounts, less any shares previously diversified. In the sixth year, the allowable diversification of Holding Company stock shares increases to a maximum of 50%. After the sixth year, eligible participants may continue to diversify a maximum of 10% of their remaining number of shares of Holding Company stock. Participants who elect to diversify are allowed to convert a portion of their Holding Company stock into cash in order to invest in other securities within the Plan.

**Forfeitures**

Forfeitures of terminated participants are allocated first to restore any forfeitures of reemployed participants and then to participants' accounts in the same manner of the employer contribution for the plan year. Forfeitures may also be used to pay reasonable Plan expenses. For the years ended December 31, 2024 and 2023, \$11,470 and \$33,029, respectively, of forfeitures were allocated as an additional employer contribution to eligible participants. The balance of non-vested forfeitures as of December 31, 2024 and 2023 was \$-0-.

**Dividends**

At the sole discretion of the Holding Company, to the extent cash dividends on Company Stock are not used by the Plan for debt service, these funds shall be invested in the Participant's other investments account under provisions of the Plan Document.

**Put Option**

Under federal income tax regulations, the Holding Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Holding Company buy any shares of its stock distributed to participants for which there is not market. The put price is representative of the fair market value of the stock. The Holding Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ultimate ability to obtain cash.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Allocations**

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees which rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. The fair value of the Holding Company common stock is based on an annual independent third party appraisal. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and are reflected in the statements of changes in net assets available for benefits.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Income Taxes**

The Holding Company's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:  
 Quoted prices for similar assets or liabilities in active markets;  
 Quoted prices for identical or similar assets or liabilities in inactive markets;  
 Inputs other than quoted prices that are observable for the asset or liability;  
 Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Interest-Bearing Cash: Valued at cost plus interest earned.

Common Stock: The fair value of Security State Bank Holding Company common stock held by the Plan is valued at estimated fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and earnings valuation techniques.

**NOTE 5 PLAN TERMINATION**

The Holding Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Board of Directors directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

**NOTE 6 INCOME TAX STATUS**

The Plan has received a determination letter from the IRS dated March 3, 2017 stating that the Plan is qualified under the IRC and, therefore the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 LOAN PAYABLE**

On May 1, 2015, the Plan entered into a \$1,000,000 loan agreement with the Holding Company and used the proceeds to purchase additional Holding Company common stock. Multiple principal advances on the loan are allowed up to the maximum \$1,000,000 for the first year. Principal advances on the loan totaled \$1,000,000. On September 30, 2015, the Plan entered into a \$1,000,000 loan agreement with the Holding Company and used the proceeds to purchase additional Holding Company common stock. Multiple principal advances on the loan are allowed up to the maximum \$1,000,000 for the first year. Principal advances on the loan totaled \$960,329. As of December 31, 2024, the loan has been paid off.

On August 4, 2021, the Plan entered into a \$2,660,000 loan agreement with the Holding Company and used the proceeds to purchase additional Holding Company common stock. The original loan was structured to be amortized over five years with a final payment date of April 15, 2026. On July 24, 2024, the loan was modified. The terms of the note were updated to bear a zero percent interest rate and change the maturity date to April 15, 2033. Principal payments are due annually. The Holding Company is obligated to make contributions to the Plan that, when aggregated with the Plan's dividends, equal the amount necessary to enable the Plan to make its regularly scheduled payment of principal and interest due on the note.

On September 19, 2024, the Plan entered into a \$1,657,500 loan agreement with the Holding Company and used the proceeds to purchase additional Holding Company common stock. The loan is structured to be amortized over 12 years with a final payment date of September 19, 2036. Principal payments are due annually. The Holding Company is obligated to make contributions to the Plan that, when aggregated with the Plan's dividends, equal the amount necessary to enable the Plan to make its regularly scheduled payment of principal and interest due on the note.

On October 10, 2024, the Plan entered into a \$292,500 loan agreement with the Holding Company and used the proceeds to purchase additional Holding Company common stock. The loan is structured to be amortized over 12 years with a final payment date of September 19, 2036. Principal payments are due annually. The Holding Company is obligated to make contributions to the Plan that, when aggregated with the Plan's dividends, equal the amount necessary to enable the Plan to make its regularly scheduled payment of principal and interest due on the note.

Collateral for each of the loans consisted of all unallocated Holding Company common stock and any income generated from the loans collateral. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the current year payment divided by the total of this year's payments, plus all future year's principal and interest payments. This resulted in 2,070.1589 and 1,689.3174 shares being released and allocated for the Plan years ended December 31, 2024 and 2023, respectively.

**NOTE 8 COMPANY DIVIDENDS**

The Company paid dividends to the ESOP of \$21.12 per share or \$2,103,952 and \$20.91 per share or \$1,979,383 during the years ended December 31, 2024 and 2023, respectively. In 2024, \$212,755 was applied to debt service and the remaining was allocated participants. In 2023, \$340,000 was applied to debt service and the remaining was allocated participants.

**NOTE 9 RELATED PARTIES**

The Plan invests in Holding Company common stock and has indebtedness guaranteed by the Company. These are related party and party-in-interest transactions. As described in Note 1, certain plan expenses are paid by the Company. The Plan's recordkeeper, Principal Life Insurance Company, is also a party-in-interest under ERISA. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

**NOTE 10 RISKS AND UNCERTAINTIES**

The Plan investments consist primarily of the Holding Company's common stock, which is exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with the investment in the common stock and to the uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the values of the common stock will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 11 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through July 29, 2025, which is the date these financial statements were available to be issued.
