Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sparrow & Kennedy Tractor Co., Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Sparrow & Kennedy Tractor Co., Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for more complete descriptions of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Sparrow & Kennedy Tractor Co., Inc. (the "Company" or "Plan Sponsor"). The Plan provides eligible employees a means of regular and systematic savings with several investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees are eligible to participate in the Plan upon reaching the age of twenty-one and having completed at least six months and 780 hours of service within the six month time period following their employment commencement date. Participants may enter the Plan either on the first day of the Plan year or the first day of the seventh month of the Plan year following the date they satisfy the eligibility requirements. Employees are also eligible to receive employer contributions after satisfying the eligibility requirements.

Contributions

Each year, participants may contribute up to 100% but not less than 1% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Eligible employees may elect to defer eligible compensation on a pre-tax, after-tax (Roth) basis, or combination of both up to a certain limit. Contributions are subject to certain Internal Revenue Service (IRS) limitations, and for the year ended December 31, 2024, the maximum contribution allowed by an employee under 50 years of age is \$23,000, for an employee at or over 50 years of age, the maximum contribution allowed is \$30,500.

The Plan is an "eligible automatic contribution arrangement 401(k) plan" or "EACA" and a "qualified automatic contribution arrangement 401(k) plan" or "QACA." Under Plan provisions, eligible employees are automatically enrolled at a fixed percentage of 6%. In addition, the Plan is a QACA safe harbor plan where the employer makes a safe harbor matching contribution equal to 100% of an eligible employee's salary deferrals that do not exceed 1% of compensation plus 50% of salary deferrals between 1% and 6% of compensation. Safe harbor contributions are calculated each payroll period.

Additionally, employees are eligible for Company discretionary contributions if the employee is employed on the last day of the Plan Year and has completed at least 1,000 hours of service during the Plan year. The Company did not make an additional discretionary nonelective contribution during the Plan years 2024 and 2023.

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers investments in pooled separate accounts and guaranteed investment contracts for participants.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions, and related Company contributions as well as the participant’s share of the Plan’s income. Income is allocated to participants’ accounts through the change in value. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions and employer matching contributions plus actual earnings thereon. Vesting in any nonelective and qualified safe harbor employer contributions is based on years of service. A participant is 100 percent vested after three years of credited service for nonelective contributions as outlined below:

Notes Receivable from Participants

The Plan does not permit loans to participants.

Payment of Benefits

Payments equal to the vested value of the funds allocated to a participant’s account will be paid upon the participant’s termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant with a vested account balance less than \$1,000 will receive a lump sum distribution equal to the value of the participant's vested interest in his or her account. A participant with a vested account balance greater than \$1,000 but less than \$5,000 may elect a lump-sum payment or the account will be rolled into an individual retirement account in the participant's name.

Payments of Benefits (continued)

The Plan allows participants to acquire a hardship withdrawal to satisfy an immediate and heavy financial need. Participants may withdraw a minimum of \$1,000 up to the value of the participant's contributions in his or her account and attributable earnings.

In addition, the plan allows for other in-service withdrawals for participants with a disability or upon attainment of age 59 1/2 of all vested account balances. Active military members may also take a qualified reservist distribution. These in-service distributions are not subject to the \$1,000 minimum.

Benefits are recorded when paid.

Forfeitures

Forfeitures may be used to pay plan expenses, to reduce safe harbor contributions or allocated as discretionary additional matching contributions. Forfeitures used to reduce employer matching contributions during the year ended December 31, 2024 and 2023 were \$11,034 and \$12,391. There were no forfeited nonvested accounts outstanding for the year ended December 31, 2024 and 2023.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with U.S. GAAP.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions which affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (not including investments in fully-benefit insurance contracts, more fully described in Note 3). Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by the employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

NOTE 3 – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Sentry Life Insurance Company. Sentry Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The average yield and crediting interest rate was approximately 2.8% for the year ended December 31, 2024. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Sentry Life Insurance Company represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 3 – GUARANTEED INVESTMENT CONTRACT (CONTINUED)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 4 – FAIR VALUE MEASUREMENT

The Plan utilizes Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements. ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have highest priority, Level 2 inputs consist of quoted prices for similar assets or identical assets that are not active, and Level 3 inputs are unobservable and have lowest priority. The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices which are observable for the asset or liability; and d) inputs derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input which is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts: Investments are valued at net asset value, and held in pooled separate accounts through subaccounts of an insurance company. The underlying securities in pooled separate accounts are listed on national securities and valued on the basis of year-end closing prices.

NOTE 5 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Sentry Life Insurance Company (the custodian of the Plan). This information has not been audited by the Plan’s independent auditors.

NOTE 6 – TAX STATUS

The Plan Sponsor adopted a prototype non-standardized profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the opinion letter. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan’s qualified status.

NOTE 7 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Sentry Life Insurance Company, the custodian for the Plan, and therefore, transactions Sentry Life Insurance Company qualify as exempt party-in-interest transactions.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in nonelective and qualified safe harbor employer contributions.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 – SUBSEQUENT EVENTS

The Plan assessed events occurring subsequent to December 31, 2024 through July 18, 2025 for potential recognition and disclosure in the financial statements. No events have occurred that would require adjustment to or disclosure in the financial statements which were available to be issued on July 18, 2025.
