Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Eye Specialists of Mid-Florida, P.A. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Eye Specialists of Mid-Florida, P.A. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Note A - Description of Plan

The following description of the Eye Specialists of Mid-Florida, P.A. 401(k) Plan (the Plan) provides only general information. Plan participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General. The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of Eye Specialists of Mid-Florida, P.A. (the Company) who have completed six months of service, as defined. The primary purpose of the Plan is to provide employees of the Company with financial benefits upon retirement. The Plan is subject to provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*.

Contributions. Each year participants may contribute up to 100% of eligible compensation, as defined by the Plan, up to the maximum limit set by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to 100% of their pretax annual compensation. Participants may also contribute amounts representing distributions from other qualified plans (i.e. rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a target date fund based on their estimated retirement date. The Plan has adopted a safe harbor provision whereby the Company must make matching contributions of 100% of the first 3% and 50% of the next 2% of compensation that a participant contributes to the Plan. The Plan also permits the Company to make profit sharing contributions for each eligible participant at the discretion of the board of directors. For 2024 and 2023, the Company's profit sharing contributions were \$-0- and \$-0-, respectively. Contributions are subject to certain IRS limitations.

Participant Accounts. Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contributions, as well as allocations of the Company's profit sharing contribution (if any) and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions and the Company's safe harbor matching contributions, plus the earnings thereon. Vesting in the Company's discretionary contribution is based on years of continuous service. A participant does not begin to vest until year two (20%) and increases ratably until fully vested in year six. Upon attaining normal retirement age, death or permanent disability while a participant is employed, their entire account balance becomes fully vested.

Payment of Benefits. On termination of service due to death, disability, retirement, or for other reasons a participant's account is distributed as a lump sum distribution if the vested balance does not exceed \$5,000. If a participant's vested balance exceeds \$5,000 a participant may elect to receive either a lump sum distribution or installments over a fixed period of time, not more than the participant's assumed life expectancy.

Forfeitures. At December 31, 2024 and 2023, forfeited non-vested accounts total \$19,298 and \$8,051, respectively. These accounts will be used to reduce future employer discretionary and safe harbor matching contributions and/or pay administrative expenses. In 2024 and 2023, total forfeitures plus investment returns were \$24,397 and \$38,020, employer safe harbor matching contributions were reduced by \$-0- and \$96,883, and plan expenses were reduced by \$13,150 and \$13,165, respectively.

Note A - Description of Plan - Continued

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note repayment terms range up to five years from the date of the note unless such note is for the purchase of a participant's primary residence, in which the repayment period may exceed five years. Notes are secured by the vested balance in the participant's account and bear interest at a rate established by the plan administrator in a nondiscriminatory matter. Principal and interest are paid ratably through payroll deductions. Notes outstanding at December 31, 2024, bear interest at rates ranging from 8.50% to 9.50%.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for disclosure of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as deemed distributions based upon terms of the plan document.

Administrative and Investment Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Note C - Trust Agreement

Empower Trust Company is the trustee for the Plan, manages Plan assets, executes investment transactions for the Plan, and makes distributions to participants as directed by the plan administrator. Definiti, LLC serves as the plan administrator.

Note D - Certified Investments by Empower Trust Company

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of and for the years ended December 31, 2024 and 2023, included in the Plan's financial statements and supplementary schedule, that was prepared by or derived from information prepared by Empower Trust Company, the Trustee, and furnished to the Company. The Company has obtained certifications from the Trustee as of and for the years ended December 31, 2024 and 2023, that such information is complete and accurate.

- Level 1 The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.
- Level 2 The fair value of the collective trust fund is based on quoted net asset values of the shares in markets that are not actively traded.

Note F - Party-in-Interest Transactions

Certain Plan investments are managed by Empower Annuity Insurance Company (Empower). Empower is an affiliate of the trustee, therefore, these transactions qualify as party-in-interest transactions.

Empower provides certain administrative services to the Plan pursuant to a Recordkeeping Services Agreement (RSA) between the Company and Empower. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

If the revenue received by Empower from such mutual fund service providers, exceeds the amount owed under the RSA, Empower remits the excess to the Plan's trust on a monthly basis. Such amounts may be applied to pay Plan administrative expenses or be allocated to the accounts of participants. During 2024 and 2023, there was excess revenues of \$33,328 and \$30,869 credited to the plan and administrative expenses of the plan were reduced by \$33,328 and \$30,869, respectively.

Empower is the Plan's recordkeeper and qualifies as a party-in-interest. Fees paid to Empower in 2024 and 2023 from the Plan were \$66,760 and \$64,620, respectively.

Definiti, LLC is the Plan's administrator and qualifies as a party-in-interest. Fees paid to the plan administrator in 2024 and 2023 from the Plan were \$10,464 and \$11,364, respectively.

Advus Financial Partners, LLC is the Plan's investment advisor and qualifies as a party-in-interest. Fees paid to the Plan's investment advisor in 2024 and 2023 were \$33,328 and \$30,869, respectively.

Empower Advisory Group is the Plan's investment manager and qualifies as a party-in-interest. Fees paid to the Plan's investment manager in 2024 and 2023 were \$2,774 and \$3,351, respectively.

The Plan's audit firm qualifies as a party-in-interest. Fees paid to the Plan's audit firm in 2024 and 2023 were \$13,150 and \$13,165, respectively

Note G - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note H - Right to Terminate Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of *ERISA*. In the event of Plan termination, participants would become 100% vested in their accounts.

Note I - Income Tax Status

The Plan adopted the Volume Submitter prototype non-standardized 401(k) profit sharing plan which received a favorable opinion letter dated March 31, 2014, from the Internal Revenue Service (IRS). The opinion letter stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress for any tax periods.
