Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Bibliotheca, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Bibliotheca, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520-103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Bibliotheca, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Bibliotheca, LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1 - Description of plan:

The following description of the Bibliotheca, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The plan sponsor is Bibliotheca, LLC. The Plan is a defined contribution plan covering substantially all employees of Bibliotheca, LLC (the Company, Plan Sponsor, or Plan Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility of participants

Upon meeting the entry date requirements, eligible employees, as defined, may participate in the Plan immediately upon date of hire with no minimum age requirement. Entry date is on the first day of the month coinciding with or next following the date the eligibility requirements have been met. All eligible employees, as defined, are automatically enrolled in the Plan upon becoming eligible, with the default pre-tax deferral percentage of 6% of eligible compensation, unless they elect otherwise. The automatic contribution rate will increase by 1% annually on the first day of the plan year up to a maximum of 10% unless the employee elects otherwise.

Contributions

Participants may elect to contribute up to 100% of compensation, up to current Internal Revenue Service (IRS) limitations, through payroll deductions. Participants who have attained age 50 before the end of the Plan year are permitted to make catch-up contributions. Both pre-tax and Roth contributions are allowed in the Plan.

The Company provides a safe-harbor matching contribution equal to 100% of employee contributions up to 3% of compensation and 50% of contributions between 3% and 5% of compensation, as defined. The Company also has the option to provide a discretionary non-elective contribution. There were no discretionary non-elective contributions for the 2024 Plan year.

Note 1 - Description of plan - continued:

Participant accounts

Each participant's account is credited with the participant's contributions, the Company's safe-harbor matching contributions, the Company's discretionary non-elective contribution, if any, Plan expenses, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Forfeited accounts

Forfeited non-vested amounts may be used to either pay Plan administrative expenses or to reduce employer matching contributions. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts. During 2024, there were \$921 of forfeitures used to pay administrative expenses of the Plan or to reduce employer contributions to the Plan.

Vesting

Participants are immediately vested in their voluntary deferral contributions plus actual earnings thereon. Participants are also immediately vested in the employer safe-harbor matching contributions plus actual earnings thereon. Participants vest in the Company's discretionary employer non-elective contributions after three years of service, as defined.

Participants are immediately vested upon termination of the Plan or upon death or disability while an employee of the Company.

Payment of benefits

A participant is entitled to a distribution of the vested value of his or her account upon termination of service, disability, death, attainment of the normal retirement age of 65, or retirement. Participants may elect to take distributions as a lump sum payment. Additionally, in-service withdrawals of a participant's deferrals and vested matching contributions are permitted after attaining age 59 1/2. In-service withdrawals of a participant's deferrals are allowed in cases of proven financial hardship. Participants are required to provide hardship documentation for approval prior to receiving a hardship distribution.

Note 1 - Description of plan - continued:

Notes receivable from participants

Participants may borrow a minimum of \$600 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms are for a maximum of five years, except for notes for the purchase of a primary residence which may be up to 10 years. Participants may have only one note outstanding at a time. Notes are secured by the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. Participants may prepay their note at any time.

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Administrative expenses

Administrative expenses of the Plan are paid by either the Company or the Plan, as determined by the Plan Sponsor. The Company absorbs a portion of the administrative expenses of the Plan. Fees related to recordkeeping and investment management are charged to participants as defined in the individual agreements. Fees charged for processing notes receivable from participants, as well as other account transaction fees, are charged directly to the account of the applicable participant.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Note 2 - Summary of significant accounting policies - continued:

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investment valuation and income recognition - continued

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- Shares of registered investment company funds (mutual funds) are valued at the net asset value (NAV) of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges. The registered investment company funds held by the Plan are deemed to be actively traded.
- Units of participation in the common/collective trust fund are valued at net asset value (NAV) provided by the fund's trust manager. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Certain underlying investments are valued based on quoted market prices while others are valued by discounting the related cash flows based on current yields of similar instruments with comparable durations, considering the credit-worthiness of the issuer. Investment fair value may be modified by the manager if unusual market conditions exist based upon the manager's valuation policies.
- Units of participation in pooled separate account are valued at the NAV provided by the Fund's trust manager. The NAV is based on the quoted market prices of the underlying investments held in the pooled separate account at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

The Plan has evaluated subsequent events through July 31, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

Note 3 - Investments and information certified by the custodian:

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company.

Note 4 - Party-in-interest transactions:

The custodian and their affiliates perform services for the Plan, sell products to the Plan, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. The Plan also has a third-party investment advisor for which fees are charged to the Plan. The Plan pays a portion of the administrative expenses. Such transactions, while considered party-in-interest transactions under ERISA, are specifically exempt from the prohibited transaction rules.

Note 5 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants' accounts will become fully vested.

Note 6 - Tax status:

The underlying prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for Plan years prior to 2021.
