**NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024, September 30, 2024 and September 30, 2023**

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Measurement Solutions Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the summary Plan description or Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan for which Rosemount, Inc (the Employer or the Company) is a subsidiary of Emerson Electric Company and is the current sponsor of the Plan. The Plan is intended to qualify as a profit-sharing plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Management Review Committee of Emerson (MRC) is the Plan fiduciary and the committee charged with governance. Vanguard Trust Company (the Trustee) is the directed trustee of the Plan and Vanguard Group, Inc. serves as the record keeper to maintain the individual accounts of each Plan's participants (together "Vanguard").

***Plan Merger***

Effective December 31, 2024, the Plan merged into the Emerson Electric Co. Employee Savings Investment Plan ("ESIP") and all assets were transferred to ESIP. From that day onward, all benefits payable under this Plan will be governed by the terms of the ESIP. Accordingly, the Plan has no assets as of December 31, 2024 and the statement of changes in net assets available for benefits is a short period covering October 1, 2024 through December 31, 2024 as the Plan has a normal year-end of September 30.

Effective January 1, 2025, ESIP was renamed Emerson Savings Plan. Emerson Savings Plan also utilizes Vanguard as its trustee and recordkeeper.

***Participation***

Upon hire, employees are eligible to participate in the Plan. To become an active participant, an employee must enter into an earnings reduction agreement with the Employer whereby the employee's base salary or wage is reduced by the required minimum 2% contribution. If an employee does not enroll in the Plan when first eligible to do so, the employee may enroll at a later date subsequent to completing earnings reduction agreement. New employees are automatically enrolled in the Plan after 30 days with an initial contribution rate of 3% of pre-tax eligible compensation, unless any participant makes an election to affirmatively opt out in accordance with procedures established by the Company.

Eligible participants may receive Employer contributions equal to a percentage of each participant's eligible compensation after the completion of 6 months of service provided the employee completed 1,000 hours or more of service during a Plan year, meets the 2% minimum contribution requirement and are active employees on the last working day of the Plan year.

***Contributions***

The Plan document provides for the following contributions, which are all invested directly into the funds elected by the participant:

*Employee contribution* - A participant may contribute, on a pre-tax basis and/or as a Roth elective deferral, any whole percentage amount, between 2% and 40% of eligible compensation for a payroll period. Additionally, an eligible participant who has attained age 50 before the end of the Plan year shall be eligible to make catch-up contributions. Participant contributions are subject to Internal

Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts (rollovers).

*Employer annual contribution* - The Employer shall contribute to the Plan an amount determined by the combination of a worldwide sales growth and earnings before interest and tax margin matrix and a gross margin matrix, reduced by the amount contributed by the Employer to Measurement Solutions Profit Sharing Plan (the Safe Harbor Contribution) for such Plan year. This profit-sharing contribution shall be made annually by the Employer. As this Employer contribution is made annually, as of December 31, 2024, there is no formal commitment to make a partial profit-sharing contribution to the Plan.

The Employer is required to contribute an Employer Safe Harbor Contribution annually to the Plan in an amount equal to 3% of the participant's eligible compensation. The Employer Safe Harbor Contribution is initially allocated to the Emerson common stock fund; however, the participant may direct the investment of all or a portion of his or her Employer Safe Harbor Contribution in other investment electives.

The Employer may contribute to the Plan a discretionary per capita contribution payable to accounts of eligible participants who meet the requirements as established by the Employer. During 2024, the Employer did not make a discretionary contribution.

***Participant Accounts***

Participants may direct the investment of their account balances into various investment options offered by the Plan. Each participant's account is credited with his or her own contributions, Employer contributions and earnings thereon. Earnings are allocated pro rata based on the value of the participant's account in an investment fund related to the total assets in the fund as of the earnings determination date. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

***Notes Receivable from Participants***

The Plan allows participants to request loans from their participant accounts. Loans are considered assets of the Plan and are limited to the lesser of (i) 50% of the vested portion of the participant's account, excluding the after-tax account, or (ii) \$50,000 minus the highest outstanding balance of loans from the Plan (and all other plans of the Employer and all Affiliates) to such Participant during the one year period ending on the day before the new loan is made, or (iii) \$25,000. The minimum loan amount is \$500. The loans are secured by the balance in the participant's account. Loan repayments are made by the participants through monthly payroll deductions, not to exceed 60 months, and include principal payments plus interest at the prime interest rate plus 1%. A participant may transfer more than one loan from a plan maintained by an affiliate to this Plan; however, no new loan shall be allowed until all loans transferred into the plan have been satisfied.

***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon and the 3% Employer Safe Harbor Contribution. Vesting in the Employer's annual profit-sharing contribution and discretionary Employer per capita contribution is based on years of service. All Plan years of service in which the participant has 1,000 hours or more of service count toward vesting.

A participant will be 100% vested upon death, total disability or attainment of age 55.

***Payment of Benefits***

A participant whose termination of employment occurs for any reason shall be entitled to benefits equal to 100% of the employee's elective contribution, voluntary contribution, 3% guaranteed contribution and rollover contribution account, plus the vested percentage of the Employer's annual contribution account. Distribution of a participant's benefits can be made to the participant or beneficiaries in a lump sum or installments.

Under certain circumstances, accelerated distributions may be made to participants from their voluntary accounts or from the Employer's annual contribution account.

Partial distributions to retired or terminated participants (up to one per month) are permitted with a minimum amount of \$100.

***Forfeitures***

If a participant has a break in service and is not again a participant in the Plan before the end of the Plan year in which the break occurs, the non-vested portion of the participant's account arising from annual Employer contributions is used first to restore any forfeited accounts as required by the Plan, to correct errors, omissions and exclusions. Any remaining portion is reallocated to the accounts of other participants as if it were an additional Employer annual profit-sharing contribution. During December 31, 2024, and September 30, 2024, \$525,000 and \$448,476 was allocated to Plan participants. As of December 31, 2024, September 30, 2024, and September 30, 2023, forfeitures were \$0, \$515,386 and \$409,115, respectively.

***Administration and Expenses***

The Plan is administered by the MRC, which is appointed by authority of the Company's board of directors. The MRC, with the approval of the board of directors, has appointed a trustee to manage and maintain the Plan's assets in accordance with a trust agreement. The reasonable expenses of administering the Plan shall be payable out of the Plan except to the extent that the Employer, in its discretion, directly pays the expenses.

***Investment Options***

On a daily basis, subject to six reallocations per quarter, participants may elect to reallocate how their current account balances are split among the investment funds. Participants may also elect how their future payroll contributions and Employer contributions are invested among the investment funds. The change in reallocation and investment elections can be done in 1% increments and will be effective as of the next business day.

The Plan, through its participation in the Master Trust, currently offers the Emerson common stock fund, which invests in Emerson's common stock and various mutual funds and commingled funds.

Elective contributions cannot be invested in Emerson Stock; however, the Employer annual profit sharing contribution can. The Company has a 10% limit on profit sharing contributions going into Emerson stock. Also, the 3% safe harbor is contributed to Emerson stock and can be moved out the next day if the participants wish to.

All funds may invest in cash equivalents as temporary investments and to maintain liquidity. Participants may change their investment options at any time. Participants may transfer (subject to certain restrictions on transfers into or out of the Emerson common stock fund by the Company's executive officers), in 1% increments, all or part of an existing account balance in a fund among the other investment funds to the extent permitted by the underlying investment contracts. Transfers may be made up to six times per quarter.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that affect the reported amounts in the financial statements. Actual results could differ from those estimates.

***Investment Valuation***

The Plan's investments, through its participation in the Master Trust, are stated at fair value. See Notes C and D regarding investments in the Master Trust.

***Income Recognition***

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

***Risks and Uncertainties***

The Master Trust may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, September 30, 2024 or September 30, 2023.

**NOTE C - MASTER TRUST**

All of the Plan's investments are held in a Master Trust, consisting of the Plan and other defined contribution plans of Emerson Electric Co. and subsidiaries. All Plan income or loss is derived from Master Trust investment appreciation or depreciation and investment income (interest and dividends). Net appreciation/depreciation includes the gains and losses on investments bought and sold as well as held during the year.

Each participating plan's interest in the assets of the Master Trust is based on participant-directed account balances. Additionally, loans to Plan participants are included in the Master Trust. Master Trust investment income and expenses are allocated to participating plans based on respective balances.

The Plan's investments in the Master Trust are stated at fair value. The fair values of mutual funds and Emerson common stock are based on quoted market prices in active markets. Money market funds are stated at cost, which approximates fair value. Investments measured using the net asset value (NAV) as a practical expedient are primarily collective funds and trusts where the underlying securities have observable prices available from active markets. There are no redemption restrictions or unfunded commitments related to these investments. The cost basis of investments held under the Plan is determined using the average cost method of accounting.

**NOTE D - FAIR VALUE MEASUREMENTS**

Under Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, a formal hierarchy and framework exists for measuring fair value and making disclosures about fair value measurements and the reliability of valuation inputs. Within the hierarchy, Level 1 instruments use observable market prices for the identical item in active markets and have the most reliable valuations. Level 2 instruments, of which there are none, are valued through broker/dealer quotation or through market-observable inputs for similar items in active markets, including forward and spot prices, interest rates and volatilities. Level 3 instruments, of which there are none, are valued using inputs not observable in an active market, such as entity-developed future cash flow estimates, and are considered the least reliable.

Following is a categorization of all Master Trust investments (see Note C) by level within the ASC 820 fair value hierarchy. Investments valued based on the NAV practical expedient are excluded from the fair value hierarchy. There were no asset transfers between levels during either year shown.

**NOTE E - TAX STATUS**

The IRS has determined and informed the Company by a letter dated April 7, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to amend and terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested.

As noted in Note A, the Plan merged to ESIP as of December 31, 2024.

**NOTE G - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

Additionally, Plan investment options include shares of Emerson common stock. Emerson is the parent company of the Plan sponsor. These transactions qualify as party-in-interest transactions and are allowable under ERISA regulations.

**NOTE I - SUBSEQUENT EVENTS**

Plan management evaluated events subsequent to December 31, 2024 and through July 10, 2025, the date on which the financial statements were available to be issued. Plan management is not aware of any subsequent events that would require recognition or disclosure in the accompanying financial statements.
