Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Knights of Columbus Tax Savings Investment Plan for U.S. Agents, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Knights of Columbus Tax Savings Investment Plan for U.S. Agents' ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. generally accepted accounting principles.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES to FINANCIAL STATEMENTS
December 31, 2024 and 2023

1 - Plan Description

General

The Knights of Columbus Tax Savings Investment Plan for U.S. Agents (the Plan) was adopted on January 17, 1998 (effective April 1, 1998) as an IRC Section 401(k) Plan. The Plan was most recently restated on May 5, 2022, effective March 11, 2022. The Plan is a compensation deferral plan, participation in which is available to U.S. agents who are age eighteen or older. It is subjected to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Contributions

Subject to certain limitations imposed by the Internal Revenue Code, plan participants with a compensation deferral agreement may contribute to the Plan on a pre-tax and/or after-tax (designated Roth contributions) basis up to 75% of their compensation. Participants who are age 50 or older at any time during the calendar year may make additional contributions, known as catch-up contributions, in accordance with the Plan provisions. All contributions are subject to overall dollar limits permitted by law.

Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers registered investment companies (mutual funds), pooled separate accounts, and a group annuity contract as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Plan's earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately and fully (100%) vested in the value of their accounts.

Payment of Benefits

Benefits are payable upon separation of service, retirement, disability, death or attainment of age 59 1/2. Terminated participants with account balances less than \$1,000 receive automatic lump sum payouts. Participants with balances greater than \$1,000 may elect to receive benefits in a lump sum or installments. Benefit payments shall be distributed or must begin to be distributed no later than April 1st of the calendar year following the later of: (1) the calendar year in which the participant reaches age 73 or (2) the calendar year in which the participant retires. Participants working beyond the age of 73 may elect to defer their required distribution until retirement.

Withdrawals

The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified within the Plan.

2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus guaranteed and additional interest, less funds used to pay benefits and administrative expenses. The Plan invests in a group annuity contract that is considered to be fully benefit-responsive.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Pension-401(k) Committee (See Note 3) determines the Plan's valuation policies utilizing information from Delaware Charter Guarantee and Trust Company (Principal Trust Company). Registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

Pooled separate accounts are reported at unit value based on values obtained from independent pricing sources at the measurement date; unit value is used as a practical expedient to estimate fair value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses represent fees for plan administrative services, distribution fees and participant investment redemption fees, when applicable. Participant investment redemption fees are incurred and paid by each participant that has an investment that charges redemption fees. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Management has evaluated subsequent events through May 14, 2025, the date on which the financial statements were available to be issued.

3 - Plan Administration

The Plan Trustee is Principal Trust Company acting under a Trust Agreement. The sole purpose of the Trust is to receive contributions from participants and, together with the income thereon, hold and administer the funds to provide retirement benefits pursuant to the participants' authorizations.

Fees for administration services are included in administrative expenses and charged directly to the participant's account. The Board of Directors of the Knights of Columbus (the Society) has appointed the Pension-401(k) Committee (Plan Administrator) with responsibility for the general administration of the Plan. The Plan is covered under a fidelity bond issued to the Society in the amount of \$30,000,000 against losses through fraud or dishonesty.

4 - Information Certified by Principal Trust Company

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (the trustee of the Plan).

5 - Group Annuity Contract with Insurance Company

The Plan invests in the Principal Fixed Income Guaranteed Option, a guaranteed general-account backed group annuity contract that has been issued by Principal Life Insurance Company (Principal Life). The Principal Fixed Income Guaranteed Option contract provides a guarantee of principal, a guaranteed minimum crediting rate of interest of 1.30% under contract, and the potential for additional interest if declared by Principal Life.

Participants who elect to direct their contributions to this account enter into individual contracts with Principal Life that provide various options. Provisions in the contract contain liquidity restrictions that can limit the participant's ability to make withdrawals from the contract.

The investment contracts were credited with an interest rate of 1.55% for the year ended December 31, 2024. The investment contracts were credited with interest rates ranging from 1.55% to 1.75% for the year ended December 31, 2023.

Although Plan management has no intentions of terminating the group annuity contract, certain contract types contain plan-level liquidity restrictions on the redemption of Principal Fixed Income Guaranteed Option accumulations, which could impact the value realized upon exiting the contract.

6 - Related Party Transactions

The Plan invests in pooled separate accounts managed by an affiliate of Principal Trust Company. Principal Trust Company acts as trustee for only those investments as defined by the Plan. Also, the Plan invests in shares of the Knights of Columbus family of mutual funds which are managed by Knights of Columbus Asset Advisors LLC, an affiliate of the Society (the Plan sponsor). Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

7 - Tax Status

The Plan obtained its latest determination letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, subject to the adoption of certain proposed amendments, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. As of December 31, 2024 and 2023, the plan administrator believes there are no uncertain tax positions taken by the Plan and therefore no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however, there are no audits for any tax periods in progress.

8 - Plan Termination

Although the Society expects to continue the Plan indefinitely, it retains the right to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all amounts credited to the accounts of affected participants are fully vested and nonforfeitable.

9 - Risks and Uncertainties

Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

10 - Fair Value Measurements

The Plan utilizes the market approach as the valuation technique used to measure fair value of its financial instruments. U.S. generally accepted accounting principles establishes a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value of financial instruments into three levels:

Level 1 - Quoted prices (unadjusted) in active markets for identical assets or liabilities where the organization has the ability to access at the measurement date;

Level 2 - Significant other observable inputs other than quoted prices included in Level 1, which are observable for the asset or liability, either directly or indirectly (i.e. quoted prices in inactive markets, broker or dealer quotations, or alternative pricing sources with reasonable levels of price transparency); If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs are used to the extent that observable inputs are unavailable due to little, if any, market activity for the asset or liability. Unobservable inputs are developed based on the best information available, which might include the organization's own data that reflects assumptions that market participants would use in pricing the asset or liability.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Investments that are measured at fair value that utilize a net asset value per share (or its equivalent) practical expedient are not categorized within the fair value hierarchy. Investments measured at net asset value per share (or its equivalent) are presented in the following fair value hierarchy table to permit a reconciliation of the fair value hierarchy to the amount presented in the Statement of Net Assets Available for Benefits.

Investments in the pooled separate accounts provide for daily liquidity and have a transfer restriction allowing for one transfer per 30 day period. This transfer restriction applies to all participant directed transfers out of the pooled separate accounts. Once the number of allowed transfers out is met, participants are not allowed to transfer back into this investment option until the holding period elapses. There were no unfunded investment commitments at December 31, 2024 and 2023.

The Plan's policy is to recognize transfers in and transfers out of each level as of the actual date of the event or change in circumstances that caused the transfer. There were no transfers between each level during 2024 or 2023.
