Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Accurate Perforating Company, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

1. Description of the Plan

General:

Accurate Perforating Company, Inc. 401(k) Plan (the Plan) is sponsored by Accurate Perforating Company, Inc. for its employees and the employees of Accurate Metal Fabricating Company and 36th and Kedzie Building Corporation, affiliates through common ownership of Accurate Perforating Company, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility:

Employees become eligible to participate in the Plan on the first day of each quarter subsequent to completing 90 days of service and reaching 18 years of age.

Contributions:

Deferral contributions by a participant cannot exceed the maximum contribution allowed by the Internal Revenue Service. The Plan also allows rollover contributions whereby participants may contribute amounts representing distributions from other qualified plans. The Plan allows an employer discretionary match contribution for employees not covered by a collective bargaining agreement. Employees must be employed as of the last day of the Plan year to be eligible for the employer match contributions. During the year ended December 31, 2024, the Company made no such discretionary employer match contribution.

For the employees of the Company covered by a collective bargaining agreement with UAW Local 6, the Company matches each dollar contributed by the participant up to a maximum of \$25 per week.

For the employees of the Company covered by a collective bargaining agreement with PWU Local 18, the Company matches each dollar contributed by the participant up to a maximum of \$20 per week.

For the employees of the Company covered by a collective bargaining agreement with Teamsters Local 781, the Company matches each dollar contributed by the participant up to a maximum of \$10 per week.

1. Description of the Plan (continued)

Contributions: (continued)

In addition, the Company may make annual discretionary profit-sharing contributions in an amount to be determined at Plan year-end by the Company. Employees must be employed as of the last day of the Plan year and complete one year of service to be eligible for profit-sharing contributions. During the year ended December 31, 2024, the Company made no such discretionary profit-sharing contribution.

Participant accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants self-direct their contributions and their share of the Company's contribution among the investment options.

Vesting:

Participants are immediately vested in their employee contributions plus actual earnings thereon. Discretionary profit-sharing contributions and matching contributions, together with corresponding earnings on each, shall vest 100% after one year of service for all non-collectively bargained participants. For those participants covered by a collective bargaining agreement with UAW Local 6, PWU Local 18 and Teamsters Local 781, employer matching contributions and corresponding earnings shall vest 100% after three years of service. Participants become fully vested upon reaching normal retirement age, death, or disability.

Payment of benefits:

A participant becomes entitled to benefits under the Plan upon retirement at age 65, permanent disability or resignation from the Company. In-service distributions are also allowed for participants who attain the age of 59 ½ and hardship distributions are permitted. A participant's account balance becomes fully vested upon death or disability. Upon resignation or retirement, participants are entitled to receive the vested portion of their account balance.

1. Description of the Plan (continued)

Loans to participants:

Loans are available to Plan participants at the prime interest rate plus 1% at the time the loan was initiated. The prime rate was 7.50% and 8.50% at December 31, 2024 and 2023, respectively. The minimum loan is \$1,000 and the maximum amount is equal to the lesser of \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period or 50% of their vested account balance. All loans must be repaid in ratable payments on at least a quarterly basis, over a five-year period unless the loan is for the purchase of a principal residence for which the term of the loan may be as long as thirty years. Loan defaults are treated as distributions. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

Forfeitures:

If a participant terminates employment and is less than 100% vested in the employer account, then the participant may forfeit the nonvested portion of the employer account. A forfeiture will occur in the Plan year that a distribution of the entire vested account is received or if a distribution is not received after five consecutive one-year breaks in service. Forfeitures may be used to pay Plan expenses or to reduce employer contributions to the Plan.

2. Summary of significant accounting policies

Basis of presentation:

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds and money market funds are valued at the market value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

2. Summary of significant accounting policies (continued)

Contributions:

Participants' contributions are recognized by the Plan when withheld from the participants' paychecks by the Company.

Payment of benefits:

Benefits are recorded when paid.

Notes receivable from participants:

As described in Note 1, the Plan allows participants to borrow against their vested account balances and the loans are secured by the participant's account balance. Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest.

Administrative expenses:

All administrative costs, charges and expenses are paid by the Plan to the extent not paid by the Company.

Expense offset arrangements:

Fees incurred by the Plan for investment management services and recordkeeping are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits as of December 31, 2024 and 2023 and the reported amounts of changes in net assets available for benefits during the year ended December 31, 2024. Accordingly, actual results could differ from those estimates.

Subsequent events:

The Plan Administrator has reviewed and evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.

3. Risks and uncertainties

The Plan invests in various investment securities. These investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Investments (information prepared and certified by Fidelity Management Trust Company (the Trustee))

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in these financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Trustee.

The Trustee certified the fair value of investments of \$12,736,418 and \$12,970,940 as of December 31, 2024 and 2023, respectively. Notes receivable from participants of \$170,191 and \$114,522 were also certified by the Trustee at December 31, 2024 and 2023, respectively. Interest rates on outstanding balances range from 4.25% to 9.50% at December 31, 2024 and 2023.

For the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought, sold and held during the year) appreciated in value in the amount of \$1,038,974, as certified by the Trustee. Dividend and interest income was \$610,185 and interest on notes receivable from participants was \$10,360 for the year ended December 31, 2024, as certified by the Trustee.

Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

7. Party-in-interest transactions

Plan investments are shares of mutual funds and money market funds managed by the Trustee. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$31,776 for the year ended December 31, 2024.

The Plan also allows rollover contributions whereby participants may contribute amounts representing distributions from other qualified plans. The Plan allows an employer discretionary match contribution for employees not covered by a collective bargaining agreement. Employees must be employed as of the last day of the Plan year to be eligible for the employer match contributions. During the year ended December 31, 2024, the Company made no such discretionary employer match contribution.

For the employees of the Company covered by a collective bargaining agreement with UAW Local 6, the Company matches each dollar contributed by the participant up to a maximum of \$25 per week.

For the employees of the Company covered by a collective bargaining agreement with PWU Local 18, the Company matches each dollar contributed by the participant up to a maximum of \$20 per week.

For the employees of the Company covered by a collective bargaining agreement with Teamsters Local 781, the Company matches each dollar contributed by the participant up to a maximum of \$10 per week.

Contributions: (continued)

In addition, the Company may make annual discretionary profit-sharing contributions in an amount to be determined at Plan year-end by the Company. Employees must be employed as of the last day of the Plan year and complete one year of service to be eligible for profit-sharing contributions. During the year ended December 31, 2024, the Company made no such discretionary profit-sharing contribution.

Participant accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants self-direct their contributions and their share of the Company's contribution among the investment options.

Vesting:

Participants are immediately vested in their employee contributions plus actual earnings thereon. Discretionary profit-sharing contributions and matching contributions, together with corresponding earnings on each, shall vest 100% after one year of service for all non-collectively bargained participants. For those participants covered by a collective bargaining agreement with UAW Local 6, PWU Local 18 and Teamsters Local 781, employer matching contributions and corresponding earnings shall vest 100% after three years of service. Participants become fully vested upon reaching normal retirement age, death, or disability.

Payment of benefits:

A participant becomes entitled to benefits under the Plan upon retirement at age 65, permanent disability or resignation from the Company. In-service distributions are also allowed for participants who attain the age of 59 ½ and hardship distributions are permitted. A participant's account balance becomes fully vested upon death or disability. Upon resignation or retirement, participants are entitled to receive the vested portion of their account balance.

1. Description of the Plan (continued)

Loans to participants:

Loans are available to Plan participants at the prime interest rate plus 1% at the time the loan was initiated. The prime rate was 7.50% and 8.50% at December 31, 2024 and 2023, respectively. The minimum loan is \$1,000 and the maximum amount is equal to the lesser of \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period or 50% of their vested account balance. All loans must be repaid in ratable payments on at least a quarterly basis, over a five-year period unless the loan is for the purchase of a principal residence for which the term of the loan may be as long as thirty years. Loan defaults are treated as distributions. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

Forfeitures:

If a participant terminates employment and is less than 100% vested in the employer account, then the participant may forfeit the nonvested portion of the employer account. A forfeiture will occur in the Plan year that a distribution of the entire vested account is received or if a distribution is not received after five consecutive one-year breaks in service. Forfeitures may be used to pay Plan expenses or to reduce employer contributions to the Plan.

2. Summary of significant accounting policies

Basis of presentation:

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds and money market funds are valued at the market value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

2. Summary of significant accounting policies (continued)

Contributions:

Participants' contributions are recognized by the Plan when withheld from the participants' paychecks by the Company.

Payment of benefits:

Benefits are recorded when paid.

Notes receivable from participants:

As described in Note 1, the Plan allows participants to borrow against their vested account balances and the loans are secured by the participant's account balance. Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest.

Administrative expenses:

All administrative costs, charges and expenses are paid by the Plan to the extent not paid by the Company.

Expense offset arrangements:

Fees incurred by the Plan for investment management services and recordkeeping are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits as of December 31, 2024 and 2023 and the reported amounts of changes in net assets available for benefits during the year ended December 31, 2024. Accordingly, actual results could differ from those estimates.

Subsequent events:

The Plan Administrator has reviewed and evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.

3. Risks and uncertainties

The Plan invests in various investment securities. These investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Investments (information prepared and certified by Fidelity Management Trust Company (the Trustee))

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in these financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Trustee.

The Trustee certified the fair value of investments of \$12,736,418 and \$12,970,940 as of December 31, 2024 and 2023, respectively. Notes receivable from participants of \$170,191 and \$114,522 were also certified by the Trustee at December 31, 2024 and 2023, respectively. Interest rates on outstanding balances range from 4.25% to 9.50% at December 31, 2024 and 2023.

For the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought, sold and held during the year) appreciated in value in the amount of \$1,038,974, as certified by the Trustee. Dividend and interest income was \$610,185 and interest on notes receivable from participants was \$10,360 for the year ended December 31, 2024, as certified by the Trustee.

Mutual funds and money market funds: Valued at the market value of shares held by the Plan at year-end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes that the Plan's valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax status

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

7. Party-in-interest transactions

Plan investments are shares of mutual funds and money market funds managed by the Trustee. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$31,776 for the year ended December 31, 2024.
