Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment

information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of Hospice Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan sponsored by Hospice & Palliative Care Buffalo, Inc. and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan permits participation of eligible employees of Hospice & Palliative Care Buffalo, Inc. and its related employers Hospice Buffalo, Inc. and Hospice Foundation of WNY, Inc. (collectively, the Organization). The Retirement Plan Committee is responsible for oversight of the Plan. American TCS Fiduciary Services, LLC is an administrative and investment fiduciary to the Plan. TRG Advisors, Inc. serves as the investment advisor to the Plan. The investment fiduciary determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility:

Employees of the Organization, except for leased employees, collectively-bargained employees, and Puerto Rico residents, are eligible to participate in the Plan. Eligible employees are automatically enrolled upon hire. The Plan provides for non-elective safe harbor contributions, matching and discretionary profit-sharing contributions to participants upon being enrolled.

Contributions:

Unless otherwise directed by the participant, participants are automatically enrolled in salary reduction contributions equal to 6% of eligible compensation, as defined. These pre-tax contributions are invested in a designated fund until changed by the participant. Participants may elect an alternate salary reduction amount, up to 90% of eligible compensation, on a pre-tax and/or Roth basis. Automatically enrolled participants who elect less than 6% are subject to an annual automatic 1% increase, up to a maximum salary reduction of 6% of eligible compensation. Participants who are fifty years and older may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover).

Non-elective safe harbor contributions equal to 3% of the participant's eligible compensation are provided by the Organization. Matching contributions are made by the Organization equal to 100% of elective deferrals contributed up to a maximum of 2% of eligible compensation, plus 50% of the participant's elective deferral contributions which are over 2% of eligible compensation but not more than 6% of eligible compensation, for a maximum employer match of 4% of eligible compensation. The Organization made discretionary profit-sharing contributions equal to 2% of the participant's eligible compensation for the years ended December 31, 2024 and 2023.

Contributions are subject to certain limitations of the Internal Revenue Code (the Code). Participants direct the investment of contributions into various investment options offered by the Plan.

Note 1. Plan Description (Continued)

Participant accounts:

Each participant's account is credited with the participant's contributions, Organization contributions, and an allocation of Plan earnings and reduced for benefits paid, participant loan origination, loan maintenance and benefit processing fees, if applicable, and an allocation of certain administrative expenses. Allocation of plan earnings and certain administrative expenses are based on the investments held by the participant relative to the total Plan investments. Pursuant to fee leveling arrangements, impacted participants are allocated a pro-rata reimbursement of fund management fees received by the Plan. The benefit to which a participant is entitled is limited to that which can be provided from the participant's vested account balance.

Vesting:

Participants are vested immediately in their contributions, plus actual earnings thereon.

Participants hired prior to January 1, 2023 are vested immediately in their employer non-elective safe harbor and employer matching contributions, plus actual earnings thereon. These participants are 25% vested in profit-sharing contributions after one year of service, 50% vested after two years, and 100% vested after three years of credited service, as defined.

Participants hired between January 1, 2023 and January 31, 2024 are 100% vested in employer non-elective safe harbor contributions after two years of service and are 20% vested in profit-sharing and employer matching contributions after two years of service, with vesting increasing in 20% increments for each year of service completed thereafter.

Participants hired on or after February 1, 2024 are 100% vested in employer non-elective safe harbor contributions after two years of service and 100% vested in profit-sharing and employee matching contributions after three years of service.

Payment of benefits:

On termination of employment with the Plan Sponsor, death, disability, or retirement, a participant or a participant's beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or periodic equal payments. Distributions are also permitted in the event of financial hardship and for participants who have attained age 59½. Participants may also withdraw from the portion of their account related to Roth contributions at any time that will be subject to income taxes on the investment earnings thereon.

Notes receivable from participants:

Participants may borrow from certain of their accounts a minimum of \$1,000 up to a maximum loan equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than 2 loans outstanding at any given time. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator. Loans must be repaid in at least monthly installments over a maximum term of 5 years for personal loans and over a term determined by the Plan Administrator for loans related to the purchase of a participant's primary residence. Principal and interest are paid ratably through payroll deductions.

Note 1. Plan Description (Continued)

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the origination and maintenance of notes receivable from participants, benefit processing and recordkeeping, fiduciary and investment advisory services are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment from the Plan. Amounts provided to the Plan pursuant to fee leveling arrangements are reported as other income on the statements of changes in net assets available for benefits.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements have been prepared on the accrual basis of accounting.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. American TCS Fiduciary Services, LLC determines the Plan's valuation policies utilizing information provided by the Plan's trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

Benefits:

Benefits are recorded when paid.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events:

Subsequent events have been evaluated through August 11, 2025, which is the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by T. Rowe Price Trust Company (T. Rowe Price), the trustee of the Plan. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the fund's trustee, is used as a practical expedient to estimate fair value. The NAV is primarily based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The Plan's investment in the collective trust fund has a daily redemption frequency, no redemption notice requirement and has no unfunded commitments at December 31, 2024 and 2023. If the Plan initiates a full redemption, the issuer reserves the right to require 12 or 30 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

For investments using the NAV practical expedient, there are no participant redemption restrictions; 12 or 30 months' advance written notice is required for redemption; the redemption frequency is daily, and there are no unfunded commitments at December 31, 2024 and 2023.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 6. Tax Status

The Plan has adopted a non-standardized pre-approved plan sponsored by T. Rowe Price Retirement Plan Services Inc. The Plan has received the opinion letter from the Internal Revenue Service (IRS) as to the Plan's qualified status dated August 19, 2020. The opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code.

HOSPICE RETIREMENT PLAN

NOTES TO FINANCIAL STATEMENTS

Note 6. Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7. Party-In-Interest Transactions

A Party-in-interest is defined under the Department of Labor's regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, certain participants, and others. The Plan allows participants to take loans from certain accounts in the Plan. Certain notes receivable from participants and income thereon qualify as party-in-interest transactions.

The Plan holds certain investments managed by T. Rowe Price. T. Rowe Price is the trustee as defined by the Plan and, therefore, transactions within these funds qualify as party-in-interest transactions. T. Rowe Price Retirement Plan Services, Inc. (T. Rowe Price RPS), an affiliate of T. Rowe Price, is the recordkeeper as defined by the Plan. Fees paid by the Plan to T. Rowe Price RPS for loan origination and maintenance, benefit processing and recordkeeping services qualify as party-in-interest transactions and are reported as administrative expenses. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment from the Plan. Fees paid by the Plan to TRG Advisors, Inc. for investment advisory services qualify as party-in-interest transactions and are reported in administrative expenses.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
