Note 1: Description of Plan

The following brief description of the Moyer & Son, Inc. 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted by the Board of Directors of Moyer & Son, Inc. (the "Company") effective December 1, 1985. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The purpose of the Plan is to assist employees in accumulating funds for retirement through a combination of employee salary deferrals and employer matching contributions.

Eligibility Requirements

Employees become eligible to join the Plan after 90 days of service and attaining age 21. Participation in the Plan is voluntary.

Contributions

Participants in the Plan may contribute, subject to an annual limit, the lesser of 60% of eligible compensation as defined by the Plan or the maximum of \$23,000 for the year ended December 31, 2024 not to exceed IRS regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make discretionary matching contributions at a percentage determined by the management of the Company. A matching contribution was made by the Company and was equal to 50% of the first 4% of compensation that a participant contributed to the Plan in 2024. Participants direct the investment of all contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's elective and rollover contributions, an allocation of Plan investment earnings, and the Company's contribution and charged with withdrawals and distributions and an allocation of Plan investment losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may change their self-directed investment options daily.

Vesting

Employer contributions become 20% vested after the completion of one year of service. The percentage vested increases 20% every year thereafter with 100% vesting after five years of Plan participation. Employees must work at least one year to be credited with a year of service for vesting purposes.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and the maximum amount of the lesser of one-half of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior twelve-month period. The loan must be repaid within five years. The loans are secured by the balance in the

participant's account and bear interest at rates that range from 4.25% to 9.5%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through weekly payroll deductions. An administrative fee by the trustee is charged to the employee's account when a new loan is made. Interest income on notes receivables is net of these fees. Interest received on participant notes for the year ended December 31, 2024 totaled \$21,970.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. For any vested account balance less than or equal to \$1,000, a distribution to a qualified IRA account or as a lump-sum payment will automatically generate without the participant's consent. Eligible employees meeting the vesting requirements are entitled to receive the full value of their account balances at the participants' normal retirement age or April 1 following the year the participants reach age 70½. Normal retirement age is age 65. If a participant dies, the Plan will pay the beneficiary the total amount in the participant's account in a lump sum payment.

An employee who becomes totally and permanently disabled is entitled to receive 100% of his or her account as soon as administratively feasible.

Investment Options

The Plan has various investment options in which participants may elect to have their contributions invested with varying risk levels to allow participants to meet their individual investment objectives.

Forfeitures

Forfeitures of nonvested employer matching contributions are retained in the Plan and will be used to pay administrative expenses or to reduce employer contributions payable under the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$263 and \$254. Forfeitures of approximately \$42,391 during 2024 were used to reduce employer contributions.

Secure Act and Secure Act 2.0

The Plan is currently working with their third party administrator to ensure compliance and any required plan changes are made to comply with the Secure Act and the Secure Act 2.0.

Note 2: Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Note 2: Summary of Accounting Policies (Continued)

Investment Valuation and Income Recognition

The investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The presentation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events

Management has evaluated subsequent events through July 17, 2025, the date the financial statements were available to be issued. Adjustment or additional disclosures, if any, have been included in these financial statements.

Note 3: Fair Value Measurements

The Plan follows the guidance for fair value measurements and disclosures in accordance with Accounting Standards Codification Topic 820, *Fair Value Measurements and Disclosures* ("ASC 820"). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

In determining fair value, Management uses various valuation approaches, as appropriate in the circumstances. ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are market data from independent sources. Unobservable inputs are Management's assumptions, based on the best information available, of how the market would price the asset or liability. The fair value hierarchy is categorized into three levels based on the inputs as follows:

Level 1

Valuations based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these securities does not entail a significant degree of judgment.

Level 2

Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.

Level 3

Valuations based on inputs that are unobservable and significant to the overall fair value measurement. The inputs into the determination of fair value require significant judgment and estimation.

The Plan does not maintain Level 2 or 3 assets.

The Plan's policy is to recognize transfer of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies or level designation used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund

The objective of the money market fund is to earn interest while preserving the value at \$1 per share. The fund invests in a portfolio of money market instruments comprising a diversified portfolio of high-quality short-term debt obligations issued by the U.S. government and its agencies, and repurchase agreements secured by those obligations.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) This class includes investment in common/collective trust that primarily invests in investment contracts and security backed contracts. The investment contracts are issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period. A security-backed contract has similar characteristics as traditional investment contract and is comprised of two parts: the first part is a fixed income security or portfolio of fixed income securities; the second part is a contract value guarantee (wrapper) provided by a third party. Wrappers provide contract value payments for certain participant-initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity. The Fund's investment objective is to maintain principal. The fair value of the investments in this class have been estimated using the net asset value per unit of the investments in the trust.

Note 4: Tax Status

The Company has adopted a Standardized Prototype Deferred Profit Sharing Plan as prepared by Fidelity Management Trust Company ("trustee"). The Plan has received favorable determination letters from the Internal Revenue Service, the most recent of which is dated June 30, 2020 stating that the Plan and related trust agreement are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving this determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with all appropriate requirements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 5: Information Prepared and Certified by the Trustee (Unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all

investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental Schedule of Assets Held for Investment Purposes at End of Year (attachment for Schedule H, Line 4i) as of December 31, 2024, and the related investment activity and interest on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 6: Administration of Plan Assets

Plan assets are held by Fidelity Management Trust Company, the trustee of the Plan.

The Plan is administered by the Benefits Administrator of the Company whereby certain administrative functions are performed by employees of the Company. No employees receive compensation from the Plan. Contributions are held and managed by the trustee, which invests the cash received, as well as interest and dividend income as designated by the participants and makes distributions to participants. The trustee also administers the payments of interest and principal on participant loans.

Note 7: Related Party Transactions

Certain Plan investments are proprietary funds and managed by the trustee, and therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Participant fees paid by the Plan amounted to \$37,226 for the year ended December 31, 2024.

Note 8: Plan Termination

The Plan is intended to be a permanent program of the Company. However, the Company can at any time declare the Plan terminated subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 9: Concentrations of Credit Risk

The Plan provides for investment options in various mutual funds with Fidelity Management Trust Company. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across different mutual fund elections. Additionally, the investments within each participant-directed mutual fund election are further diversified into varied financial instruments.
