Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Alliance Beverage Distributing, LLC Employees Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering certain employees of Alliance Beverage Distributing, LLC (the "Company"). In order to be eligible for the Plan, employees must attain 21 years of age and complete at least 1 hour of service during the first 6 months of employment. If an employee does not work at least 1 hour during the first 6 months, the employee will satisfy the Plan's minimum service requirement once a year of service has been reached. The Plan is subject to the Internal Revenue Code (IRC) Section 401(k) and the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Contributions: A participant can make voluntary salary or wage deferral contributions up to 90% of his or her eligible compensation, within the maximum allowed by the Internal Revenue Service. Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the plan, and they may elect to change or discontinue deferrals at any time. Participants who have attained age 50 by the end of the Plan year may also make catch-up employee deferral contributions in accordance with Code Section 414(v). The Plan also provides for a discretionary employer matching contribution. During the year ended December 31, 2024, the Company elected to match 50% of participant contributions up to the first 8% of eligible wages, to be paid to those employees who are 21 years of age and completed a minimum of 1 hour of service, totaling \$556,900.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Discretionary employer matching contributions are allocated to participants who made salary or wage deferrals in the current year. Allocations of Plan earnings or losses are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant (beneficiary) is entitled to 100% of his or her account balance upon reaching normal retirement age, death or total disability.

Vesting: Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's discretionary matching contributions plus earnings thereon is based upon years of service. A participant is 100% vested after six years of credited service with graduated vesting beginning at 20% after two years.

Forfeitures: The nonvested portion of employer matching and annual contributions of terminated participants may be used to pay Plan expenses, allocate as additional employer contributions or to reduce employer contributions under the Plan, at the discretion of Plan management.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a reasonable fixed rate determined by the plan administrator. All loans are covered by demand notes and are repayable through payroll deductions.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$1,000 are automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum or in installment payments. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event the Plan terminates, all accounts shall become 100% vested and the accrued benefits in an employee's individual account will be distributed in accordance with the terms of the Plan agreement.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from the estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan provides for various investments. The investments are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balance.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Stable Value Fund: The fair values of interest in stable value funds are based upon the net asset values of such funds, as reported in the most recent audited financial statements of the fund (Level 2 inputs). The primary investment objective of the fund is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The Fund's returns are based on returns generated by an actively managed, highly diversified portfolio of investment grade, fixed and floating rate securities. The fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notification requirements.

NOTE 5 - PARTY-IN-INTEREST

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Transactions during the year with parties-in-interest include administrative services. Investment management fees are paid for by the Plan to investment managers who qualify as parties-in-interest, including Leafhouse Financial Advisors, OneDigital Investment Advisors, Newport Group, Reliance Trust Company, The W.L. Burmeister Company, Transamerica Retirement Solutions and Transamerica Life Insurance Company Inc. These investment management fees are reflected in the financial statements as a reduction of the return on the Plan's investments. Professional fees for the audit of the Plan are paid by the Plan. The majority of administrative fees of the Plan are paid for by the Company. The Plan holds a collective trust stable value fund managed by Transamerica Life Insurance Company Inc. at December 31, 2024 and 2023, that qualifies as a party-in-interest investment. The notes receivable from participants are also considered to be party-in-interest transactions.

NOTE 6 - INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
