## Independent Auditor's Report

To the Trustees and Plan Administrator of  
AMSC 401(k) Savings Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of AMSC 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AMSC 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. DESCRIPTION OF PLAN

The following description of AMSC 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a defined contribution plan with a cash or deferred profit-sharing arrangement sponsored by American Superconductor Corporation (the Company) (AMSC) for the benefit of its employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan Administrator and has authority, along with the Trustees, to control and manage the operation and administration of the Plan, subject to the terms and provisions of the Plan.

#### b. Eligibility

All employees of the Company and its wholly owned subsidiary, Superconductivity, Inc., who have attained the age of 21, excluding union employees, leased employees, contractors, and residents of Puerto Rico, are eligible to participate in the Plan and receive the Company common stock matching contribution. Participants must be employed at the end of the year and have 1,000 hours of service to be eligible for the Company's discretionary profit-sharing cash contribution.

#### c. Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, subject to Internal Revenue Code (IRC) limitations. Participants who have attained the age of 50 or older are also permitted to make catch-up contributions into the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Plan allows participants to contribute post-tax (Roth) deferral contributions subject to IRC limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company matches participant contributions at the rate of 50% of the first 6% of the participant's salary. The match is made in shares of the Company's common stock, which is calculated based upon the NASDAQ closing quote on the final business day of the month. A participant has the option to liquidate any or all of the vested portion of the participant's matching account in the Company's common stock by transferring the proceeds into securities offered by the Plan. The Company may also elect to make a discretionary profit-sharing cash contribution. The Company did not make a discretionary profit-sharing cash contribution for the year ended December 31, 2024.

#### d. Participant Accounts

Each participant account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings and losses and charged with administrative expenses. Allocations are based upon each participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### e. Notes Receivables from Participants

Participants may borrow from their accounts an aggregate amount up to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans must be repaid within five years unless the loan is for the purchase of the participant's primary residence, in which case, the term may be up to fifteen years. A participant may only have one outstanding loan. Loans are secured by the participant's non-forfeitable interest in the Plan and are supported by a promissory note. The interest rate is set at a commercially reasonable rate determined by the Plan Administrator. All loans are repaid through payroll deductions.

#### f. Payments of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. The Plan allows in-service withdrawals upon attainment of age 59½. There are also retirement benefits available upon disability and death. Distributions are made in lump-sums. The Plan has an involuntary cash-out provision allowing for the Plan Administrator to pay out vested balances up to \$1,000 to participants who terminated employment with the Company during the plan year. Effective April 15, 2024, the Plan adopted the optional provision of SECURE Act 2.0 to increase the limit of involuntary force-out distributions from \$1,000 to \$7,000.

A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to Section 401(k) of the IRC or standards established by the Secretary of the Treasury or their delegate.

#### g. Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, Company contributions, and actual earnings thereon.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of asset and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institutions. See Note 4 for discussion of fair value measurement.

#### Investment Valuation and Income Recognition (Continued)

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loans to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of December 31, 2024, there were no defaulted loans.

#### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Department of Labor's and Internal Revenue Service's (IRS) rules and regulations, including any excess deferrals, Company common stock matching contributions or discretionary profit-sharing cash contributions, are reflected as liabilities in the accompanying financial statements with a corresponding amount reflected as benefit payments paid to participants for the corrective distributions or a reduction in contributions in the case of excess deferrals or Company common stock matching contributions or discretionary profit-sharing cash contributions. As of December 31, 2024 and 2023, the Plan reported excess contributions payable totaling \$1,038 and \$74,219, respectively.

#### Contributions

Contributions from plan participants and the Company common stock matching contribution are recorded in the year which the contributions are withheld from compensation. The Company's discretionary profit-sharing cash contributions are recorded when such contributions are authorized by the Company.

#### Payment of Benefits

Benefit payments are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to record-keeping, investment advisory services, the administration of notes receivable from participants, and processing of distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of investments.

#### Subsequent Events

Subsequent events have been evaluated through August 5, 2025, which is the date the financial statements were issued. There were no events that met the criteria for recognition for disclosure in the financial statements, except as disclosed in Note 10.

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the period April 13, 2024 to December 31, 2024.

Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, (collectively, Principal), a second qualified institution, has certified to the completeness and accuracy of all investments reported in the accompanying statement of net assets available for benefits as of December 31, 2023, and certain related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits for the period January 1, 2024 to April 12, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024.

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### 4. FAIR VALUE MEASUREMENT (Continued)

The determination of where assets and liabilities fall within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price and, accordingly, these investments are valued using observable inputs. The mutual funds held by the Plan are deemed to be actively traded.

*AMSC common stock:* Valued at the closing price as of the last trading day of the respective calendar year-end, reported on the active market on which the security is traded.

*Pooled separate accounts:* The fair value of the Plan's interest in the pooled separate accounts is based on the fund's daily net asset value (NAV) as a practical expedient, which is considered by the Company to be the best approximation of fair value. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the pooled separate accounts will be sold for an amount different from NAV. As of December 31, 2023, the Plan had no plans to sell the pooled separate accounts at amounts different from NAV. This account is not exchange traded. Data for the NAV is available daily to plan administrators and client investors on Principal's website and provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. Although the underlying assets of the fund cannot be quickly sold and converted to liquid assets, Principal's guaranteed interest account provides the fund with a liquidity guarantee whereby Principal ensures that the account has funds available to meet participant redemption, transfer, or cash withdrawal requests. There are no unfunded commitments from participants in the Plan who invest in these accounts. All pooled separate accounts are direct filing entities.

There have been no changes in the valuation methodologies used as of December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Company believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. TAX STATUS

AMSC has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Sections 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the Plan's qualified institutions, notes receivable from participants, fees paid to the Plan's third-party administrator and auditor are considered party-in-interest transactions. During 2024, the Plan paid \$95,843 of administrative expenses to the qualified institutions and investment advisor.

### **7. PLAN TERMINATION**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Plan and ERISA. In the event of plan termination, all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### **8. RISK AND UNCERTAINTIES**

The Plan invests in various investment options in a number of investments. Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant balances and the amounts reported in the statements of net assets available for benefits.

### **9. DELINQUENT PARTICIPANT CONTRIBUTIONS**

During 2023 and 2022, the Company failed to segregate and remit in a timely manner, certain participant contributions (salary reduction amounts) within the required time period as specified by the United States DOL Reg. 2520.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction. The Company computed the lost earnings on these 2023 and 2022 deferrals and made a contribution for lost earnings to the Plan during the 2024 plan year.

### **10. SUBSEQUENT EVENT**

The Company acquired NWL, Inc. effective August 5, 2024. As part of the acquisition, the NWL, Inc. 401(k) Retirement Plan will be merged into the AMSC 401(k) Savings Plan with a target date of January 1, 2026, for the plan merger.
