Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i, as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1—Description of the Plan

The following description of the Points of Light Foundation 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and Summary Plan Description for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan sponsored by Points of Light Foundation (the “Foundation”) for the benefits of its employees. Employees who work 20 hours or more a week are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Foundation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Plan is administered by the Foundation, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. Empower Trust Company, LLC or one of its affiliates (“Empower”) served as the “Custodian” of the Plan and provided recordkeeping and other administrative services to the Plan for the year ended December 31, 2024. Empower also serves as the issuer of the EI Fixed Account - Series Class III, a contract held by the Plan.

Contributions – Participants may elect to contribute a percentage of their compensation or a set amount per pay period to the Plan each Plan year through pre-tax or post-tax (Roth) elective deferrals. There is no service requirement for an employee to defer a portion of their compensation as a pre-tax deferral. Total participant contributions in any calendar year are limited to the applicable limits under the Internal Revenue Code (“IRC”) Section 402(g). Contributing employees are eligible to receive matching contributions made by the Foundation. The Foundation will match 50% of an eligible participant’s compensation up to 7% of eligible compensation. Participants are eligible to make rollover contributions to the Plan in accordance with Internal Revenue Service (“IRS”) regulations. Rollover contributions can be used between the same or different Plan types if a distributable event is met. Rollover contributions are at all times fully vested and nonforfeitable under the Plan.

Catch-Up Contributions – If a participant is eligible to make deferrals and attained age 50 before the end of the calendar year, the participant may defer additional amounts to the Plan as pre-tax contributions subject to certain IRC limitations. Catch-up contributions are eligible for matching contributions made by the Foundation.

Discretionary Contributions – The Foundation may make discretionary matching contributions or discretionary nonelective contributions to the Plan. There were no such discretionary contributions made to the Plan for the year ended December 31, 2024.

Participant Accounts – Each participant’s account is credited with the participant’s contribution, the Foundation’s contributions, if any, and allocation of Plan earnings. Additionally, each participant’s account is charged with Plan losses, benefit payments, and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Investment account options available include fixed annuity accounts and mutual funds. Upon enrollment in the Plan, the Plan permits participants to direct the investment of their elective deferrals and Foundation contributions into various investments offered by the Plan. Participants may change their investment options at any time.

Vesting – Participants are immediately vested in their voluntary contributions. Participants vest in the Foundation’s matching and discretionary contributions and related earnings thereon based on years of continuous service as follows:

Participants hired on or prior to December 31, 2019:

Forfeitures – As of both December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0-. Per the Plan document, these amounts may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During the year ended December 31, 2024, \$16,415 of forfeited nonvested accounts were used to reduce employer contributions and \$0 of forfeited nonvested accounts were used to pay Plan expenses.

Payment of Benefits – Upon termination, retirement, permanent disability, or death, a participant or beneficiary may elect to receive either a lump-sum amount equal to the vested balance of their account or convert to an income option (if assets are invested in an annuity contract). A participant may elect to receive a distribution of their rollover contributions at any time. Withdrawals other than for termination are permitted under circumstances provided by the Plan. A participant may request a withdrawal from their balance of elective deferrals based on financial hardship as defined by IRC regulations. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Vested account balances greater than \$5,000 will be distributed in accordance with the participant’s election either as a lump-sum payment or as a rollover to an individual retirement account or another qualified retirement plan. For vested account balances of \$5,000 or less, the Plan provides for mandatory distribution of a participant’s vested account balance following severance from employment. Participants with a vested account balance less than \$1,000 upon severance from employment will receive a lump-sum payment from the Plan whereas vested account balances between \$1,000 and \$5,000 may be automatically rolled over into an individual retirement account.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at rates ranging from 5.75% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions.

Basis of Presentation – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Note 2—Summary of significant accounting policies

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are valued at fair value, with the exception of the fully benefit-responsive investment contract, which is required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds and fixed interest accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable is recorded on the accrual basis. Delinquent loans are reclassified as deemed distributions based upon the terms of the Plan document and are included in the statements of changes in net assets available for benefits under benefits paid to participants.

Plan-to-Plan Transfers – The Plan includes provisions authorizing plan-to-plan transfers. Plan-to-plan transfers are used to transfer assets between plans of the same type as described in Revenue Procedures 2007-51 by the IRS and the Plan document. Plan-to-plan transfers are permitted between 403(b) plans if: (i) the terms of the transferring and receiving plans allow these transfers; (ii) the transferred assets belong to a current or former employee of the receiving plan's sponsor; (iii) the accumulated benefit after the exchange is at least the same before the exchange; and (iv) any benefit restrictions of the transferring plan are maintained by the receiving plan. Refer to Note 8 for discussion over the Plan's 403(b) status. Unlike rollover contributions, a participant does not have to meet a distributable event to be eligible for a plan-to-plan transfer. Under the Plan document, plan-to-plan transfers are 100% vested and nonforfeitable.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits – Benefit payments to participants are recorded upon distribution.

Administrative Expenses – Certain expenses of operating and maintaining the Plan have been paid by the Foundation and are excluded from the accompanying financial statements. In the event the Foundation does not continue to pay the Plan expenses, the Plan expenses will be paid by the Plan and charged on a pro rata basis to the value of the participant's account balances.

Fair Value Measurements – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds – These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

The Plan believes its valuation method is appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3—Information certified by the Custodian (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower has certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments at fair value, investments at contract value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at the end of year).

Note 5—Group annuity contract

The Plan invests in a group annuity contract, which is an unallocated, fully benefit-responsive investment contract with Empower Trust Company beginning in April 2023.

A group annuity contract is maintained in a general account that is recorded at contract value. Contract value represents contributions made under the contract, plus interest credited, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. There are no reserves against contract value for credit risk. The crediting interest rate is determined on a quarterly basis by an actuarial formula, as designated by the Custodian. The crediting interest rate is subject to a guaranteed minimum floor rate of 1.00%. The crediting interest rate at December 31, 2024 and 2023 was 2.85% and 1.65%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger into another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Foundation or other Foundation events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The group annuity permits the Custodian to terminate the contract with a 30-day written notice in which a market value adjustment or other withdrawals restrictions may apply. The adjustment may be payable by the Foundation or deductions from participants' contract value account balances.

Note 6—Party-in-interest transactions

Plan investments include investments managed by the Custodian and, therefore, these transactions qualify as party-in-interest. Notes receivable are also considered to be party-in-interest transactions as they are transacted with Plan participants. Administrative expenses paid to the Custodian totaled \$44,190 for the year ended December 31, 2024. The Foundation performs services for the Plan without compensation and payments made by the Foundation on behalf of the Plan are excluded from the financial statements.

Notes receivable from participants qualify as party-in-interest transactions.

Note 7—Plan termination

Although it has not expressed an intention to do so, the Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Plan sponsor matching contributions.

Note 8—Tax status

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

A tax determination letter program is not yet available for IRC Section 403(b) plans through the IRS; however, the Plan administrator believes the Plan is currently designed and being operated in compliance with applicable requirements of the IRC and as such is exempt from federal income taxes.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 9—Subsequent events

The Plan has evaluated subsequent events for potential recognition and disclosure through July 24, 2025, the date the financial statements were available to be issued.
