INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor
AAC Education Services, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of AAC Education Services, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of AAC Education Services, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, which was established on January 1, 2021, is a defined contribution plan open to substantially all employees of AAC Education Services, LLC d/b/a All Around Children (the “Company” and the “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

All employees of the Company are eligible to participate in the Plan after completing one month of service. This includes pre-tax and after-tax (“Roth”) contributions, employer matching contributions, and non-elective contributions. Any employee who is covered by a collective bargaining agreement, leased employees, and employees who are non-resident aliens are not eligible to participate in the Plan. Employees may enter the Plan on the first day of the calendar month following the satisfaction of the service requirement.

Contributions

Once eligible, participants may make voluntary pre-tax contributions or Roth contributions by means of a salary deferral agreement of up to 100% of their compensation, subject to IRS limitations for the Plan year. The Plan provides for automatic enrollment and, accordingly, employees are treated as having elected to contribute 6% of their earnings as pre-tax 401(k) contributions unless an election is made for a different amount, or an election is made not to participate. Plan participants over the age of 50 are permitted to make additional pre-tax and Roth catch-up contributions to a maximum of \$7,500 in 2024. The Plan also permits rollover contributions from other qualified pre-tax retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer matching contributions are equal to 100% of the first 3% of employee deferrals and are remitted to the plan each pay period. The Company may also make discretionary non-elective contributions to eligible employees who are employed by the Company on the last day of the Plan year. Discretionary non-elective contributions are determined annually at the end of the Plan year. No discretionary matching contributions were made in 2024.

Participant Accounts

A separate account is maintained for each participant. Each participant’s account is credited with the participant’s elective deferrals, rollover contributions, employer matching contributions, an allocation of non-elective contributions (if applicable), and the Plan’s earnings or losses as defined by the Plan agreement. Plan earnings or losses are allocated daily based on each participant’s account balance.

Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may request a lump sum amount or installment payments equal to the value of the participant's vested interest in his or her account. The normal retirement age is 65. If a terminated participant's vested account balance is less than \$5,000, the trustee is authorized to automatically make a lump-sum distribution. Participants whose termination of service was due to death must have their entire account balance paid to all beneficiaries by December 31 following the fifth anniversary of the participant's death.

Participants may also be permitted to receive a distribution from their account prior to termination of employment if they reach age 59½ or experience financial hardship. In case of hardship, a participant may apply for a distribution, for certain qualifying reasons, as described in the Plan agreement.

Vesting

Participants are immediately 100% vested in their contributions to the Plan, plus any affiliated earnings thereon. Participants are 100% vested in the Company's matching contributions and non-elective contributions after two years of service. Prior to attaining two years of service, participants are not vested in the Company's matching contributions and non-elective contributions.

Forfeited Accounts

Forfeited nonvested accounts are used to pay administrative expenses or to reduce future employer contributions. Forfeitures should be used no later than the end of the Plan year following the Plan year which the forfeiture occurred. At December 31, 2024, there were no forfeited nonvested accounts. At December 31, 2023, forfeited nonvested accounts totaled approximately \$16,500. During 2024, employer contributions were reduced by approximately \$43,000.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Cash and Cash Equivalents

Cash and cash equivalents consists primarily of certain interest-bearing and noninterest-bearing cash accounts, and money market balances held by the custodian.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value by Matrix Trust Company, LLC ("Matrix"), the custodian of the Plan, as of December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments, including gains or losses, are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefit payments to participants are recorded when paid.

Plan Expenses

The Plan's administrative expenses are paid either by the Plan or the Company as provided by the Plan agreement. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in administrative expenses.

Income Taxes

In accordance with GAAP, the plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, the Plan did not recognize any liability for unrecognized tax benefits. The Plan undergoes regular audits by tax authorities, but there are currently no ongoing audits for any tax periods.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through August 14, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments, measured at fair value, are comprised of Level 1 mutual funds totaling \$704,722 and \$487,679, respectively. The Plan did not hold any Level 3 assets during the year.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix, the custodian of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, has certified to the completeness and accuracy of all investments held at December 31, 2024 and 2023, and the net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024.

NOTE 5 – CONTRIBUTIONS TO PARTICIPANTS

During the year ended December 31, 2023, an operational failure limited the ability of the Plan to withhold elective deferrals (pre-tax contributions) from one Plan participant after satisfying the eligibility requirements of the Plan. Plans with automatic contribution provisions are not required to contribute a qualified nonelective contribution (“QNEC”), under Revenue Procedure 2021-30 (“EPCRS”), if the following three conditions are met:

- 1) The correct deferrals begin on or before the earlier of:
 - a. Nine and a half months after the end of the plan year in which the failure occurred; or
 - b. The pay period on or after the end of the month following the month during which the affected participant notifies the Plan Sponsor of the deferral failure.
- 2) The employer must make a corrective matching contribution if the affected employees should have received a required or discretionary matching contribution, adjusted for lost earnings, for the period of failure.
- 3) Notice must be provided to the affected participants within 45 days of correct deferrals starting.

The Plan Sponsor fulfilled all three requirements to avoid the need for a QNEC related to a missed deferral. As a result, no QNEC was made in 2024 for the employee portion of the missed deferral.

Given the nature of the operational failure, there are no ERISA non-compliance implications.

NOTE 6 – INCOME TAXES

The trust established under the Plan, which holds the Plan's assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust's net investment income is exempt from income taxes. The Plan has adopted an Internal Revenue Service approved prototype plan. The prototype plan has received a favorable opinion letter from the IRS that it qualifies under IRS Code section 401(a), provided all terms of the plan are followed. The Plan has been amended since adopting the prototype plan. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor reserves the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.
