1. Description of Plan

The following description of NVRH 401(k) Retirement Plan (Plan) is provided for general information. Participants should refer to the Plan provisions for a more complete description of the Plan's provisions. The Plan is a defined contribution plan covering substantially all the employees of Northeastern Vermont Regional Hospital, Inc. (Hospital). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan has an Automatic Contribution Arrangement where participants, upon eligible, are automatically enrolled into a pre-tax contribution of 2% with an automatic escalation of 1% until the 401(k) contributions deferral percentage reaches 10%.

The Hospital contributes a non-elective contribution of 3% of a participant's eligible compensation, and a matching contribution equal to 100% of a participant's elected deferral, up to 1.5% of the participant's eligible compensation. Discretionary contributions are also allowed under the Plan, although none were made in 2024.

Participants can elect to contribute, on a before-tax basis, during the Plan year, up to the maximum allowable amount as determined by the Internal Revenue Code (IRC). Participants elect to have their contributions invested in accordance with the options available under the Plan.

Participant Accounts

Each participant's account is credited with an allocation of (a) the Hospital's matching and non-elective contributions, (b) the participant's elected contribution, and (c) Plan earnings and losses. Earnings and losses for participant-directed accounts are allocated to the respective segregated participant account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Eligibility

An employee will become a participant in the Plan on the first day of the month coinciding with, or the next following day, after which the employee has performed one month of service.

Vesting

Hospital contributions allocated to each account are 100% vested upon the participant's effective date of participation.

Distribution of Benefits

Upon termination of service a participant may elect to receive a lump sum distribution, or partial distribution, subject to rules that require certain minimum distribution requirements.

Participant Notes Receivable

Participants may borrow from their Plan account the lesser of \$50,000 or 50% of their vested account balance. Loan terms range up to a maximum of five years, longer if for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest is paid ratably through bi-weekly payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from these estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 5 for discussion of fair value measurements.

Purchases and sales of shares in the investment funds are recorded on trade date based on the share values reported by the funds on the day of the transaction. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment in Common Collective Trust

The T. Rowe Price Stable Value Fund (Fund) is managed by T. Rowe Price Trust Company as a commingled pool, seeking to preserve principal while earning a level of interest income consistent with principal preservation. The Fund strives to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive plan or participant payment.

The Fund is invested in benefit-responsive investment contracts issued by insurance companies, banks, and other financial institutions. The principal value of these assets is designed to remain stable regardless of stock and bond market fluctuations.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance, plus any accrued, but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through July 28, 2025, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Plan Termination

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will continue to be 100% vested in their accounts and be entitled to receive any amount then credited to their account after proportional adjustment of the accounts for all fund expenses, losses, or profits to the date of termination.

4. Income Tax Status

The Plan obtained its latest determination letter on August 19, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter, however, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. Fair Value Measurements

The Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year-end.

Common collective trust: Valued at the market approach based on the NAV of the units held by the Plan at year-end.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value, or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In addition, the Plan paid investment advisor fees to Pinnacle Pension Consultants and QDRO Consultants of \$35,000 and \$300, respectively.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
