**A. Description of Plan**

The following description of JND Holdings 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of JND Holdings, Inc. (the Company) and its affiliated companies who are not subject to collective bargaining agreements, are age 18 or older, and have six consecutive full months of employment.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors oversees governance of the Plan. The Plan's investment committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The recordkeeper maintains records of participant data and the custodian holds Plan assets.

**Concentration of Credit Risk** – The Plan maintains its cash in a deposit account, the balance of which is periodically in excess of federally insured limits. However, no losses have been experienced in such accounts.

**Contributions** - Participants may make (a) pre-tax contributions to the traditional 401(k) Plan, and/or (b) after-tax contributions to the Roth 401(k) Plan of any amount of gross pay up to the maximum dollar amount allowed by law for the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute certain rollover amounts representing distributions from other qualified defined benefit or contribution plans.

The Company will match 100% of employee elective deferrals up to 3% of compensation and 50% of employee elective deferrals up to an additional 2%. In addition, the Company may make discretionary non-elective contributions to the Plan which will be allocated to each participant's account based on their individual compensation as a percentage of total compensation, although the Company is not required to do so. During the years ended December 31, 2024 and 2023, the Company did not make any non-elective contributions.

**Rollovers** – Participants may elect to rollover amounts from other qualified plans or individual retirement accounts into the Plan, provided that certain conditions are met.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contribution, (b) Plan earnings (losses), and (c) charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately fully vested in their contributions and employer safe harbor contributions, plus actual earnings thereon.

**Investment Options** - The Plan offers a variety of mutual funds and an insurance product with varying general investment objectives and degrees of risk. Participants enrolled in the Plan may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change investment options during the year by logging in to their Empower account online.

**Forfeited Accounts** - Any forfeiture shall be applied to reduce administrative expenses and then employer matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4 and \$4, respectively.

**Payment of Benefits** - Upon retirement, termination of employment, disability or death, a participant or his or her beneficiary in the event of death, may elect to receive either a lump-sum payment, a partial lump-sum payment, or installment payments in an amount up to the value of the vested interest in his or her account, less any applicable tax withholdings and fees. Employees may elect in-service withdrawals of vested account balances upon attaining age 59 ½. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required age. The Plan allows for hardship withdrawals, subject to account balance limits and applicable laws.

Terminated participants with account balances of \$7,000 or less will receive a lump-sum cash payment as soon as administratively practicable upon the participant's employment termination.

**B. Summary of Significant Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and the insurance company. See Note G for discussion of fair value measurements.

Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts since contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions** – Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Administrative Expenses** - The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Various administrative expenses for recordkeeping and plan reporting requirements are charged directly to participants' accounts within the Plan. An annual asset-based fee of 56 basis points (.56%) was charged directly to participants' accounts. Additionally, participants' accounts were charged \$50 for each withdrawal in 2024 and 2023. The expenses to maintain participants' accounts within the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Excess Contributions Payable** - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. Total excess contributions payable for the years ended December 31, 2024 and 2023 were \$0 and \$1,917, respectively. The Plan distributed the 2023 excess contributions to the applicable participants prior to the year ended December 31, 2024.

**Payment of Benefits** - Benefit payments to participants are recorded when paid. At December 31, 2024 and 2023, there were no benefit claims payable for distributions to participants from the Plan requested prior to the end of the Plan year.

**Date of Management's Review** - Management has evaluated events for the Plan through August 20, 2025 the date the financial statements were available to be issued.

**C. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**D. Tax Status**

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the pre-approved plan indication that the pre-approved plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or assets) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**E. Plan Termination**

Although the Company has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions.

**F. Certified Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, an insurance company and the Plan recordkeeper.

**G. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under the FASB Accounting Standards Codification 820, *Fair Value Measurements*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2 – Inputs to the valuation methodology include:**

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There are no plan assets requiring the use of Level 3 inputs for the periods presented.**

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023:

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth, by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. The carrying value of receivables included in the accompanying statements of net assets available for benefits are approximated at fair value at December 31, 2024 and 2023, and are thus not included in the following table:

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2, and no transfers into or out of Level 3.

**H. Related Party and Party-In-Interest Transactions**

Certain Plan investments are shares of funds which are offered by Empower Trust Company, LLC and Empower Life & Annuity Insurance Company, and therefore, these transactions and the Plan's payment of custodian fees qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Empower Retirement, third-party record-keeper, is the name of the retirement plan business of Empower Trust Company, LLC and Empower Life & Annuity Insurance Company. Some administrative expenses for the Plan are paid directly by the Company and amounted to \$15,400 and \$14,300 for the years ended December 31, 2024 and 2023, respectively.

**I. Fully Benefit Responsive Investment Contract**

The Plan holds an investment in the Key Guaranteed Portfolio Fund issued under a Great-West Life Annuity Insurance Company Group Annuity Contract (the Contract). The Contract meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investments at contract value. There are currently no reserves against contract value for a credit risk of the contract issuers or otherwise. The contract value of this investment was \$790,334 and \$850,012 as of December 31, 2024 and 2023, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that would also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, or (c) a material misrepresentation, or (d) a material amendment to the agreement without the consent of the issuer.
