NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following is a brief description of the Osmose 401(k) Plan (“the Plan”) provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 1993. The Plan is a defined contribution, salary deferral plan covering substantially all employees of Osmose Utilities Services, Inc. (“the Company and Plan Sponsor”). Additionally, the Plan covers the following participating employers whose employees have met the eligibility requirements, as defined, Osmose, Inc., Osmose Railroad Services, Inc., Osmose Realty Corporation, Power Survey, LLC, Wood Protection L.P and IMCORP. The Plan is a qualified plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Employees must have attained age 21 and have six months of service in order to participate.

Contributions

Participants who are newly eligible to participate in the Plan are automatically enrolled with an elected contribution of 4% of his or her salary that will increase annually by 1% until it reaches 12% unless the participant affirmatively elects not to contribute or contribute a different percentage of his or her salary. Each participant may elect to contribute from 1% to 60% of his or her salary, not to exceed \$23,000 and \$22,500 per year for 2024 and 2023, respectively, as a tax-deferred contribution to the Plan. Participants who are 50 years old and over may make an additional catch-up contribution annually. This contribution was limited to \$7,500 in 2024 and 2023, respectively. The Company makes non-discretionary matching contributions based on 50% of pretax participant contributions up to a maximum matching contribution of 12%. The Company may also make annual discretionary profit-sharing contributions in an amount to be determined at Plan year-end by the Plan Sponsor’s Board of Directors. The Company did not make a discretionary contribution for the years ended December 31, 2024 and 2023. The Plan provides that participants may rollover balances from other qualified retirement plans.

Participants direct the investment of employee and employer contributions into various investment options offered by the Plan. Participants may change their investment allocation on a daily basis.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contribution, and allocated earnings. Earnings are allocated daily from the investment chosen by a participant based on the fair value of their respective ownership in the underlying investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. A portion of Plan expenses may be charged to the participant’s account.

1. DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their accounts in accordance with the rules as prescribed in the Plan Document. Loans are limited to the lesser of one-half of the value of the participant's vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at the prime rate as determined by the plan administrator plus 1%. Principal and interest are paid ratably through payroll deductions. A loan must be at a minimum of \$1,000 and a participant may have only one loan outstanding at a time.

Payment of Benefits

Participants are entitled to receive 100% of their account balances upon normal retirement at age 65 or at early retirement after age 55 with at least three years of service, or upon the death or disability of the participant. Participants may normally elect to withdraw their funds from the Plan upon termination of service, death, disability, attaining age 59½, or earlier in the event of financial hardship.

Vesting

Participants are fully vested in all voluntary contributions, plus actual earnings thereon. Participants vest in the Company's contribution portion of their account based on years of continuous service. A participant is 50% vested after two years of credited service and 100% vested after three years of credited service or when they reach age 65, become disabled, die, or if the Plan is terminated. However, if a participant was terminated between January 1, 2014 and September 30, 2015, they are 100% vested in the Company's contribution portion of their account. If a participant merged into the Plan from Power Survey, LLC on February 3, 2020, they are 100% vested in the Company's contribution portion of their account.

Forfeited Accounts

Forfeitures of unvested Company contributions are retained by the Plan, rather than returned to the Company, and will be used as a credit to reduce future Company contributions as well as pay Plan expenses. At December 31, 2024 and 2023 there were \$10,283 and \$40,583 forfeited funds on hand, respectively. In 2024 and 2023, forfeitures used to pay Company contributions were \$604,635 and \$572,077, respectively. In 2024 and 2023, forfeitures used to pay Plan administrative expenses were \$85,512 and \$83,339, respectively.

Plan Administration

The Plan is administered by the Company. Participant account records are maintained by the Plan's Trustee, Fidelity Management Trust Company. Costs of administration are primarily paid by the Company. A portion of Plan expenses may be charged to the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants become 100% vested in their account balances which will be paid out in a single lump sum.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Valuation of Investments

Investments held by a defined-contribution plan are required to be reported at fair value or net asset value (NAV) as a practical expedient for fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on assets bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Income Taxes

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Risks and Uncertainties

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the accompanying financial statements.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes to valuation methodologies in 2024 or 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds - The fair value of the mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Common collective trusts (CCT) - Valued at net asset value (NAV). The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it was determined to be probable that the funds will sell the investment for an amount different from the reported NAV.

- The Fidelity Growth Company Commingled Pool attempts to obtain prices from one or more third party pricing vendors or brokers to value its underlying investments. There were no unfunded commitments of the CCT as of issuance. The redemption frequency is daily and there is no redemption notice period.

3. FAIR VALUE MEASUREMENTS (Continued)

- The Putnam Stable Value Fund invests in fully benefit-responsive traditional guaranteed investment contracts, security-backed investment contracts (which may include, but are not limited to, asset-backed securities, corporate bonds, mortgage-backed securities, or securities backed by U.S. government agencies), and other short-term investments. The underlying investments are valued as follows; the fair value of traditional guaranteed investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. Individual assets of the security-backed investment contracts are generally valued on the basis of valuations furnished by a pricing service, which determines valuations using methods based on market transactions for comparable securities and various relationships between securities which are generally recognized by institutional traders. Short-term investments are valued at its closing net asset value each business day. Investment income earned from security-backed investment contracts is recorded net of fees paid to the wrap contract providers and investment income earned by short-term investments is reinvested in the Fund. There were no unfunded commitments of the CCT as of issuance. The redemption frequency is daily with participant transactions typically processed within one business day of being requested.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.
