## INDEPENDENT AUDITOR'S REPORT

To the Trustee of the Infinity Laboratories LLC 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.



Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### A. Description of Plan

The following description of the Infinity Laboratories LLC (Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### 1. *General*

The Plan is a defined contribution plan covering all employees who have completed 90 days of service during which the employee completes 500 hours and are 21 or older, except for certain union employees and non-resident aliens. Participants may participate in the plan on the first day of the month following when they meet the plan eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings, and monitor investment performance.

#### 2. *Participant Contributions*

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Investment options for participants include pooled separate accounts (PSAs). Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

#### 3. *Employer Contributions*

The Company contributes a safe harbor match equal to 100 percent of the participant's contribution up to 5 percent of eligible compensation. The Company may also make discretionary non-elective contributions. There were no discretionary non-elective contributions made for the period ended February 11, 2025 and years ended December 31, 2024 and December 31, 2023. Participants direct the Company contribution into various investment options offered by the Plan.

#### 4. *Participant Accounts*

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary matching contributions, non-elective contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### 5. *Vesting*

Participants are immediately vested in their contribution and safe harbor matching contributions plus actual earnings thereon. Participants are vested upon reaching 1000 hours of service for discretionary non-elective contributions, plus actual earnings thereon. Participants vest 20 percent once they complete their second year of service and are 100 percent vested after six years of credited service. Participants are immediately vested in all balances upon death or disability.

#### 6. *Notes Receivable From Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent as of December 31, 2024 and from 4.25 percent to 8.5 percent as of December 31, 2023, which are commensurate to a reasonable rate that is charged by a bank or other professional lender making a loan in similar circumstances. The loan interest rate is determined at the date the loan is made and is set at the prime rate plus one percent. Principal and interest is paid ratably through bi-weekly payroll deductions. Participants are charged a \$100 transaction fee for each loan requested.

#### 7. *Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments, partial withdrawals, as annuity for beneficiaries only, or a direct rollover to another qualified retirement plan. In addition, hardship distributions are permitted if certain criteria are met. Participants may also make an in-service withdrawal after obtaining the age of 59 ½.

#### 8. *Forfeited Accounts*

As of February 11, 2025, December 31, 2024, and December 31, 2023, forfeited non-vested accounts totaled \$0, \$0, and \$1,553, respectively. These accounts were used to reduce future employer contributions or to pay for plan administrative expenses. For the year ended December 31, 2023, forfeited non-vested accounts were used to reduce employer contributions or pay plan administrative expenses.

#### 9. *Plan Amendments*

The plan was amended on October 28, 2024, with an effective date of January 1, 2014. The amendment contained the following changes:

- The hours of service requirement was removed. 90 days of service is no longer required with respect to participant eligibility.
- Default form of payment has changed. Beneficiaries can no longer make distributions in the form of an annuity.
- The plan was frozen as of December 31, 2024, with respect to eligibility and benefit accruals.

#### 10. *Plan Termination*

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Company decided to terminate the plan following a merger with Eurofins Scientific Limited in September of 2024. The plan was terminated effective February 11, 2025. Plan assets of \$4,169,370 were transferred to the Eurofins Scientific, Inc. 401(k) Plan on February 12, 2025.

### **B. Summary of Accounting Policies**

#### 1. *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### 2. *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### 3. *Payment of Benefits*

Benefits are recorded when paid.

#### 4. *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Review and Advisory Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### 5. *Contributions*

Contributions from plan participants and safe harbor matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

#### 6. *Notes Receivable From Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as transaction fees and are expensed when incurred. Transaction fees were

#### 7. *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in transaction fees. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

#### 8. *Contributions Receivable and Current Expected Credit Losses*

In June 2016, the FASB issued ASU No. 2016-13, Financial Instruments – Credit Losses (Topic 326) – the ASU is required to be adopted by private companies for fiscal years beginning after December 15, 2022. The Plan has adopted this standard using the retrospective approach effective January 1, 2023. The ASU introduces a new credit loss methodology, Current Expected Credit Losses (CECL), which could result in earlier recognition of credit losses, while also providing additional transparency about credit risk. The CECL Methodology utilizes a lifetime “expected credit loss” measurement objective for the recognition of credit losses for employee and employer contributions receivable at the time of origination. The expected credit losses are adjusted each period for changes in expected lifetime credit losses. At adoption, there was no material impact to the Plan's net assets.

Historical write-off rates continue to be the basis for the Company's allowance for current expected credit losses. To calculate the reserve, the Company considered the processes surrounding the contributions receivable since the inception of the Plan. The Company has not historically written off the contributions receivables that were accrued at Plan year-end. The Company expected business conditions for the Plan year ended December 31, 2024, the collection period for the contributions receivables, to remain consistent with current conditions. As a result, the Company has recorded expected credit losses of \$0 as of December 31, 2024.

#### 9. *Subsequent Events*

Plan management has evaluated subsequent events from the statement of net assets available for benefits date through August 14, 2025, the date the financial statements were available to be issued. There were no material events noted in the subsequent period that would have impacted results reported herein or require disclosure.

#### D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 11, 2025, December 31, 2024 and December 31, 2023.

*Pooled separate accounts (PSAs):* Valued at fair value based on the investment's net asset value per unit. In accordance with fair value measurements and disclosure guidance, the PSAs are reported at the net asset value per unit as a practical expedient. The NAV is based on the fair value of the underlying investments held by the PSAs, less its liabilities. This practical expedient is not used when it is determined to be probable that the PSAs will sell the investment for an amount different from the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### E. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### F. Party in Interest Transactions

John Hancock Life Insurance Company (U.S.A.) provides certain administrative services to the Plan pursuant to a Master Plan Services agreement (MSA) between the Company and John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) receives revenue from pooled separate account service providers for services John Hancock Life Insurance Company (U.S.A.) provides. This revenue is used to offset certain amounts owed to John Hancock Life Insurance Company (U.S.A.) for its administrative services to the Plan. Fees paid by the Plan for recordkeeping services amounted to \$2,895 and \$29,384 for the period ended February 11, 2025 and year ended December 31, 2024, respectively, which is included in transaction fees.

If revenue received by John Hancock Life Insurance Company (U.S.A.) from such pooled separate account service providers exceeds the amount owed under the MSA, John Hancock Life Insurance Company (U.S.A.) remits the excess to the Plan's trust. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of participants. During 2024, there were no excess amounts remitted to the Plan.

The Plan uses the investment advisory services of Sheridan Road Advisors, LLC. As a service provider to the Plan, fees paid for investment advisory services from Plan assets qualify as party-in-interest transactions. The Plan made direct payments to Sheridan Road Advisors, LLC totaling \$691 and \$7,866 for the period ended February 11, 2025 and year ended December 31, 2024, respectively.

Certain plan administrative duties are performed by MAP Retirement, Inc. ("MAP"). The Plan compensates MAP for services performed. Fees paid by the Plan for third-party administrative services amounted to \$600 and \$3,400 for the period ended February 11, 2025 and year ended December 31, 2024, respectively.

#### **G. Tax Status**

The IRS has informed the Plan Sponsor by an advisory opinion letter dated June 30, 2020, that the prototype plan adopted by the Plan Sponsor, for the Plan and related trusts are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Thus, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Federal and State of Colorado taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
