Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1. Description of the Plan**

***General***

The following description of the DSM North America Defined Contribution Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by DSM North America, Inc. for the benefit of substantially all employees of the following affiliated companies (collectively, the Company):

- DSM North America, Inc.
- DSM Food Specialties USA, Inc.
- DSM Engineering Materials, Inc. (prior to March 31, 2023)
- DSM Nutritional Products, LLC
- DSM Biomedical, Inc.
- i-Health, Inc.
- Biomin America, Inc.
- Romer Labs, Inc.
- First Choice Ingredients, Inc.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan and serves as Plan custodian.

Effective December 29, 2023, the assets of the First Choice Ingredients, Inc. 401(k) Profit Sharing Plan, totaling \$9,108,450 were merged with and into the Plan. Of this amount, \$634,110 was received and recorded by the Plan in December 2023, and the remaining \$8,474,340 was received by the Plan in early January 2024 and was recorded as an other receivable on the statement of net assets available for benefits as of December 31, 2023.

***Contributions***

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover, Roth, after-tax and catch-up contributions are also permitted. For those employees not participating in or actively accruing a benefit under a defined benefit plan sponsored by the Company, the Company makes matching contributions of 100% of employees' salary deferral amounts, up to 4% of employees' compensation. For those employees participating or actively accruing a benefit under a defined benefit plan sponsored by the Company, the Company makes matching contributions of 100% of employees' salary deferral amounts, up to 3% of employees' compensation and 50% of employees' salary deferral amounts on the next 3% of employees' compensation. The Company makes a defined contribution of 4% of eligible compensation for those employees not participating in or actively accruing a benefit under a defined benefit plan sponsored by the Company. Contributions are subject to certain limitations. Forfeitures are used to reduce Company contributions or pay administrative expenses of the Plan.

***Participant Investment Account Options***

Each participant has the option of directing his or her contributions into any of the various investment options and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant makes an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 10%.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings, and is charged with an allocation of specific administrative expenses, as applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and employer matching contributions (excluding certain matching contributions transferred into the Plan from a prior plan as a result of merger, which are subject to separate vesting requirements), plus earnings thereon.

Vesting in the employer defined contribution account is based on years of continuous service. Such participants are generally fully vested after three years of continuous service. However, certain employer profit-sharing contributions that were transferred into the Plan from a prior plan, as a result of merger, are subject to differing vesting requirements with respect to employer contributions. The nonvested balances are forfeited upon termination of service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or for other reasons, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or installment payments.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,057,475 and \$2,525,821, respectively. These accounts will be used to reduce future Company contributions or pay administrative expenses of the Plan. During the year ended December 31, 2024, the Plan utilized forfeited nonvested accounts to reduce Company contributions in the amount of \$2,757,121 and to pay administrative expenses in the amount of \$74,524. The Plan did not utilize forfeited nonvested accounts during 2023 to reduce Company contributions or pay administrative expenses.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Plan investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interests in the collective trusts are valued at the NAV of units of the collective trusts. The NAV is used as a practical expedient to estimate fair value of the collective trust investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification by Plan Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are managed by Fidelity, which is the trustee of the Plan. Fees paid by the Plan to Fidelity for administrative services amounted to \$284,058 and \$264,844 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan to certain other providers for professional services amounted to \$151,584 and \$87,217 for the years ended December 31, 2024 and 2023, respectively. Such amounts are included, net, within Plan expense reimbursement/revenue credit and other, net on the statement of changes in net assets available for benefits. The Company provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such investments are classified within Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy.

**Note 7. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 8. Tax Status**

The Plan obtained its latest determination letter on July 12, 2024, in which the IRS stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the IRC and, therefore, not subject to tax. The Plan administrator believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Plan Amendments**

On July 14, 2023, the Plan was amended to i) allow active participants in the DSM North America Consolidated Pension Plan (Pension Plan) to elect a rollover of any lump-sum distribution to the Plan in connection with the Pension Plan termination; ii) to accept a transfer of surplus assets from the Pension Plan following its termination in accordance with the requirements of a “qualified replacement plan” under Section 7980(d) of the Internal Revenue Code; and iii) to provide for the eligibility of any active participants in the Pension Plan in defined contributions under the Plan until the earlier of the participants’ termination of employment or the exhaustion of any surplus assets transferred from the Pension Plan.

On December 15, 2023, the Plan was amended to provide for the merger of the First Choice Ingredients, Inc. 401(k) Profit Sharing Plan with and into the Plan effective as of the close of business on December 29, 2023, and to amend the cash out threshold under the Plan to reflect the provisions of the *Setting Every Community Up for Retirement Enhancement (SECURE) Act*.

**Note 11. Subsequent Events**

Subsequent events have been evaluated through August 14, 2025, which is the date the financial statements were available to be issued.

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the DSM North America Defined Contribution Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Note 1. Description of the Plan**

***General***

The following description of the DSM North America Defined Contribution Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by DSM North America, Inc. for the benefit of substantially all employees of the following affiliated companies (collectively, the Company):

- DSM North America, Inc.
- DSM Food Specialties USA, Inc.
- DSM Engineering Materials, Inc. (prior to March 31, 2023)
- DSM Nutritional Products, LLC
- DSM Biomedical, Inc.
- i-Health, Inc.
- Biomin America, Inc.
- Romer Labs, Inc.
- First Choice Ingredients, Inc.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan and serves as Plan custodian.

Effective December 29, 2023, the assets of the First Choice Ingredients, Inc. 401(k) Profit Sharing Plan, totaling \$9,108,450 were merged with and into the Plan. Of this amount, \$634,110 was received and recorded by the Plan in December 2023, and the remaining \$8,474,340 was received by the Plan in early January 2024 and was recorded as an other receivable on the statement of net assets available for benefits as of December 31, 2023.

***Contributions***

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover, Roth, after-tax and catch-up contributions are also permitted. For those employees not participating in or actively accruing a benefit under a defined benefit plan sponsored by the Company, the Company makes matching contributions of 100% of employees' salary deferral amounts, up to 4% of employees' compensation. For those employees participating or actively accruing a benefit under a defined benefit plan sponsored by the Company, the Company makes matching contributions of 100% of employees' salary deferral amounts, up to 3% of employees' compensation and 50% of employees' salary deferral amounts on the next 3% of employees' compensation. The Company makes a defined contribution of 4% of eligible compensation for those employees not participating in or actively accruing a benefit under a defined benefit plan sponsored by the Company. Contributions are subject to certain limitations. Forfeitures are used to reduce Company contributions or pay administrative expenses of the Plan.

***Participant Investment Account Options***

Each participant has the option of directing his or her contributions into any of the various investment options and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant makes an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 10%.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings, and is charged with an allocation of specific administrative expenses, as applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and employer matching contributions (excluding certain matching contributions transferred into the Plan from a prior plan as a result of merger, which are subject to separate vesting requirements), plus earnings thereon.

Vesting in the employer defined contribution account is based on years of continuous service. Such participants are generally fully vested after three years of continuous service. However, certain employer profit-sharing contributions that were transferred into the Plan from a prior plan, as a result of merger, are subject to differing vesting requirements with respect to employer contributions. The nonvested balances are forfeited upon termination of service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or for other reasons, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or installment payments.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,057,475 and \$2,525,821, respectively. These accounts will be used to reduce future Company contributions or pay administrative expenses of the Plan. During the year ended December 31, 2024, the Plan utilized forfeited nonvested accounts to reduce Company contributions in the amount of \$2,757,121 and to pay administrative expenses in the amount of \$74,524. The Plan did not utilize forfeited nonvested accounts during 2023 to reduce Company contributions or pay administrative expenses.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Plan investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interests in the collective trusts are valued at the NAV of units of the collective trusts. The NAV is used as a practical expedient to estimate fair value of the collective trust investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification by Plan Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are managed by Fidelity, which is the trustee of the Plan. Fees paid by the Plan to Fidelity for administrative services amounted to \$284,058 and \$264,844 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan to certain other providers for professional services amounted to \$151,584 and \$87,217 for the years ended December 31, 2024 and 2023, respectively. Such amounts are included, net, within Plan expense reimbursement/revenue credit and other, net on the statement of changes in net assets available for benefits. The Company provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such investments are classified within Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy.

**Note 7. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 8. Tax Status**

The Plan obtained its latest determination letter on July 12, 2024, in which the IRS stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the IRC and, therefore, not subject to tax. The Plan administrator believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Plan Amendments**

On July 14, 2023, the Plan was amended to i) allow active participants in the DSM North America Consolidated Pension Plan (Pension Plan) to elect a rollover of any lump-sum distribution to the Plan in connection with the Pension Plan termination; ii) to accept a transfer of surplus assets from the Pension Plan following its termination in accordance with the requirements of a “qualified replacement plan” under Section 7980(d) of the Internal Revenue Code; and iii) to provide for the eligibility of any active participants in the Pension Plan in defined contributions under the Plan until the earlier of the participants’ termination of employment or the exhaustion of any surplus assets transferred from the Pension Plan.

On December 15, 2023, the Plan was amended to provide for the merger of the First Choice Ingredients, Inc. 401(k) Profit Sharing Plan with and into the Plan effective as of the close of business on December 29, 2023, and to amend the cash out threshold under the Plan to reflect the provisions of the *Setting Every Community Up for Retirement Enhancement (SECURE) Act*.

**Note 11. Subsequent Events**

Subsequent events have been evaluated through August 14, 2025, which is the date the financial statements were available to be issued.
