To the Board of Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Aqua Engineers, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of the Aqua Engineers, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

- (1) **General** - The Plan is a defined contribution plan covering certain employees of Aqua Engineers, Inc. (Company) in the State of Hawaii (State). The Plan was initially effective on December 1, 1992 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (2) **Participation** - Employees become eligible to make elective deferrals and to receive discretionary matching and nonelective contributions upon their date of hire and once they have attained the age 18.
- (3) **Contributions** - Each year, participants may elect to defer up to 100% of pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company may make discretionary matching and nonelective contributions. For the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions of up to 2% of the participants' eligible compensation, as defined in the Plan. The Company made discretionary nonelective contributions of \$250,000 and \$200,000 during 2024 and 2023, respectively. Participants direct the investment of their contributions, Company contributions, and actual earnings thereon, into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.
- (4) **Participant accounts** - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- (5) **Vesting** - Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and nonelective contributions plus actual earnings thereon, is based on years of service. Benefits vest 20% annually commencing after one year with full vesting after six years of service.

NOTE A - DESCRIPTION OF PLAN (Continued)

- (6) **Notes receivable from participants** - Participants may borrow amounts from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.
- (7) **Payment of benefits** - In the event of a participant's retirement, disability, death, other termination of service, or the attainment of age 59½ years the participant (or, in the event of the participant's death, the participant's beneficiary) is entitled to receive the vested amounts credited to the participant's accounts. In-service distributions are allowed on vested amounts attributable to employee salary deferrals in the event that a participant has incurred a financial hardship and on amounts attributable to rollover contributions from another qualified plan. The amounts are based upon the value of such accounts as of the most recent valuation date before distribution.
- (8) **Forfeited accounts** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,788 and \$6,082, respectively. Forfeited matching contributions are used to reduce future employer matching contributions with any remaining amount used to reduce administrative expenses. Forfeited discretionary nonelective contributions are used to reduce future nonelective contributions, with any remaining amount used to reduce administrative expenses. During 2024 and 2023, forfeitures were used to reduce matching contributions by \$15,388 and \$20,930, respectively.
- (9) **Plan termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants affected by the termination shall become fully vested.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES

- (1) **Basis of accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting consistent with accounting principles generally accepted in the United States of America.
- (2) **Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

- (3) **Investment valuation and income recognition** - Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (4) **Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.
- (5) **Payment of benefits** - Benefits are recorded when paid.
- (6) **Administrative expenses** - Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.
- (7) **Subsequent events** - Plan management has evaluated subsequent events through August 6, 2025, the date on which the financial statements were available to be issued. There were no subsequent events that required adjustment of or disclosure in the financial statements.

NOTE C - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan can access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correction or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trusts: Valued at net asset value (NAV) per unit held by the Plan at year end. NAV of the collective investment trusts is based on the fair value of the underlying investments held by the collective investment trusts net of certain expenses and represents the price at which the Plan would be able to initiate a transaction. If the Plan were to initiate a full redemption of these collective investment trusts, the issuer reserves the right to require 12 months notification in order to ensure the securities liquidations will be carried out in an orderly business manner. As of December 31, 2024 and 2023, there were no unfunded commitments.

Pooled separate accounts: The pooled separate accounts held by the Plan each invest in a single mutual fund, which are valued at fair value. The net asset value of the pooled separate accounts represents the price at which the Plan would be able to initiate a transaction. The fair value of the underlying mutual funds is used to determine the net asset value of the pooled separate accounts.

NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (PLIC) totaling \$382,136 and \$346,869 as of December 31, 2024 and 2023, respectively. PLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by PLIC but may not be less than 1% or greater than 3%. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by PLIC, represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - TAX STATUS

On December 1, 2021, the Company adopted a PLIC 401(k) volume submitter plan. Effective July 1, 2023, the Company adopted a PLIC 401(k) Non-Standardized Pre-Approved Profit Sharing Plan. Principal received opinion letters from the Internal Revenue Service dated August 8, 2014 and June 30, 2020, specifying the form of the adoption agreements and that the basic plan documents satisfied, as of the date of the opinion letters, IRC Section 401. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

NOTE H - PARTY-IN-INTEREST TRANSACTIONS

Plan investments as of December 31, 2024 and 2023 include units of collective investment trusts and pooled separate accounts managed by companies affiliated with Principal Trust Company. Principal Trust Company is the trustee of the Plan assets. Accordingly, these transactions qualify as party-in-interest transactions.

Administrative fees paid to Principal Trust Company and its affiliates during the years ended December 31, 2024 and 2023 were \$15,698 and \$13,410, respectively.
