## **NOTE A-DESCRIPTION OF PLAN**

### **General**

Mathematical Research, Inc. DBA MRI Technologies, Inc. (the “Plan Sponsor” or the “Company”) adopted the MRI Technologies, Inc. 401(k) Plan (the “Plan”) effective January 1, 2023. The Plan has been amended throughout the subsequent years to comply with tax law and regulatory changes. The following brief description of the Plan, as amended, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan covering individuals who are employed by the Company. Employees who are at least 18 years old and have completed 2 months of service are eligible to make contributions under a salary deferral arrangement and can enter the Plan on the first day of the month following or coinciding with the date the eligibility requirements are met. Employees who are eligible and make contributions are eligible to receive employer matching contributions. The Plan can also make a discretionary nonelective contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

### **Trustee and administration**

The Plan’s assets are held by Reliance Trust Company (“Reliance Trust”), the trustee of the Plan, and are invested through participant-directed accounts in various mutual funds or other investments offered by the trustee. Duties of the trustee include, among others, recordkeeping, receiving and investing cash contributions and investment income, and making payments from the Plan funds as directed by the participants and the Plan administrator.

Administrative functions are performed by officers or employees of the Company. Certain administrative services and costs are incurred by the Company without cost to the Plan. No officer or employee of the Company receives compensation from the Plan.

### **Contributions**

Participants may make contributions to the Plan under a 401(k) salary deferral arrangement up to the maximum percentage (90%) of annual compensation, as defined by the Plan, and the dollar amount permitted under section 402(g) of the Internal Revenue Code not to exceed \$23,000 in 2024. Additionally, participants who are at least 50 years of age as of December 31, 2024, are permitted to make catch-up contributions up to \$7,500 for 2024. Participants are also allowed to contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company intends to make a discretionary matching contribution equal to 50% of each participant’s elective salary deferral not to exceed 6% of the participant’s compensation. The Company may also make discretionary non-elective contributions unrelated to employee contributions to the Plan. During 2024, the Company did not make any discretionary non-elective contributions.

### **Participant Accounts**

Each participant’s account is valued on a daily basis and credited with the participant’s contribution, his or her portion of the Company’s matching contributions and account earnings and is charged with applicable withdrawals and an allocation of certain administrative expenses as determined by the different investment options he or she directs the Plan asset custodian to make on his or her behalf. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Participant loans**

Under provisions of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms may not exceed five years. The loans are collateralized by the vested balance in the participants' accounts and bear interest at the prime rate plus 1%. Interest rates on participant loans outstanding as of December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest are repaid ratably through periodic payroll deductions.

**Forfeited Accounts**

Forfeitures consist of the non-vested portion of terminated participant account balances and may be used to reduce any administrative expenses and then reduce any future employer contributions. The forfeiture account balance totaled \$0 and \$10 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, employer contributions of \$354 were funded from the forfeiture account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon and entitled to 100% of their voluntary contributions. Participants are vested immediately in the Company discretionary matching and discretionary non-elective contributions as soon as they contribute.

**Payment of Benefits**

On termination of service, a participant who has a vested interest in their account that is less than or equal to \$5,000 shall receive a lump sum equal to the vested interest of their account. Participants who have a vested interest in their account which exceeds \$5,000 may elect to leave their account balance in the Plan or receive a lump sum payment, installment payments, or annuity payments equal to the vested interest of their account.

Under the terms of the Plan, participants who attain retirement age or become totally disabled prior to their retirement date will receive all amounts credited to their accounts. Upon the death of the participant while actively employed, the distribution is made in accordance with the participant's previous direction. All participants will receive their account balance in either a lump sum or in installments equal to the vested interest of their account.

**Investments**

Upon enrollment in the Plan, a participant may direct the allocation of their contributions and Company contributions among a range of investment funds approved by the Plan's sponsor. Each participant can choose to deposit all contributions in one fund or split the investment among the investment options in any whole percentages. The funds are invested in a broad range of stocks and bonds with varying risks. The allocation of investment income for each of the investment options is based on the ratio that each participant's account balance bears to the total balance of all eligible participants.

**Plan Expenses**

Some of the expenses of operating and maintaining the Plan have been paid by the Company. In the event the Company does not continue to pay the Plan expenses, the Plan expenses will be paid by the Plan and charged on a pro-rata basis to the value of the participants account balances.

## **NOTE B-SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”). Investments are presented at fair value in accordance with GAAP as prescribed for defined contribution plans.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Income Recognition**

The Plan presents in the statement of changes in net assets available for benefits the net appreciation or depreciation in the fair value of its investments, which consists of realized gains or losses and the unrealized appreciation or depreciation on those investments. Purchases and sales of securities are recorded on a settlement date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### **Investment Valuation**

Investments are reflected in the accompanying statements of net assets available for benefits at their estimated fair values. Fair value at December 31, 2024 and 2023, as determined by the Trustee, is based primarily on the quoted market prices of the underlying securities. Money market investments are valued at cost plus accrued earnings, which approximates fair value, as determined by the Trustee. Because of the inherent uncertainty of these valuations, the estimated values may differ from the actual fair values that may or may not be ultimately realized.

### **Administration Expenses**

Certain administrative expenses, including legal and accounting, are paid by the Plan Sponsor and, accordingly, are not reflected in the accompanying financial statements of the Plan. Certain transaction processing fees are charged to the participants and, therefore, are reflected in the accompanying statement of changes in net assets available for benefits as administrative expenses.

### **Payment of Benefits**

Benefits are recorded when paid.

## **NOTE C-INVESTMENTS**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- a. Investments, as shown in the Statements of Net Assets Available for Benefits, as of December 31, 2024 and 2023
- b. Investment activity, as shown in the Statement of Changes in Net Assets Available for Benefits, for the year ended December 31, 2024.
- c. The information in the supplemental schedule of assets (held at year end) as of December 31, 2024.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### **NOTE D-TAX STATUS**

The Plan document is based upon a prototype plan instrument from the Trustee, which received an IRS prototype letter dated October 6, 2020. The prototype plan instrument has been updated for legislative and regulatory changes. The Company's trustee believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **NOTE E-FAIR VALUE**

FASB ASC 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. Fair value measurements are based upon observable and unobservable inputs. Observable inputs reflect market data obtained from independent sources while unobservable inputs reflect the Plan's view of market assumptions in the absence of observable market information. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. In determining fair value, the Plan uses various methods including market, income and cost approaches.

The Plan categorizes its fair value measurements into a three-level fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Unadjusted quoted prices accessible in active markets for identical assets or liabilities at the measurement date and mutual funds where the value per share (unit) is determined and published daily and is the basis for current transactions.
- Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Unadjusted quoted prices for similar assets or liabilities in active markets or inputs (other than quoted prices) that are observable or that are derived principally from or corroborated by observable market data through correlation or other means. Primary inputs to this valuation technique may include comparative trades, bid/asks, interest rate movements, U.S. Treasury rates, London Interbank Offered Rate ("LIBOR"), prime rates, cash flows, maturity dates, call ability, estimated prepayments, and/or underlying collateral values.
- Level 3 – Unobservable inputs for the asset or liability. Prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. Inputs reflect management's best estimate about the assumptions market participants would use at the measurement date in pricing the asset or liability. Consideration is given to the risk inherent in both the method of valuation and the valuation inputs. Primary inputs to this valuation technique include broker quotes and comparative trades.

Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The following tables presents the assets and liabilities that are measured at fair value on a recurring basis by level within the fair value hierarchy as reported on the statements of net assets available for benefits at December 31, 2024 and 2023.

#### **Registered investment companies**

Registered investment companies are valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered level 1 investments.

#### **Common collective trusts**

Common collective trusts consist of stable value funds that are valued at fair value by the trustee based upon the net asset value of the underlying investments held by the Plan at year end.

#### **NOTE F-RELATED PARTY TRANSACTIONS**

The Company provided certain Plan administrative services without compensation during the year ended December 31, 2024. During 2024, the Plan paid \$43,611 for administrative fees and other charges to the Plan Trustee. Affiliates of the Plan Trustee manage the money market and mutual funds that constitute investment choices on the Plan.

#### **NOTE G-PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **NOTE H-RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment

securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

**NOTE I-SECURE ACT OF 2022**

The SECURE 2.0 Act of 2022 introduces several changes to qualified retirement plans, with various implementation dates ranging from 2023 to future years. Key provisions include enhanced catch-up contribution limits for participants ages 60-63 (effective 2025), requirements for higher-income participants to direct catch-up contribution to Roth accounts (effective 2026), increases to required minimum distributions from \$5,000 to \$7,000. The Plan Administrator is currently evaluating these changes to determine which options provisions may benefit plan participants. Any required amendments will be implemented by their respective deadlines, and participants will be notified of adopted changes that affect their accounts or options under the Plan.

**NOTE J-SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through August 19, 2025 the date financial statements were available to be issued. No subsequent events occurred which would require adjustment or disclosure to the financial statements as of December 31, 2024.
