INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Randall Brothers Holdings, Inc. Profit Sharing Plan & Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Randall Brothers Holdings, Inc. Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Randall Brothers Holdings, Inc. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

Note A

Description of Plan

The following description of the Randall Brothers Holdings, Inc. Profit Sharing Plan & Trust, formally known as Randall Brothers, Inc. Profit Sharing Plan & Trust, (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan was established on April 1, 1969 and has been amended and restated throughout the years to comply with tax regulations. The Plan was restated effective April 1, 2022 to comply with the IRS Cycle 3 restatement remedial amendment period. The Plan is a defined contribution plan covering eligible employees, except nonresident aliens and residents of Puerto Rico, of the Plan's sponsor, Randall Brothers Holdings, Inc. (the "Company"), who are at least 21 years of age and three months of service. The Plan is subject to requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Eligible participants may elect to defer up to 90% of their compensation either through pre-tax or Roth contributions, subject to the maximum amount allowed by the Internal Revenue Code. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Plan includes an automatic contribution arrangement where upon meeting eligibility requirements, employees will be automatically enrolled to participate in the plan at a deferral rate of 2% of compensation unless they affirmatively elect not to participate in the Plan, without automatic escalation. Automatic contribution arrangements are only applicable to employees who become eligible after January 1, 2020. Permissible withdrawals will be available to employees who become automatically enrolled for the first 90 days of enrollment. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Each year, the Company may make discretionary matching and profit sharing contributions. Participants must be employed on the last day of the plan year to receive the discretionary matching and profit sharing contributions. For the year ended December 31, 2024, discretionary matching contributions were equal to 25% of participant deferrals up to 4% of compensation.

Participant Accounts:

Each participant has an individual account that is credited with the participant's contributions, Company matching contributions, an allocation of Company profit sharing contributions, Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately and fully vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after two years of credited service.

Forfeited Accounts:

Upon termination of employment, participants forfeit their nonvested balances. Forfeited balances of terminated participants' nonvested accounts are used to reduce company contributions or pay reasonable Plan expenses. At December 31, 2024 and 2023, forfeited account balances totaled \$27,283 and \$24,696, respectively. During 2024, no forfeitures were used.

Payment of Benefits:

The vested value of a participant's account is payable upon termination, retirement, death or disability in a lump sum. Distributions are payable as soon as administratively feasible following the date on which a distribution is requested or otherwise payable. Certain in-service withdrawals are also allowed under the Plan.

Hardship Distributions:

Participants may be distributed up to 100% of their salary deferrals in the event of immediate and heavy financial need. In order to receive a hardship distribution, certain requirements and conditions must be satisfied.

Notes Receivable from Participants:

Participants may borrow from their accounts a minimum of \$500, and the maximum amount may not exceed one-half of the vested balance of the participant's account. No more than one note may be outstanding at any time. Note receivable terms cannot exceed 5 years, except that any loan used to purchase the participant's principal residence may be repaid over a period of 30 years from the date of the loan. The note is secured by the balance in the participant's account and will bear interest at the prime rate (as published by the Wall Street Journal) plus 2%. Principal and interest are paid ratably through payroll deductions.

Note B

Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note I for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Operating Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Notes Receivable from Participants:

Notes receivable participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Contributions:

Participant contributions and related Company matching contributions are recognized in the period the participant contribution is withheld from compensation.

Payment of Benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Use of Estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events:

The Plan has evaluated subsequent events through August 19, 2025, the date the financial statements were available to be issued.

Note C
Excess Contributions

Benefit distributions for the plan year ended December 31, 2024 and 2023 include payments of \$5,999 and \$16,942, respectively, made to participants to return to them excess contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. These amounts are also included in the plan's statements of net assets available for benefits as excess contributions payable at December 31, 2024 and 2023. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and March 15, 2024, respectively.

Note D
Related Party Activity

Certain Plan investments are shares of investments managed by Reliance Trust Company. Reliance Trust Company is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. ADP, Inc. is the recordkeeper and third party administrator of the plan and received direct fees from the Plan totaling \$3,601 for these services. Advisory fees of \$11,876 were paid to Merrill Lynch Pierce Fenner & Smith, the Plan's advisor. These transactions are exempt from being prohibited transactions by ERISA. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note E
Information Certified by the Custodian of the Plan

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participant held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the custodian of the Plan).

Note F
Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note G
Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan, subject to Plan provisions. Upon such termination, participants will become fully vested in their accounts, which will be distributed as prescribed by the Plan terms.

Note H

Income Tax Status

Effective April 1, 2022, the Plan was formally amended to adopt the pre-approved defined contribution plan sponsored by ADP, LLC. The pre-approved plan provider has received an opinion letter from the Internal Revenue Service dated October 6, 2020, as to the pre-approved plan's qualified status. The pre-approved plan advisory letter has been relied upon by the Plan. The Plan has been amended since the pre-approved plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years in progress.

Note I

Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three Levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as quoted by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
