NOTES TO FINANCIAL STATEMENTS

Years Ended December 31, 2024 and 2023

A. DESCRIPTION OF PLAN

The following description of the Stork H&E Turbo Blading, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Stork H&E Turbo Blading, Inc. (“Company”) and is part of the controlled group of Bilfinger. Employees are eligible to contribute immediately upon beginning employment and are immediately eligible for the Company match contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Fiduciary Committee is responsible for the governance of the Plan.

Contributions: Each year, participants may contribute a whole percentage of pretax annual compensation, as defined in the Plan (“elective deferrals”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company has elected a stated tiered match contribution. The Company matches 100% of each employee elective deferrals up to 3% of the employee’s base compensation and contributes 50% of elective deferrals which are over 3% of the base compensation, not to exceed 5% of the base compensation.

The Company has the option to make additional discretionary contributions to the Plan.

Participants may direct the investment of their contributions and the Company’s contribution into various investment options offered by the Plan. The Plan currently offers various mutual funds, collective trusts, and a stable value fund as investment options for participants. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts: Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, the Company’s discretionary contribution, an allocation of Plan earnings (losses), and charged with administrative expenses as applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their voluntary contributions and in the Company contribution plus actual earnings thereon.

Notes Receivable from Participants: Participants may borrow from their accounts, a minimum of \$1,000 up to a maximum equal to the lesser of (a) 50% of their vested account balance reduced by any outstanding loan balance or (b) \$50,000 reduced by the highest

outstanding loan balance during the one-year period ending on the day before the loan is made. The number of outstanding loans for a participant is limited to two, and the number of loans approved in any twelve-month period is limited to three. The term of each loan is generally limited to five years, but is limited to fifteen years for the purchase of a principal residence. Loans are secured by the balance in the participant's account and bear an interest rate equal to the Prime rate, as published by the Wall Street Journal, plus 1%. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits: Upon termination of service, death, disability, or retirement (age 65), a participant may elect to receive either a single-sum payment equal to the value of the participant's vested interest in his or her account, a fixed period installment option, or a fixed payment installment option. The Plan allows for in-service withdrawals if a participant reaches age 59^{1/2} and hardship distributions subject to Plan provisions.

Forfeited Accounts: Participants are immediately 100% vested in their accounts. Therefore, there are no forfeited accounts.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates and Assumptions:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition:

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis.

Benefit Payments:

Benefit payments are recorded when paid.

Administrative Expenses:

Certain administrative expenses of the Plan are paid directly by the Company.

C. INVESTMENTS (UNAUDITED)

The investment activities and balances included on the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statements of Changes in Net Assets Available for Benefits for the years then ended, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the trustee, Principal Trust Company, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$11,840,245 and \$11,544,086 and participant loans in the amount of \$453,461 and \$435,991 at December 31, 2024 and 2023, respectively, and related investment income of \$1,035,252 and \$1,330,172, respectively, and interest on participant loans of \$31,016 and \$28,504, respectively, for the years then ended.

D. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Mutual funds are quoted daily at publicly available prices, based on the market value of its underlying investments. Mutual funds are deemed to be actively traded.

Common Collective Trust Funds: Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

PARTY-IN-INTEREST TRANSACTIONS

Principal Trust Company, a member of the Principal Financial Group, is the trustee as defined by the Plan. Certain Plan investments are managed by the trustee or other affiliated companies.

Administrative services are offered through the trustee and affiliated companies of the trustee. Certain fees incurred by the Plan for the investment management services are included in investment income.

All of these transactions qualify as exempt party-in-interest transactions under ERISA.

E. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

F. TAX STATUS

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the form of the Plan was acceptable under the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan has annual regulatory filing requirements to the Department of Labor (“DOL”) of the Form 5500.

G. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

H. SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 19, 2025, the date when the financial statements were available to be issued, and no events required disclosure.
