Appendix A – Summary of Principal Plan Provisions(cont.)

Regular Benefit Amount: The normal retirement benefit is equal to 10% of a participant's average monthly compensation multiplied by their credited service up to maximum 10 years of service.

Average monthly earnings mean the average compensation paid during the 3 consecutive plan year period in the final 10 years of employment which produces the highest average.

Termination Benefit Amount: A terminating participant who has completed two year of service is entitled to receive a vested monthly benefit starting on his normal retirement date. The amount of the benefit is equal to a percentage of the Normal Retirement Benefit based on the vesting schedules.

If date of participation before May 1, 2022, then immediately 100% vested. Effective December 31, 2024, all benefits are vested.

Disability Amount: N/A

Pre-Retirement Death Benefit Amount: If a participant dies prior to the time his benefit payments commence, a qualified preretirement survivor annuity shall be provided to the participant's beneficiary equal to the actuarial equivalent of the participant's accrued benefit.

Post-Retirement Death Benefit Amount: None except as provided by the annuity form elected.

Normal Form of Benefit: The normal form is a monthly income payable as Life Annuity.

Married participants receive a fully subsidized joint and survivor annuity. This option provides a 50% continuation that is payable to a surviving spouse if the participant predeceases the spouse.

Optional Forms of Payment: Benefits which are actuarially equivalent to the normal form may be paid in alternative forms, if approved by the participant and spouse:

- Life annuity.
- 60 or 120 months Certain and Life Annuity.
- 50%, 66 2/3%, 75% or 100% Joint and Survivor
- Single Lump Sum

Changes Since Last Year: Benefit accruals cease December 31, 2024. All benefits are vested. Plan is terminated effective December 31, 2024.
