Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule of assets held at end of year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### **NOTE A - Description of Plan**

##### **General**

TF Cornerstone Inc. 401(k) Plan (the "Plan") was established effective January 1, 1988 as a defined contribution 401(k) plan for the exclusive benefit of all full-time nonunion employees, except for contract laborers and rental agents of TF Cornerstone Inc. (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2016, the Plan adopted the prototype basic plan of Schwab Plan Retirement Services, Inc. and the Plan trustee became Charles Schwab Bank.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and earnings and allocations of the Company's contribution, all of which are participant directed. Forfeited balances of terminated participants' non-vested accounts attributed to the Company's matching contributions and discretionary profit sharing contributions are used to reduce both the Company's matching contributions and discretionary profit sharing contributions for the Plan year in which the forfeitures become available. The Plan must maintain forfeited non-vested accounts until the earlier of vested distribution payments to the terminated participant or five years from termination of employment for those participants who do not elect distributions. As of December 31, 2024 and 2023, the balance of unallocated forfeited non-vested accounts totaled \$37,765 and \$26,064, respectively.

##### **Contributions**

Participants must be at least 20 years of age, have more than three months of service with the Company and may contribute up to 100% of their annual compensation, which cannot exceed the maximum allowable under the Internal Revenue Code which is currently \$23,000 for participants under age 50 and \$30,500 for those over 50. The Company makes a matching contribution equal to 50% of each participant's eligible contributions for the Plan year, which contributions may not exceed 6% of the participant's eligible compensation for the Plan year. A matching contribution of \$1,118,998 was authorized for the year ended December 31, 2024 against which forfeitures of non-vested accounts of \$37,765 was applied. The Company can also make a discretionary profit sharing contribution, which is determined by the Company's board of directors. No discretionary profit sharing contribution was authorized for the year ended December 31, 2024.

In order to be eligible for the employer matching and profit sharing contributions, a participant must be an employee of the Company at December 31, except for employees who have retired, or have become deceased, or disabled. The discretionary profit sharing contribution is allocated in the ratio that the participants' compensation bears to all eligible participants' compensation.

NOTES TO FINANCIAL STATEMENTS

**NOTE A - Description of Plan (Continued)**

**Contributions (Continued)**

The Plan includes a qualified automatic contribution arrangement, pursuant to which all eligible employees are enrolled automatically with a 4% tax-deferred contribution rate unless the employee elects otherwise. These contributions are invested in the Plan's default investment option unless the employee makes a different investment election. The default investment option is the Schwab Retirement Planner. Employees may opt out of the automatic enrollment, stop contributions, modify their contribution rate or type, or change their investment elections at any time. Starting the first year after a participant is automatically enrolled in the Plan, the participant's tax-deferred contribution rate is automatically increased by 1% annually, up to a maximum of 10%. This occurs with the first payroll period in January of each year, and participants may decline these rate increases or elect a different rate.

**Vesting**

Participants are immediately vested in their contribution. Effective January 1, 2016, the Company's matching and profit sharing contributions, plus the earnings thereon, vest according to the schedule below:

The Company adopted the elapsed time method for determining years of vesting service. This method of counting service does not track actual hours of service worked by an employee, but instead measures the length of time an individual is an employee of the Company. However, upon the participant's death, disability or attainment of age 65, all amounts are immediately vested.

#### **NOTE A - Description of Plan (Continued)**

##### **Participant Loans**

Participants may borrow from their account a minimum of \$1,000 and up to an amount equal to 50 percent of their pre-tax elective deferral account and rollover account. However, outstanding loans under the Plan cannot exceed the lesser of 50% of the vested balance or \$50,000 per participant. Loans, which are evidenced by a negotiable promissory note, bear interest at a rate reasonable and comparable to the rates being charged by representative commercial banks fixed at the date of the loan. Repayment must be made in level payments over a period not to exceed five years, unless the loan qualifies as a home loan in which case the repayment period is not to exceed twenty years. Participant loans are carried at their unpaid principal balance plus any accrued but unpaid interest.

##### **Withdrawals**

A participant may withdraw an amount not in excess of the amount attributable to the participant's vested amount, subject to an Internal Revenue Service early withdrawal penalty if made before the participant attains 59 ½ years of age.

##### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant is to receive the vested value of their account in either a lump sum, if the account balance is less than \$5,000, or at the participant's discretion, on an installment basis or a lump sum, if the account balance is greater than \$5,000.

##### **Termination of Plan**

In the event of the termination of the Plan, after payment of administrative expenses, if any, the trust fund shall be used for the exclusive benefit of Plan members and their beneficiaries and for no other purpose.

#### **NOTE B - Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

##### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **NOTE B - Summary of Significant Accounting Policies (Continued)**

##### **Valuation of Investments**

The Plan's investments are stated at fair value. Shares of mutual funds are valued by the trustee of the Plan at the net asset value of shares held by the Plan at year end based on quoted market values.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Participant Loans**

Participant loans are carried at their unpaid principal balance plus any accrued but unpaid interest. Interest rates on outstanding loans ranged from 4.25% to 10.25% during 2024. As of December 31, 2024, the due dates on the outstanding loans range from one month to seventeenth years. Delinquent participant loans are reclassified as distributions upon the terms of the Plan document.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Tax Status**

The Internal Revenue Service has issued a determination letter stating that a prototype plan from which the Plan was derived meets the requirements of Section 401(a) of the Internal Revenue Service Code (IRC) qualifying for tax-exempt status. Therefore, a specific determination letter for the Plan has not been applied for or obtained.

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

##### **Subsequent Events**

The Company has considered subsequent events occurring through August 18, 2025, the date the financial statements were available for issuance, in evaluating its estimates and in the preparation of its financial statements.

#### **NOTE C - Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

The FASB ASC 820 standard on "*Fair Value Measurements*" establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 is observable information for similar items in active or inactive markets, and Level 3 inputs are unobservable inputs to be used in situations where markets don't exist or are illiquid. Level 3 has the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered Level 1 investments.

Self-directed brokerage accounts: Accounts primarily consists of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

**NOTE E - Party-In-Interest Transactions**

Certain Plan investments are managed by Charles Schwab Bank, the Plan's investment trustee, and, therefore, these transactions qualify as party-in-interest transactions. However, they are exempt from the prohibited transactions rules under ERISA. The fair value of such investments aggregated \$18,363,189 and \$19,624,870 as of December 31, 2024 and 2023, respectively. Fees paid by the Plan for the investment management services are netted against net appreciation in the fair value of investments.

ERISA's definition of party-in-interest includes employees. Participant loans to employees are also specifically exempted from the ERISA prohibited transaction rules. The value of participant loans was \$538,805 and \$269,485 as of December 31, 2024 and 2023, respectively.

**NOTE F - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
