NOTE A - DESCRIPTION OF PLAN

The following description of the Richards Manufacturing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, and adoption agreement for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution plan was established on January 9, 1993, previously named Electronic Technology Incorporated Savings and Investment Plan, and was amended and restated on July 1, 2022, to merge Bleema Manufacturing Corporation Employees' 401(k) Retirement Plan and Chardon Custom Polymers, LLC 401(k) Profit Sharing Plan and Trust and renamed to Richards Manufacturing 401(k) Plan. The Plan was established pursuant to the provisions of Section 401(k) of the Internal Revenue Code (the Code), covers all eligible employees, as defined, of Richards Manufacturing Co. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Employees are immediately eligible to participate in the Plan for the purposes of making employee elective deferral contributions up to the maximum permitted under the Code.

Eligibility

Employees are eligible to participate in the Plan on the date of hire. Eligible employees are eligible to make participant contributions and receive discretionary matching contributions from Plan Sponsor if and to the extent specified in the applicable adoption agreement or otherwise provided by the Plan.

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined, into the Plan, up to the maximum allowed under the Code. For 2024, the maximum deferral limit for a participant's pre-tax and/or Roth after tax contributions was \$23,000. Participants who have attained age 50 before the end of a Plan year are eligible to make catch up contributions. For 2024, the maximum pre-tax and/or Roth catch up contribution was \$7,500. Participants may also make rollover contributions to the Plan from other qualified plans, individual retirement accounts and annuities. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions equal to a uniform percentage or dollar amount of the participants' elective deferrals each payroll period. For the year ended December 31, 2024, the Company elected to make discretionary matching contributions equal to 50% of the participant's elective deferral, not to exceed 6% of compensation.

The Company may also make nonelective contributions. The contribution is discretionary and the Company, in its sole discretion may determine the amount of the contribution. There were no nonelective contributions in 2024.

Participant Accounts

Each participant's account is credited with the participant's elective deferral contributions, Company discretionary matching contributions, true up match contributions, the nonelective contribution, Plan earnings and an allocation of certain expenses, where applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account and any related earnings into the various investment options offered by the Plan. Participants may make transfers between existing funds and change their investment options on a daily basis as permitted by the selected investment. Participant accounts are valued daily.

Notes Receivable from Participants

Participants may borrow from the vested portion of their account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms are fixed up to five years, except in the case of a loan used to acquire a principal residence, in which case the loan term will be established by the Plan Administrator at the time of the loan. The loans are secured by the vested balance in the participant's account and bear interest at a reasonable rate at the time of the loan, generally 1% above the prime rate. Principal and interest are paid ratably through payroll deductions. A participant can only have one loan currently outstanding from the Plan.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching & nonelective contribution portion of their accounts will be 100% vested after 90 days of service. Notwithstanding the above, all participants are fully vested upon retirement, death, or permanent disability.

Forfeitures

Forfeitures in any year from the accounts of participants whose employment with the Company has terminated shall be used in the following year to pay plan expenses, allocate as an additional discretionary nonelective contribution, allocate as an additional discretionary matching contribution, reduce any nonelective contribution, or to reduce any matching contribution. The forfeited non-vested accounts as of December 31, 2024 and 2023 were \$22,189 and \$13,720, respectively. There were no forfeitures used in 2024.

Payment of Benefits

Upon separation of employment due to termination of employment, death, disability or retirement, participants may, at their election, withdraw their benefits or maintain their vested balance in the Plan. If the value of a separated participant's vested balance is less than \$5,000, vested portions will be distributed to the participant in a lump sum payment. Participants are permitted certain in-service withdrawals from their accounts for financial hardships, attaining age 59½ or are disabled. Participants, at any time, may also withdraw amounts attributable to their after-tax contributions, rollover contributions and/or any portion of their transferred balance that is available under a grandfathered withdrawal option.

Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are presented in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) and were prepared using the accrual basis of accounting.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and change therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in a separate pooled account are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net depreciation/appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan basic plan document and participant loan program.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Certain expenses incurred in connection with general administration services are allocated to participants pro-rata based on the ratio of the participant individual account balance to the total of all account balances.

NOTE C - INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Plan's custodian, Voya Retirement Insurance and Annuity Company ("Voya"), has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, investments at contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the assets measured at fair value.

Pooled Separate Account - Valued at the net asset value (NAV) provided by the administrator of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Redemption frequency for the Pooled Separate Accounts is immediate, the Pooled Separate Accounts contain no unfunded commitments and have no redemption restrictions.

All of the Plan's investments are valued at NAV as practical expedient, therefore, there are no investments that are required to be included in the fair value hierarchy.

NOTE E - GUARANTEED INVESTMENT CONTRACT WITH VOYA

Plan assets include a fully benefit responsive guaranteed investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$4,039,171 and \$4,283,152, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a semiannual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestitures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE F - INCOME TAX STATUS

The Plan has adopted a Defined Contribution Pre-Approved Plan sponsored by Prime Pensions, Inc. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related accounts are tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan holds a group annuity contract issued by Voya, the Custodian and the Plan's recordkeeper. These transactions qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions. Notes receivable from participants also qualify as permitted party-in-interest transactions under ERISA.

NOTE H - SUBSEQUENT EVENTS

Plan management has evaluated the financial statements for subsequent events through August 15, 2025, the date the financial statements were available to be issued. Management is not aware of any subsequent events that would require recognition or disclosure in the financial statements.
