NOTE A - DESCRIPTION OF PLAN

The following description of Educator Solutions 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2019. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) covering substantially all employees of ESI Technical Co. dba Educator Solutions Inc. (the Company and Plan Sponsor) who are age 18, have met the service requirement of one month of service using the elapsed time method, and are not collectively bargained employees, nonresident aliens, or highly compensated employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan document effective January 1, 2019 originally excluded certain positions from being eligible to participate in the Plan. On November 25, 2024, the Plan was retroactively amended to remove all exclusions effective through August 1, 2024, pursuant to the self-correction program under the Employee Plan Compliance Resolution System (EPCRS). The retroactive amendment was made effective January 1, 2019.

On October 1, 2024, the Company made the decision to change its service providers. Effective November 6, 2024, the Company entered into an agreement with Voya Retirement Insurance and Annuity Company (VRIAC) for recordkeeping, third-party administration, and investment advisory services. The assets of the Plan were transferred from John Hancock Life Insurance Company (U.S.A.) (John Hancock) to VRIAC through two transfers on December 26, 2024 and December 30, 2024. As of December 31, 2024, the assets were in a holding account with VRIAC.

Amendments

Effective May 28, 2024, the Plan was amended to remove the eligible automatic contribution arrangement.

Effective August 1, 2024, the Plan was amended to exclude certain employees as follows: Per diem employees and substitutes; Before and After Care Program Counselor; Community Engagement Coordinator; ESE Administrative Assistant; Jeweler; Licensed Mental Health Therapist; Lunchroom Monitor; Sales Associate; School Counselor I; Staff Accountant; Student Discipline Coordinator; Substitute Operations Assistant; Data Specialist.

Contributions

Participants may elect to contribute on a pre-tax basis or after-tax (Roth) basis up to the maximums allowed by law. Effective through May 27, 2024, certain participants, as defined in the Plan document, were automatically enrolled in the Plan to contribute 5% of pre-tax compensation each pay period on the first day of the month after or coinciding with the date the eligibility requirements were met unless the participant made an affirmative election. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

#### NOTE A - DESCRIPTION OF PLAN (CONTINUED)

##### Contributions (continued)

The Company may make discretionary matching contributions. For the years ended December 31, 2024 and 2023, the Company elected to match 100% of participant contributions between 3.00% and 4.50% of compensation each pay period for certain employee groups. Participants direct the investment of their Company contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company discretionary matching contributions, if any, and an allocation of Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are vested immediately in their contributions, the Company discretionary matching contributions, if any, and actual earnings thereon.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. Participant loans are secured by the balance in the participant's account and bear interest at a rate equal to the prime interest rate plus 2%. Principal and interest are paid ratably through payroll deductions.

##### Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Hardship withdrawals are permitted by the Plan. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 ½. Benefit payments are made in the form of lump sum distributions. Participants who terminate employment with a balance of less than \$1,000 may receive an automatic lump sum distribution of their balance. Effective January 1, 2024, participants who terminate employment with a vested balance of less than \$7,000, but more than \$1,000, may receive an automatic rollover of their balance into an individual retirement account (IRA). Effective through December 31, 2023, participants who terminated employment with a vested balance of less than \$5,000, but more than \$1,000, may have received an automatic rollover of their balance into an IRA.

##### Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. Forfeitures may be used to pay Plan expenses or reduce future employer contributions. There was no forfeiture balance as of December 31, 2024 and 2023. No forfeitures were used during the years ended December 31, 2024 and 2023.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

##### Contributions

Contributions from Plan participants and the Company discretionary matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

##### Payment of Benefits

Benefits are recorded when paid.

##### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for recordkeeping services, investment advisory, and third-party administration are included in administrative expenses and allocated to participant accounts based on a pro rata formula. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses.

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Due to the change in service providers, there was a change in the Plan's investment offerings which resulted in a change in valuation methodologies used as of December 31, 2024 due to the values being readily determinable. The Plan assets were held in a pooled separate account investment as of December 31, 2024, due to the timing of the transfer of assets to VRIAC and the blackout period. The following is a description of the valuation methodology used to measure the asset at fair value as of December 31, 2024:

*Pooled separate account:* The pooled separate account is measured at the net asset value (NAV) per share of the underlying fund held in the separate account on a daily basis. The value is readily determinable. There are no redemption restrictions. There are no unfunded commitments.

The following is a description of the valuation methodology used for assets measured at fair value as of December 31, 2023:

*Pooled separate accounts:* Pooled separate accounts are valued at the NAV based on units of the pooled separate accounts. The NAV is used as a practical expedient to estimate fair value. The redemption frequency is daily and there are no redemption restrictions. There are no unfunded commitments related to the Plan's investments in the pooled separate accounts.

The investments measured at NAV per share (or its equivalent) as a practical expedient as of December 31, 2023 are not classified in the fair value hierarchy. The Plan did not hold any investments that were required to be disclosed in the fair value hierarchy table as of December 31, 2023. The table as of December 31, 2023 has been omitted from these financial statements.

#### NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### NOTE F – TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan which obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan is designed in accordance with the applicable requirements of the IRC. While the Plan has been amended since receiving the opinion letter, the Plan sponsor believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Definiti LLC was the third-party administrator for the Plan during the year ended December 31, 2023 and for the period from January 1, 2024 through November 5, 2024. VRIAC became the third-party administrator and recordkeeper for the Plan on November 6, 2024. John Hancock Life Insurance Company (U.S.A.) was the trustee and recordkeeper for the Plan during the year ended December 31, 2023, and for the period from January 1, 2024 through December 30, 2024, which was the date the Plan assets were completely transferred to VRIAC.

Wilshire Associates Inc (USA) was the investment advisor for the Plan during the year ended December 31, 2023 and for the period from January 1, 2024 through November 5, 2024. Voya Retirement Advisors, LLC, an affiliate of VRIAC, became the investment advisor on November 6, 2024.

Fees paid to the service providers have been included in administrative expenses. The transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Certain investments held by the Plan were managed by VRIAC and John Hancock and, therefore, are party-in-interest transactions. The transactions are exempt from the prohibited transaction rules.

Notes receivable from participants and related interest income also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

#### NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE I – PLAN CORRECTIONS DUE TO OPERATIONAL FAILURE

During the 2023 Plan audit, an operational failure was discovered related to the improper exclusion of certain eligible employees from participation in the Plan. The operational failure impacted the Plan years ended December 31, 2024, 2023, 2022, 2021, 2020, and 2019. A corrective contribution was quantified by the Company to correct the missed deferral opportunities in accordance with IRS regulations. The corrective contribution, which includes the qualified non-elective contributions (QNEC), the employer match, and lost earnings totaled \$20,549 and \$69,932 for the years ended December 31, 2024 and 2023, respectively.

As of December 31, 2023, an other employer contribution receivable of \$69,932 was recorded, which was made up of the QNEC and employer match owed to the Plan for the corrections related to the Plan years ended December 31, 2023, 2022, 2021, 2020, and 2019. The corrective contribution was funded during the year ended December 31, 2024. As of December 31, 2024, an other employer contribution receivable of \$6,622 was recorded for the corrections related to the Plan year ended December 31, 2024. The amount was funded in 2025.

#### NOTE J – DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2024, the Company failed to remit participant contributions and loan repayments within the time period required by regulations, which is a prohibited transaction. The late remittances totaled \$1,683, which includes participant contributions and loan repayments. The Company corrected the delinquent participant contributions in 2025 in accordance with regulations.

#### NOTE L – SUBSEQUENT EVENTS

Effective May 1, 2025, the Plan amended its excluded eligible employees list to remove the Staff Accountant and Executive Assistant positions.

The Plan has evaluated subsequent events for recognition and disclosure through August 20, 2025, the date the financial statements were available to be issued.
