NOTE A – Description of Plan

The following brief description of the Poteat, Inc. Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all full-time employees of Poteat, Inc. (the Company) who have completed one year of service, have worked 1,000 hours during the 12-month period, and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Contributions to the Plan include (a) salary reduction contributions authorized by participants, (b) matching contributions made by the Company, (c) profit sharing contributions made at the discretion of the Company's management, and (d) participant rollovers from another qualified plan. Each year, participants may contribute on a pre-tax basis a portion of their annual compensation up to the maximum allowed by current IRS regulations. The Company contributes a matching amount based on 100 percent of employee contributions up to 4 percent of the participant's compensation. An employee who is age 50 or older may make a catch-up contribution as defined by IRS regulations.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Employer's contribution in participants accounts are immediately vested in safe harbor matching contributions money type plus actual earnings thereon. Employer's contribution in participants accounts are vested in the Company's Employer Profit Sharing contribution money type is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of half of their account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates 2 percent above prime rate. Principal and interest is paid ratably through monthly payroll deductions. All loans must generally be repaid within five years.

Payment of Benefits. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of time not more than the participant's assumed life expectancy determined at the time of distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts. Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Such forfeitures can be applied to reduce employer contributions or Plan administrative expenses otherwise payable by the Company. In 2024, forfeited non-vested amounts totaled \$0.

The financial statements of the plan are prepared on the modified cash basis of accounting which is a comprehensive basis of accounting other than generally accepted accounting principles. Modified cash basis of accounting is defined as cash basis accounting that adjusts securities investments to fair value.

Use of Estimates. The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value instruments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits. Benefit payments to participants are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative fees are charged directly to the participant's account and are included in administrative costs.

Subsequent Events. Management has evaluated subsequent events through July 21, 2025, the date of which the financial statements were available to be issued.

NOTE C – Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. John Hancock Life Insurance Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments, related investment activity, and related activity in the accompanying statements of net assets available for benefits for the years ended December 31, 2024 and 2023, the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 and accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE D – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB Statement ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include –

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E – Related Party Transactions and Party In Interest Transactions

Certain Plan investments are shares of mutual funds managed by John Hancock Life Insurance Company, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services for the year ended December 31, 2024 amounted to \$3,947. Other fees related to the Plan's operations are paid directly by the Plan Sponsor.

The Plan's financial statements are audited on an annual basis. Fees paid to the Plan's auditor qualify as party-in-interest transactions. Fees paid to the Plan's auditor for the year ended December 31, 2024 totaled \$10,500.

NOTE F – Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE G – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated January 1, 2022, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

NOTE I – Fidelity Bond Requirement

The Plan is required to maintain a Fidelity Bond, which covers every fiduciary, and/or individual of an employee benefit plan who handles funds or other property of the Plan. Fidelity Bond coverage protects the Plan from any losses resulting from mishandling or misappropriation of the Trust assets. The amount of the Fidelity Bond must be at least 10 percent of the value of all Trust assets up to a maximum of \$500,000 of coverage, unless the Plan holds non-qualifying assets (i.e. assets held outside a funding institution). Based on the plan assets reported, the current level of coverage does meet the requirements.

NOTE A – Description of Plan

The following brief description of the Poteat, Inc. Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all full-time employees of Poteat, Inc. (the Company) who have completed one year of service, have worked 1,000 hours during the 12-month period, and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Contributions to the Plan include (a) salary reduction contributions authorized by participants, (b) matching contributions made by the Company, (c) profit sharing contributions made at the discretion of the Company's management, and (d) participant rollovers from another qualified plan. Each year, participants may contribute on a pre-tax basis a portion of their annual compensation up to the maximum allowed by current IRS regulations. The Company contributes a matching amount based on 100 percent of employee contributions up to 4 percent of the participant's compensation. An employee who is age 50 or older may make a catch-up contribution as defined by IRS regulations.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Employer's contribution in participants accounts are immediately vested in safe harbor matching contributions money type plus actual earnings thereon. Employer's contribution in participants accounts are vested in the Company's Employer Profit Sharing contribution money type is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of half of their account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates 2 percent above prime rate. Principal and interest is paid ratably through monthly payroll deductions. All loans must generally be repaid within five years.

Payment of Benefits. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of time not more than the participant's assumed life expectancy determined at the time of distribution. Forfeited Accounts. Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Such forfeitures can be applied to reduce employer contributions or Plan administrative expenses otherwise payable by the Company. In 2024, forfeited non-vested amounts totaled \$0.

NOTE D – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB Statement ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include –

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E – Related Party Transactions and Party In Interest Transactions

Certain Plan investments are shares of mutual funds managed by John Hancock Life Insurance Company, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services for the year ended December 31, 2024 amounted to \$3,947. Other fees related to the Plan's operations are paid directly by the Plan Sponsor.

The Plan's financial statements are audited on an annual basis. Fees paid to the Plan's auditor qualify as party-in-interest transactions. Fees paid to the Plan's auditor for the year ended December 31, 2024 totaled \$10,500.

NOTE F – Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE G – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated January 1, 2022, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

NOTE I – Fidelity Bond Requirement

The Plan is required to maintain a Fidelity Bond, which covers every fiduciary, and/or individual of an employee benefit plan who handles funds or other property of the Plan. Fidelity Bond coverage protects the Plan from any losses resulting from mishandling or misappropriation of the Trust assets. The amount of the Fidelity Bond must be at least 10 percent of the value of all Trust assets up to a maximum of \$500,000 of coverage, unless the Plan holds non-qualifying assets (i.e. assets held outside a funding institution). Based on the plan assets reported, the current level of coverage does meet the requirements.
