Dear Sir or Madam:

I am writing in response to the IRS notice dated July 28, 2025, assessing penalties for the late filing of Form 5500-SF for the plan year ending December 31, 2023.

We respectfully request abatement of the penalties based on **reasonable cause**. The late filing was not due to willful neglect, but rather to circumstances beyond our control. Specifically, we switched third party administrators as of 1/1/2024. There was a miscommunication between third party administrators as to who was handling the 12/31/2023 Form 5500-SF filing. Once the issue was discovered, we acted promptly to complete and file the 12/31/2023 return.

We have taken corrective action to prevent this from recurring, including confirming with the new and current third-party plan administrator the filing of the Form 5500-SF for future years going forward. We have submitted the 12/31/2023 Form 5500-SF as well.

Because ordinary business care and prudence were exercised under the circumstances, we respectfully request the IRS abate the penalties under its reasonable cause provisions.
