To the Trustees and Participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Central Supply Company, Inc. Employees' Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, Vanguard Fiduciary Trust Company, as of April 30, 2024 and 2023 and from Ascensus Trust Company, as of December 31, 2024, and for the periods and years then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

INDEPENDENT AUDITOR'S REPORT - Continued

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The following description of the Central Supply Company, Inc. Employees' Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established to provide for the retirement of Central Supply Company, Inc. (the "Company") employees. The Plan is a defined contribution plan covering all employees of the Company who have completed six months of service and are at least 20 years of age. Employees subject to collective bargaining agreements will be eligible only if their bargaining unit has negotiated with the Company and they are not covered under another retirement plan sponsored by the Union. The Plan entrance dates are January 1st, April 1st, July 1st, and October 1st. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contribution, and investment earnings. In addition, participants who are employed at year-end with at least 1,000 hours worked are credited with a discretionary profit sharing contribution. The benefit to which a participant is entitled is that participant's vested account balance.

Vesting

A participant is 100% vested in the value of his or her accumulated voluntary contributions at all times. A participant is considered fully vested in the Company's matching and profit sharing contributions after three years.

Contributions

Participants may contribute to the Plan subject to limits imposed by Federal tax law. The Plan includes automatic enrollment for all eligible employees who are not contributing participants. The initial amount of the automatic Elective Deferral is 3% of Compensation. The plan also has an automatic increase provision which will increase the participant's deferral rate by 1% annually until the participant reaches the maximum rate of 15%. The employee has the opportunity to opt to defer a different percentage. The Company, at its discretion, may make a Matching, Qualified Matching, Profit Sharing, or top-heavy Contribution in an amount to be determined each year by the Employer.

Payment of Benefits

Upon termination of employment, death, disability or retirement, the participant may receive distributions as a lump sum, partial payments, or installment payments as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

Forfeitures

Forfeitures are used to reduce the Company's contributions and pay Plan expenses. Forfeitures for 2024 and 2023 were \$39,865 and \$33,571, respectively. As of December 31, 2024 and 2023 forfeited nonvested account totals were \$78,057 and \$73,203, respectively.

NOTE 1 PLAN DESCRIPTION - continued

Participant Loans (Notes Receivable From Participants)

Participant loans are permitted under the Plan. The maximum number of loans per participant is one with a minimum amount of \$1,000 per loan. Loans cannot exceed the lesser of \$50,000 or 50% of a participant's vested balance. All loans are to be repaid within five years (or ten years for loans used for a home purchase) with payments being made each pay period. The interest rate is determined at the time of the loan and is fixed at 1% over prime.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Concentration of Credit Risk

The Plan invests in mutual funds. Mutual funds consist of equity, fixed income, and cash equivalent investments. Mutual fund investments are not insured. Valuations of mutual funds with equity and fixed income securities are affected by market fluctuations in the underlying stocks and bonds in which the fund managers have invested.

Valuation of Investments and Income Recognition

As of December 31, 2024 and 2023, the Plan's assets were principally invested in mutual funds. These investments are stated at fair value based on quoted market prices or at amortized cost, approximating fair value. All investment funds are participant directed.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Reclassifications

Amounts previously shown have been reclassified to conform to the current year presentation.

Evaluation of Subsequent Events

The Plan has evaluated subsequent events through August 19, 2025, which is the date the financial statements were available to be issued.

NOTE 3 PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right, by action of its directors, to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, amounts credited to participants' accounts will become fully vested and non-forfeitable.

NOTE 4 PARTIES IN INTEREST

There were no known prohibited transactions with known parties in interest as defined in ERISA Section 3(14) and regulations thereunder, including those transactions set forth in ERISA Sections 406 and 407(a) and Internal Revenue Code Section 4975(c).

The Plan invests in shares of mutual funds managed by an affiliate of Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company acted as trustee for only those investments as defined by the Plan until April 30, 2024. As of May 1, 2024, the Plan, is now administered by Vanguard Retirement Plan Access. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

NOTE 5 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

There were no reconciling items between the financial statements and Form 5500.

NOTE 6 INCOME TAX STATUS

The Company adopted a Non-standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020. The Plan has been amended since receiving the determination letter. However, the Plan trustee believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

NOTE 8 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Statement ASC 820, Fair Value Measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds and money market mutual funds: Valued at the net asset value ("NAV") of share held by the plan at year end. These funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
