Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Fresh Market, Inc. Employees 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

The supplemental schedules, as listed in the accompanying table of contents, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

1. Description of Plan

The following description of The Fresh Market, Inc. Employees 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan available to substantially all employees of The Fresh Market, Inc. (the “Company” or “Employer”), which is 67% owned by South American retailer Cencosud. To be eligible to participate in the Plan, an employee must have attained age 21 and completed 60 days of service, with an entry date on the first day of the next month following the date eligibility requirements are met. Employees become eligible for the Company’s safe harbor matching contributions upon completion of 12 continuous months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Part-time, temporary, and seasonal employees are only eligible to participate in the Plan if they work 1,000 hours in a 12-month period (measured on the one-year service anniversary and each plan year after the one-year service anniversary).

Effective January 2024, in line with provisions of the SECURE Acts, long-term, part-time (LTPT) employees who have worked at least 500 hours in the prior three consecutive years are eligible to participate in the Plan. Effective January 2025, LTPT employees who work 500 hours in the prior two consecutive years are eligible to participate.

Contributions

Eligible employees may elect to contribute up to 80% of their annual pre-tax and/or after-tax compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). The Company makes a safe harbor matching contribution equal to 100% of the first 3%, plus 50% of the next 2% of each participant’s compensation contributed to the Plan.

The Company may also make a discretionary matching contribution. Furthermore, the Company may also make a discretionary qualified nonelective contribution, which is allocated based upon the percentage of each participant’s compensation to total compensation for all participants who are active as of the last day of the Plan year. However, no such contributions were made in 2024.

Participants may direct contributions between the investment options offered by the Plan. Participants may change their investment options and deferral percentages at any time.

Participant Accounts

Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based upon participant contributions, earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of Plan (Continued)

Vesting

The Plan provides for immediate vesting in participant contributions and the Company's safe harbor contributions, plus earnings thereon. Participants are 100% vested in the Company's discretionary contributions if employed on January 1, 2014. If hired January 2, 2014 to June 30, 2019, vesting in the Company's discretionary contributions, plus actual earnings thereon, is based on years of continuous service according to the following schedule:

Any participant hired on or after July 1, 2019, is subject to a three-year cliff vesting schedule for the Company's discretionary contributions as follows:

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, participants will generally receive the value of the vested interest in his or her account through lump-sum payment, partial payment, fixed period installment, or fixed payment installment. In-service distributions may be made to participants who have reached age 59½. Withdrawals may also be made upon circumstances of financial hardship, as defined by the Plan.

Notes Receivable from Participants

Plan participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participants' accounts and bear interest of 1% over the prime rate on the first business day of the month in which the note was requested. The repayment period is generally five years, unless for the purchase of a primary residence. Participants may have up to one outstanding note at any time. Principal and interest are paid ratably through payroll deductions. Effective February 1, 2025, after the repayment of an outstanding note, no additional notes will be approved for a participant for 14 calendar days.

Forfeited Accounts

Forfeitures from non-vested accounts may be used to reduce future Company contributions or offset administrative expenses. During 2024, approximately \$113,000 in forfeitures were used to reduce Company contributions. At December 31, 2024 and 2023, available forfeitures totaled approximately \$0 and \$37,000.

Administrative Expenses

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Certain plan expenses, such as trustee and recordkeeping expenses, are permitted to be paid from the Plan's assets. Distribution and note fees are paid from the affected participant's account.

SECURE 2.0 Act

Effective January 2024, the Plan adopted certain provisions of the SECURE 2.0 Act including provisions that allow for participants to take loans and withdrawals in the event of a federally declared disaster, as well as provisions that allow participants to take withdrawals for emergency expenses and in situations of domestic abuse, up to certain dollar limits.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through Voya Retirement Insurance and Annuity Company ("VRIAC") as well as Principal Life Insurance Company ("PLIC"). See further information in Note 8.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through August 14, 2025, the date the financial statements were available to be issued, and has determined that no additional events have occurred that require adjustments to or additional disclosure in the financial statements, other than those disclosed in Note 1.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (“Principal”), the trustee of the Plan.

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by PLIC. The IRS has determined and informed PLIC by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants’ accounts will become fully vested and nonforfeitable.

7. Party-in-Interest Transactions

Certain plan investments are managed by Principal or its affiliates. Fees paid by the Plan to Principal or its affiliates for administrative services were \$284,408 for 2024. Principal serves as the trustee and recordkeeper of the Plan and, as such, these transactions qualify as party-in-interest.

Fees paid by the Plan to Compass Financial Partners for advisory services were \$37,500 in 2024.

Fees paid by the Plan for accounting and other professional fees were \$23,796 for 2024.

The Plan receives funding through an agreement with Principal for an ERISA expense account to be used for administrative expenses. During 2024, \$94,871 was deposited into this account, and \$61,296 was used to reduce administrative expenses. As of December 31, 2024 and 2023, \$61,578 and \$27,374 were available to use for future administrative expenses.

8. Investments at Contract Value

During 2023, the Plan changed its combined trustee and recordkeeper service provider from Voya to Principal, and in conjunction with this transition, The Fresh Market Stable Return Fund (“TFMSR Fund”) was created. This fund holds the combined accounts of the Voya Fixed Account as well as the Principal Fixed Income Guaranteed Option (“PFIGO”). Effective August 2023, all contributions to this fund will go into the PFIGO. Below is further information on these two contracts held within TFMSR Fund.

TFMSR Fund holds a benefit-responsive group annuity investment contract with VRIAC, who maintains the contributions in a general account, the Voya Fixed Account. The Voya Fixed Account is an obligation of VRIAC’s general account that supports all of the Company’s insurance and annuity commitments. All guarantees are based on the financial strength and claims-paying ability of VRIAC, who is solely responsible for all obligations under its contracts. VRIAC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Interest is credited on contract balances using a single portfolio rate approach, where all amounts invested by the Plan in the Voya Fixed Account receive the same credited rate. As the Company notified VRIAC of its intention to liquidate this investment for receipt into the PFIGO, one-sixth of the Voya Fixed Account will be liquidated each year through August 2028 during the transition period, and the credited rate was set at 1.40% for the duration of the contract. Therefore, the current credited rate under the contract is 1.40% at both December 31, 2024 and 2023.

TFMSR Fund also holds a benefit-responsive group annuity investment contract with PLIC, who maintains the contributions in a general account, the PFIGO. The PFIGO is an obligation of the Principal Life Insurance Company’s general account that supports all of the Company’s insurance and annuity commitments. All guarantees are based on the financial strength and claims-paying ability of PLIC, who is solely responsible for all obligations under its contracts. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. PLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan and reset semiannually. The current credited rate under the contract is 4.75% and 4.65% at December 31, 2024 and 2023.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events limit the ability of the Plan to transact at contract value with the issuer. The plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

9. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”) which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurement

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

9. Fair Value Measurements (Concluded)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Common collective trust funds: Valued at NAV as determined by the issuer using estimated fair value of the underlying assets, minus liabilities, held in the fund, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

Pooled separate accounts: Valued at the NAV per share as reported by the issuer based on quoted market prices of the underlying assets, which is then adjusted for dividends and separate account fees. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
