Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TSI Profit-Sharing and Thrift Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis For Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities For The Audit Of The Financial Statements section of our report. We are required to be independent of The Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities Of Management For The Financial Statements

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the subsidiaries of TSI Holding Company (the Company or Plan Administrator). The Plan is designed to conform to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan includes two separate funding arrangements - a profit sharing arrangement and a cash or deferred compensation (401(k) component) arrangement. Individual participant accounts are maintained for the profit sharing and the 401(k) component accounts.

Contributions

Under the 401(k) component, employees may elect to have a portion of their salary deferred and contributed to the Plan to be invested. Contributions are made biweekly. Participants may elect to defer any whole percentage of compensation paid up to the Internal Revenue Code (the Code) maximum dollar limit of contributions, which was \$23,000 and \$22,500 for 2024 and 2023, respectively, for participants under the age of 50 and \$30,500 and \$30,000 for both 2024 and 2023, respectively, for participants age 50 and over. The Company may make a matching contribution up to 50% of a participant's salary deferral contribution. In addition, the Company may also make profit sharing contributions and additional discretionary contributions to be allocated to participant accounts.

Administration Of The Plan

Vanguard Fiduciary Trust (Vanguard) has retained Ascensus Trust Company (Ascensus) as a subcontractor to provide certain plan recordkeeping and administrative services on its behalf, which included being the Plan's Trustee.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company's contributions and allocations of Plan earnings (losses). Allocations are based on participant earnings (losses) or account balances, as defined by the Plan. The investments of the Plan are divided among funds. A participant may elect to invest his or her account in one or any combination of these funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

TSI PROFIT-SHARING AND THRIFT PLAN

Notes To Financial Statements *(Continued)*

Vesting

Participants become fully vested in profit sharing contributions after completion of three years of service, with no vesting earned prior to becoming 100% vested. Matching contributions made by the Company vest immediately.

Forfeitures

There were no forfeitures of nonvested account balances available to be used to reduce future Company contributions at December 31, 2024 and 2023. There were no forfeitures used in 2024 or 2023.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance, as defined by the Plan. Loans are to be repaid in level payments within the repayment period not to exceed five years.

The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% at time of issuance. The loans are repaid through biweekly payroll deductions including principal and interest.

Investment Options

Participants may allocate their contributions among a number of investment options offered through the Trustee and record-keeper.

Payment Of Benefits

Upon termination of employment, death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or periodic installments. Active participants who reach age 59-1/2 may withdrawal all or part of their vested accounts.

Administrative Expenses

Significant administrative expenses of the Plan are paid by the Company. These amounts are not reflected in the financial statements.

Plan Termination

The Company has the right, under the Plan, to discontinue its contributions at any time and to partially or fully terminate the Plan. In the event of termination, the individual accounts of all participants and former participants affected shall be nonforfeitable. Upon such termination, the Plan provides that the assets of the Plan will be distributed to the persons entitled thereto.

Notes To Financial Statements (*Continued*)

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan have been prepared on the accrual basis.

Investment Valuation And Income Recognition

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

The net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits includes realized and unrealized gains and losses.

Investment advisor fees are paid directly from fund earnings. They are included in the fund expense ratio. Purchase fees are paid by participants investing in funds subject to such fees.

Notes Receivable From Participants

Notes receivable from participants are measured at unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

TSI PROFIT-SHARING AND THRIFT PLAN

Notes To Financial Statements (*Continued*)

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by Ascensus (the Trustee), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

4. Income Tax Status

The Plan uses a prototype plan document sponsored by Ascensus LLC. The prototype plan sponsor obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the prototype plan document was in compliance with the applicable requirements of the Code. The Plan itself has not received a determination letter. The Plan has been amended since the date of the latest opinion letter; however, the Company believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Company believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Party In Interest Transactions

The Plan invests in shares of mutual funds managed by an affiliate of Vanguard. Vanguard has retained Ascensus as a subcontractor to provide these services under the record-keeping agreement on behalf of Vanguard. In addition, certain participants have outstanding loans with the Plan. These transactions in such investments and participant loans qualify as party in interest transactions, which are exempt from prohibited transaction rules under ERISA.

6. Financial Instruments Measured At Fair Value

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Quoted market prices in active markets for identical assets or liabilities.
- Level 2: Observable market based inputs or unobservable inputs that are corroborated by market data.
- Level 3: Unobservable inputs reflecting the reporting entity's own assumptions or external inputs from inactive markets.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce fair value calculation's that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
