Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Notes to Financial Statements

1. Description of the Plan

The following description of the SPR Therapeutics, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 2009 covering all eligible employees of SPR Therapeutics, Inc. (the Company). Employees of the Company are eligible after completing three months of service and attained 21 years of age. Employees may enter the Plan on the first day of the month after becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The trustees are responsible for oversight of the Plan. The trustees, along with an investment advisor, determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Contributions

Each year, participants may contribute from 1% to 100% of annual compensation, as defined in the Plan. The Plan allows for voluntary after-tax (Roth) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

During the year ended December 31, 2023, the Company contributed discretionary matching contributions equal to 100% of participants' elective deferral contributions up to 3% of compensation. Effective January 1, 2024, the Plan adopted a flexible discretionary matching contribution equal to 100% of participants' elective deferral contributions up to 3% of compensation.

Employees are eligible for Company discretionary non-elective contributions. There were no authorized non-elective contributions during the years ended December 31, 2024 and 2023.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. The Company discretionary matching and non-elective contributions are subject to the following vesting schedule:

Notes Receivable From Participants

The Company amended the Plan to add a participant loan provision effective February 1, 2023. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms range from 1 to 5 years or longer if the note receivable is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1.00%. No participant may have more than two outstanding loans. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon death, disability, retirement, or termination of services, a participant's voluntary contributions plus the vested amount of the Company contributions and earnings are paid in a lump sum payment, as provided by the Plan. If the participant's account is between \$1,000 and \$5,000, the Plan may make an automatic rollover of the participant's vested interest in his or her account to a qualified individual retirement account. If the participant's account balance is less than \$1,000, the Plan may make an automatic lump sum distribution to the participant equal to the participant's vested interest in his or her account. Effective January 1, 2024, the automatic lump sum distribution threshold was increased from \$1,000 to \$5,000. Upon reaching age 59 ½, participants in service may elect to receive distributions of their fully vested account balances. The Plan also permits distributions to participants who have a qualifying financial hardship.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,807 and \$19,676, respectively. These accounts will be used to pay expenses of the Plan or to reduce future Company contributions to the Plan. During 2024 and 2023, employer contributions were reduced by \$71,328 and \$0, respectively, from forfeited non-vested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments and certain administrative service fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value in investments.

Subsequent Events

The Plan has evaluated subsequent events through August 18, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Effective October 1, 2024, the Plan's custodian was changed from Mid Atlantic Trust Company dba American Trust Custody (ATC) to Empower Trust Company, LLC (Empower), the custodian and corporate trustee.

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and cash at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the respective custodians, qualified institutions. Notes receivable from participants at December 31, 2024 and interest income on notes receivable from participants for the period October 1, 2024 to December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. The mutual funds are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds are deemed to be actively traded.

Collective trust fund: The Putnam Stable Value Fund 25 (Fund) is a collective investment trust that is composed primarily of synthetic guaranteed investment contracts that are valued at the net asset value (NAV) of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell for an amount different from the reported NAV. There are no unfunded commitments or significant restrictions on redemptions relating to this Fund. Participant transactions may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that security liquidations will be carried out in an orderly manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Company has adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement sponsored by Definiti, LLC (Definiti) for the year ended December 31, 2023 and Ascensus, LLC (Ascensus) effective January 1, 2024. Definiti and Ascensus received an opinion letter dated June 30, 2020 from the IRS stating that the form of the pre-approved plan documents was in compliance with the requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

7. Related-Party and Party In Interest Transactions

For the year ended December 31, 2023 and period from January 1, 2024 to September 30, 2024, Definiti was the recordkeeper and ATC was the custodian of the Plan. Administrative fees of \$2,723 and \$2,305 was paid to Definiti and \$11,323 and \$6,520 was paid to ATC by the Plan for the period from January 1, 2024 to September 30, 2024 and the year ended December 31, 2023, respectively.

For period from October 1, 2024 to December 31, 2024, FuturePlan was the recordkeeper of the Plan and Empower was the custodian of the Plan. Administrative fees of \$2,035 was paid to FuturePlan and \$5,953 was paid to Empower by the Plan for period from October 1, 2024 to December 31, 2024.

These transactions qualify as party in interest transactions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
